Indiana secured school fund. Resets language regarding the use of matching grants from the Indiana secured school fund for student and parent support services plans.

1 Page 6, delete lines 26 through 42, begin a new paragraph and
2 insert:

6 JULY 1, 2026]: Sec. 2. (a) The Indiana secured school fund is
7 established to provide:
8 (1) matching grants to school corporations, charter schools, and
9 accredited nonpublic schools, where the matching grants may be
10 used to:
11 (A) employ a school resource officer, employ a law
12 enforcement officer, or enter into a contract or a memorandum
13 of understanding with a:
14 (i) local law enforcement agency;
15 (ii) private entity; or
16 (iii) nonprofit corporation;
17 to employ a school resource officer or a law enforcement
18 officer;
19 (B) conduct:
20 (i) a site vulnerability assessment of the buildings within a
21 school corporation or the buildings that are operated by a
22 charter school or accredited nonpublic school; or
23 (ii) critical incident digital mapping of the buildings within
24 a school corporation or the buildings that are operated by a
25 charter school or accredited nonpublic school;
26 (C) purchase equipment, hardware, materials, and technology

- 19 (c) The fund shall be administered by the department of homeland
- 20 security.
- 21 (d) The fund consists of:
- 22 (1) appropriations from the general assembly;
- 23 (2) federal grants;
- 24 (3) amounts deposited from any other public or private source;

- 26 (4) amounts deposited under IC 33-37-9-4.
- 27 (e) The expenses of administering the fund shall be paid from
- 28 money in the fund.
- 29 (f) The treasurer of state shall invest the money in the fund not
- 30 currently needed to meet the obligations of the fund in the same
- 31 manner as other public money may be invested. Interest that accrues
- 32 from these investments shall be deposited in the fund.
- 33 (g) Money in the fund at the end of a state fiscal year does not revert
- 34 to the state general fund.

- 38 enable a school corporation, charter school, or accredited nonpublic
- 39 school (or a coalition of schools applying jointly) to:

- (A) local law enforcement agency;

 - (E) provide staff with information about open or closed status of interior and exterior doors;

 - 29 (1) The total cost of the program established by the school
 - 30 corporation, charter school, or accredited nonpublic school (or the
 - 31 coalition of schools applying jointly).
 - 32 (2) Except as provided in subsection (d), the following amounts:
 - 33 (A) Thirty-five thousand dollars (\$35,000) per year, in the case
 - 34 of a school corporation, charter school, or accredited
 - 35 nonpublic school that:
 - 36 (i) has an ADM of at least one (1) and less than one
 - 37 thousand one (1,001) students; and
 - 38 (ii) is not applying jointly with any other school corporation,
 - 39 charter school, or accredited nonpublic school.
 - 40 (B) Fifty thousand dollars (\$50,000) per year, in the case of a

3 (i) has an ADM of more than one thousand (1,000) and less
4 than five thousand one (5,001) students; and

5 (ii) is not applying jointly with any other school corporation,
6 charter school, or accredited nonpublic school.

7 (C) Seventy-five thousand dollars (\$75,000) per year, in the
8 case of a school corporation, charter school, or accredited
9 nonpublic school that:

10 (i) has an ADM of more than five thousand (5,000) and less
11 than fifteen thousand one (15,001) students; and

12 (ii) is not applying jointly with any other school corporation,
13 charter school, or accredited nonpublic school.

14 (D) One hundred thousand dollars (\$100,000) per year, in the
15 case of a school corporation, charter school, or accredited
16 nonpublic school that:

17 (i) has an ADM of more than fifteen thousand (15,000); and

18 (ii) is not applying jointly with any other school corporation,
19 charter school, or accredited nonpublic school.

20 (E) One hundred thousand dollars (\$100,000) per year, in the
21 case of a coalition of schools applying jointly.

22 (c) Except as provided in subsection (d), the match requirement for
23 a grant under this chapter is based on the ADM for the school
24 corporation, charter school, or accredited nonpublic school (or coalition
25 of schools applying jointly) that is the subject of the grant as follows:

26 (1) For a school corporation, charter school, or accredited
27 nonpublic school with an ADM of less than five hundred one
28 (501) students, the grant match must be twenty-five percent
29 (25%) of the grant amount described in subsection (b).

30 (2) For a school corporation, charter school, or accredited
31 nonpublic school with an ADM of more than five hundred (500)
32 and less than one thousand one (1,001) students, the grant match
33 must be fifty percent (50%) of the grant amount described in
34 subsection (b).

35 (3) For a school corporation, charter school, or accredited
36 nonpublic school with an ADM of more than one thousand
37 (1,000) students or a coalition of schools applying jointly, the
38 grant match must be one hundred percent (100%) of the grant
39 amount described in subsection (b).

40 (d) A school corporation, charter school, or accredited nonpublic

- 1 school may be eligible to receive a grant of up to:
- 2 (1) one hundred thousand dollars (\$100,000) if:
- 3 (A) the school corporation, charter school, or accredited
- 4 nonpublic school receives a grant match of one hundred
- 5 percent (100%) of the requested grant amount; and
- 6 (B) the board approves the grant request; or
- 7 (2) for a school corporation, charter school, or accredited
- 8 nonpublic school described in subsection (c)(1) or (c)(2), a grant
- 9 of up to fifty thousand dollars (\$50,000) if:
- 10 (A) the school corporation, charter school, or accredited
- 11 nonpublic school receives a grant match of fifty percent (50%)
- 12 of the requested grant amount; and
- 13 (B) the board approves the grant request.
- 14 (e) A school corporation, charter school, or accredited nonpublic
- 15 school may receive only one (1) matching grant under this section each
- 16 year.
- 17 (f) The board may not award a grant to a school corporation, charter
- 18 school, or accredited nonpublic school under this section unless the
- 19 school corporation, charter school, or accredited nonpublic school is in
- 20 a county that has a county school safety commission, as described in
- 21 section 12 of this chapter."
