Synopsis: Department of child services. Makes changes to the child services and juvenile laws concerning the following: (1) Criminal history background checks. (2) Exception of certain governmental employees to licensing or certification requirements of social workers and counselors. (3) The responsibilities of the department of child services. (4) Transitional services plans for certain individuals receiving foster care or collaborative care. (5) Regional service strategic plans. (6) Foster care. (7) Detention of children alleged to be children in needs of services. (8) Case plans for children in need of services. (9) Dispositional decrees and review of disposition decrees concerning children in needs of services. (10) Dispositional decrees and review of dispositional decrees concerning delinquent children. Repeals provisions concerning local plans for the provision of child protection services.

ENGROSSED HOUSE BILL No. 1434

A BILL FOR AN ACT to amend the Indiana Code concerning family law and juvenile law.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 10-13-3-39, AS AMENDED BY P.L.155-2011,
2 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]: Sec. 39. (a) The department is designated as the
4 authorized agency to receive requests for, process, and disseminate the
5 results of national criminal history background checks that comply with
6 this section and 42 U.S.C. 5119a.
7 (b) A qualified entity may contact the department to request a
8 national criminal history background check on any of the following
9 persons:
10 (1) A person who seeks to be or is employed with the qualified
11 entity. A request under this subdivision must be made not later
12 than three (3) months after the person is initially employed by the
13 qualified entity.
14 (2) A person who seeks to volunteer or is a volunteer with the
15 qualified entity. A request under this subdivision must be made

- 1 not later than three (3) months after the person initially volunteers
 2 with the qualified entity.
- 3 (3) A person for whom a national criminal history background
 4 check is required under any law relating to the licensing of a
 5 home, center, or other facility for purposes of day care or
 6 residential care of children.
- 7 (4) A person for whom a national criminal history background
 8 check is ~~required~~ **permitted** for purposes of:
- 9 (A) placement of a child in a foster family home, a prospective
 10 adoptive home, or the home of a relative, **legal guardian to**
 11 **whom IC 29-3-8-9 applies**, or other caretaker **under section**
 12 **27.5 of this chapter or IC 31-34; or for purposes of**
- 13 (B) a report concerning an adoption as required by IC 31-19-8;
- 14 (C) **collaborative care host homes and supervised**
 15 **independent living arrangements as provided in**
 16 **IC 31-28-5.8-5.5; or**
- 17 (D) **reunification of a child with a parent, guardian, or**
 18 **custodian as provided in IC 31-34-21-5.5.**
- 19 (5) **A person for whom a national criminal history**
 20 **background check is required for the licensing of a group**
 21 **home, child caring institution, child placing agency, or foster**
 22 **home under IC 31-27.**
- 23 (6) **A person for whom a national criminal history**
 24 **background check is required for determining the individual's**
 25 **suitability as an employee of a contractor of the state under**
 26 **section 38.5(a)(1) of this chapter.**
- 27 (c) A qualified entity must submit a request under subsection (b) in
 28 the form required by the department and provide a set of the person's
 29 fingerprints and any required fees with the request.
- 30 (d) If a qualified entity makes a request in conformity with
 31 subsection (b), the department shall submit the set of fingerprints
 32 provided with the request to the Federal Bureau of Investigation for a
 33 national criminal history background check. The department shall
 34 respond to the request in conformity with:
- 35 (1) the requirements of 42 U.S.C. 5119a; and
- 36 (2) the regulations prescribed by the Attorney General of the
 37 United States under 42 U.S.C. 5119a.
- 38 (e) Subsection (f):
- 39 (1) applies to a qualified entity that:
- 40 (A) is not a school corporation or a special education
 41 cooperative; or
- 42 (B) is a school corporation or a special education cooperative



- 1 and seeks a national criminal history background check for a
2 volunteer; and
- 3 (2) does not apply to a qualified entity that is a:
- 4 (A) home health agency licensed under IC 16-27-1; or
- 5 (B) personal services agency licensed under IC 16-27-4.
- 6 (f) After receiving the results of a national criminal history
7 background check from the Federal Bureau of Investigation, the
8 department shall make a determination whether the person who is the
9 subject of a request has been convicted of:
- 10 (1) an offense described in IC 20-26-5-11;
- 11 (2) in the case of a foster family home, an offense described in
12 IC 31-27-4-13(a);
- 13 (3) in the case of a prospective adoptive home, an offense
14 described in IC 31-19-11-1(c);
- 15 (4) any other felony; or
- 16 (5) any misdemeanor;
- 17 and convey the determination to the requesting qualified entity.
- 18 (g) This subsection applies to a qualified entity that:
- 19 (1) is a school corporation or a special education cooperative; and
- 20 (2) seeks a national criminal history background check to
21 determine whether to employ or continue the employment of a
22 certificated employee or a noncertificated employee of a school
23 corporation or an equivalent position with a special education
24 cooperative.
- 25 After receiving the results of a national criminal history background
26 check from the Federal Bureau of Investigation, the department may
27 exchange identification records concerning convictions for offenses
28 described in IC 20-26-5-11 with the school corporation or special
29 education cooperative solely for purposes of making an employment
30 determination. The exchange may be made only for the official use of
31 the officials with authority to make the employment determination. The
32 exchange is subject to the restrictions on dissemination imposed under
33 P.L.92-544, (86 Stat. 1115) (1972).
- 34 (h) This subsection applies to a qualified entity (as defined in
35 IC 10-13-3-16) that is a public agency under IC 5-14-1.5-2(a)(1). After
36 receiving the results of a national criminal history background check
37 from the Federal Bureau of Investigation, the department shall provide
38 a copy to the public agency. Except as permitted by federal law, the
39 public agency may not share the information contained in the national
40 criminal history background check with a private agency.
- 41 (i) This subsection applies to a qualified entity that is a:
- 42 (1) home health agency licensed under IC 16-27-1; or



1 (2) personal services agency licensed under IC 16-27-4.
 2 After receiving the results of a national criminal history background
 3 check from the Federal Bureau of Investigation, the department shall
 4 make a determination whether the applicant has been convicted of an
 5 offense described in IC 16-27-2-5(a) and convey the determination to
 6 the requesting qualified entity.

7 (j) The department:

8 (1) may permanently retain an applicant's fingerprints submitted
 9 under this section; and

10 (2) shall retain the applicant's fingerprints separately from
 11 fingerprints collected under section 24 of this chapter.
