HOUSE BILL No. 1637

DIGEST OF HB 1637 (Updated February 18, 2015 10:21 am - DI 116)

Citations Affected: IC 20-32; IC 20-33.

Synopsis: Various education issues. Makes changes to provisions relating to guidelines or thresholds established by the state board of education (state board) to identify students who are likely to require remedial work at a postsecondary educational institution or workforce training program. Removes the requirement that PSAT assessment scores are to be included in a student's transcript.

Effective: July 1, 2015.

HOUSE BILL No. 1637

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-32-9-1, AS ADDED BY P.L.268-2013,
2 SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]: Sec. 1. Not later than July 1, 2013, the state board, in
4 consultation with the:
5 (1) education roundtable established under IC 20-19-4-2;
6 (2) commission for higher education established under
7 IC 21-18-2-1;
8 (3) department of workforce development established under
9 IC 22-4.1-2-1; and
10 (4) department;
11 shall develop guidelines **and thresholds** to assist secondary schools in
12 identifying a student who is likely to require remedial work at a
13 postsecondary educational institution or workforce training program if
14 the student subsequently attends ~~a~~ **an Indiana** postsecondary
15 educational institution or workforce training program upon graduation.

 18 guidelines **and thresholds** established in section 2 of this chapter as to
 19 whether the student is in need of additional instruction or remedial
 20 action with respect to a particular subject matter covered in the exam.
 21 If the appropriate school official determines that a student who takes
 22 an exam under subsection (a) is in need of remediation or supplemental
 23 instruction to prevent the need for remediation at a postsecondary
 24 educational institution or workforce development program, the
 25 appropriate school official shall inform the student's parent:

26 (1) of the likelihood that the student will require remedial course
 27 work;

28 (2) of the potential financial impact on the student or the parent
 29 for the additional remedial course work described in subdivision

30 (1), including that the student may not be eligible to receive state
 31 scholarships, grants, or assistance administered by the
 32 commission for higher education; and

33 (3) of the additional time that may be required to earn a degree;
 34 while the student attends a postsecondary educational institution or

38 (c) Before a student determined to need additional instruction or
 39 remedial action under subsection (b) with respect to a particular subject
 40 matter may enroll in a dual credit course under IC 21-43 in the same
 41 subject matter or a related subject matter, the student may receive
 42 additional instruction or remedial course work and must retake the



1 examination described in subsection (a). If the appropriate school
 2 official determines that the student no longer requires additional
 3 instruction or remedial action under the guidelines established under
 4 section 2 of this chapter after retaking the exam under this section, the
 5 student may enroll in a dual credit course under IC 21-43. The cost of
 6 the administration of the exam under this subsection shall be paid by
 7 the department.

 10 **instruction may retake the college and career readiness exam**
 11 **during grade 12 if a remediation or supplemental instruction plan**

 14 **recommendations to the general assembly in an electronic format**
 15 **under IC 5-14-6 as to the feasibility or requiring the department to**
 16 **pay costs relating to the administration of the exam under**
 17 **subsection (d). This subsection expires January 1, 2016.**

 21 include the following information in the official high school transcript
 22 for a student in high school:

23 (1) Attendance records.

24 (2) The student's latest ISTEP program test results under
 25 IC 20-32-5.

26 (3) Any secondary level and postsecondary level certificates of
 27 achievement earned by the student.

28 (4) Immunization information from the immunization record the
 29 student's school keeps under IC 20-34-4-1.

30 (5) Any dual credit courses taken that are included in the core
 31 transfer library under IC 21-42-5-4.

32 ~~(6) The student's latest PSAT program test results.~~

33 (b) A school corporation may include information on a student's
 34 high school transcript that is in addition to the requirements of
 35 subsection (a).
