ENGROSSED HOUSE BILL No. 1637

DIGEST OF HB 1637 (Updated April 7, 2015 4:32 pm - DI 116)

Citations Affected: IC 20-30; IC 20-31; IC 20-32; IC 20-33.

Synopsis: Various education issues. Requires higher education representatives with subject matter expertise to be appointed to academic standards committees. Provides that a waiver provision concerning psychomotor skills training for CPR expires July 1, 2015. Makes changes to provisions relating to guidelines or thresholds established by the state board of education (state board) to identify students who are likely to require remedial work at a postsecondary educational institution or workforce training program. Provides that the guidelines and thresholds for remediation established by the state board of education must include criteria and thresholds determined by the commission for higher education in consultation with state educational institutions. Specifies types of advanced course work and qualifying grade that may be considered as part of the determination of whether a student needs remediation. Removes the requirement that PSAT assessment scores are to be included in a student's transcript.

Effective: Upon passage; July 1, 2015.

ENGROSSED HOUSE BILL No. 1637

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-30-5-20, AS ADDED BY P.L.139-2014,
2 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: Sec. 20. (a) As used in this section, "psychomotor
4 skills" means skills using hands on practice to support cognitive
5 learning.

6 (b) Except as provided in subsection (e), each school corporation
7 and accredited nonpublic school shall include in the school
8 corporation's or accredited nonpublic school's high school health
9 education curriculum instruction in cardiopulmonary resuscitation and
10 use of an automated external defibrillator for its students. The
11 instruction must incorporate the psychomotor skills necessary to
12 perform cardiopulmonary resuscitation and use an automated external
13 defibrillator and must include either of the following:

14 (1) An instructional program developed by the American Heart
15 Association or the American Red Cross.

- 1 (2) An instructional program that is nationally recognized and is
 2 based on the most current national evidence based emergency
 3 cardiovascular care guidelines for cardiopulmonary resuscitation
 4 and the use of an automated external defibrillator.
- 5 (c) A school corporation or an accredited nonpublic school may
 6 offer the instruction required in subsection (b) or may arrange for the
 7 instruction to be provided by available community based providers.
 8 The instruction is not required to be provided by a teacher. If
 9 instruction is provided by a teacher, the teacher is not required to be a
 10 certified trainer of cardiopulmonary resuscitation.
- 11 (d) This section shall not be construed to require a student to
 12 become certified in cardiopulmonary resuscitation and the use of an
 13 automated external defibrillator. However, if a school corporation or
 14 accredited nonpublic school chooses to offer a course that results in
 15 certification being earned, the course must be taught by an instructor
 16 authorized to provide the instruction by the American Heart
 17 Association, the American Red Cross, or a similar nationally
 18 recognized association.
- 19 (e) A school administrator may waive the requirement that a student
 20 receive instruction under subsection (b) if the student has a disability
 21 or is physically unable to perform the psychomotor skill component of
 22 the instruction required under subsection (b).
- 23 (f) If a school is unable to comply with the psychomotor skill
 24 component of the instruction required under subsection (b), the
 25 governing body may submit a request to the state superintendent to
 26 waive the psychomotor skill component. The state superintendent shall
 27 take action on the waiver request within thirty (30) days of receiving
 28 the request for a waiver. A waiver request must:
- 29 (1) be in writing;
 30 (2) include the reason or reasons that necessitated the waiver
 31 request;
 32 (3) indicate the extent to which the school attempted to comply
 33 with the requirements under subsection (b); and
 34 (4) be submitted each year for the school year the school requests
 35 the waiver.
