MR. PRESIDENT:

I move that Engrossed House Bill 1001 be amended to read as follows:

- 1 Page 91, between lines 42 and 43, begin a new paragraph and insert:
- 2 "SECTION 66. IC 6-2.5-5.5 IS ADDED TO THE INDIANA CODE
- 3 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2025]:
- 5 **Chapter 5.5. Sales Tax Holiday**
- 6 **Sec. 1. This chapter applies to sales that takes place:**
- 7 **(1) in the month of January, during the period:**
- 8 **(A) beginning at 12:01 a.m. on January 24; and**
- 9 **(B) ending at 11:59 p.m. on January 31;**
- 10 **of each year; and**
- 11 **(2) in the month of August, during the period:**
- 12 **(A) beginning at 12:01 a.m. on August 24; and**
- 13 **(B) ending at 11:59 p.m. on August 31;**
- 14 **of each year.**
- 15 **Sec. 2. (a) As used in this chapter, "backpack" means the**
- 16 **following:**
- 17 **(1) Messenger bags.**

- 21 **(B) a student attending a postsecondary school;**
- 22 **in Indiana; and**
- 23 **(2) the sale takes place during the period set forth in section**
- 24 **1 of this chapter."**
