1 AN ACT making and concerning appropriations for the fiscal years ending
2 June 30, 2015, June 30, 2016, and June 30, 2017, for state agencies;
3 authorizing certain transfers, capital improvement projects and fees,
4 imposing certain restrictions and limitations, and directing or
5 authorizing certain receipts, disbursements and acts incidental to the
6 foregoing.

8 *Be it enacted by the Legislature of the State of Kansas:*

9 Section 1. (a) For the fiscal years ending June 30, 2015, June 30,
10 2016, and June 30, 2017, appropriations are hereby made, restrictions and
11 limitations are hereby imposed, and transfers, capital improvement
12 projects, fees, receipts, disbursements and acts incidental to the foregoing
13 are hereby directed or authorized as provided in this act.

14 (b) The agencies named in this act are hereby authorized to initiate
15 and complete the capital improvement projects specified and authorized by
16 this act or for which appropriations are made by this act, subject to the
17 restrictions and limitations imposed by this act.

18 (c) This act shall not be subject to the provisions of subsection (a) of
19 K.S.A. 75-6702, and amendments thereto.

20 (d) The appropriations made by this act shall not be subject to the
21 provisions of K.S.A. 46-155, and amendments thereto.

 29 provide space for the unemployment insurance program of the department
 30 of labor until such proposed purchase or other acquisition, including the
 31 preliminary plans and program statement for any capital improvement
 32 project that is proposed to be initiated and completed by or for the
 33 department of labor have been reviewed by the joint committee on state
 34 building construction.

35 (b) In addition to the other purposes for which expenditures may be
 36 made by the department of labor from moneys appropriated from any
 37 special revenue fund for fiscal year 2016 as authorized by this or other
 38 appropriation act of the 2015 regular session of the legislature,
 39 expenditures may be made by the department of labor for fiscal year 2016
 40 from the moneys appropriated from any special revenue fund for the
 41 expenses of the sale, exchange or other disposition conveying title for any
 42 portion or all of the real estate of the department of labor: *Provided*, That
 43 such expenditures may be made and such sale, exchange or other

1 disposition conveying title for any portion or all of the real estate of the
2 department of labor may be executed or otherwise effectuated only upon
3 specific authorization by the state finance council acting on this matter,
4 which is hereby characterized as a matter of legislative delegation and
5 subject to the guidelines prescribed in subsection (c) of K.S.A. 75-3711c,
6 and amendments thereto, and acting after receiving the recommendations
7 of the joint committee on state building construction: *Provided, however;*
8 That no such sale, exchange or other disposition conveying title for any
9 portion of the real estate of the department of labor shall be executed until
10 the proposed sale, exchange or other disposition conveying title for such
11 real estate has been reviewed by the joint committee on state building
12 construction: *Provided further;* That the net proceeds from the sale of any
13 of the real estate of the department of labor shall be deposited in the state
14 treasury in accordance with the provisions of K.S.A. 75-4215, and
15 amendments thereto, and shall be credited to the employment security
16 administration property sale fund of the department of labor: *And provided*
17 *further;* That expenditures from the employment security administration
18 property sale fund shall not exceed the limitation established for fiscal year
19 2016 by this or other appropriation act of the 2015 regular session of the
20 legislature except upon approval of the state finance council.

21 (c) In addition to the other purposes for which expenditures may be
22 made by the above agency from the special employment security fund for
23 fiscal year 2016, expenditures may be made by the above agency from the

30 such capital improvement purpose shall be in addition to any expenditure
31 limitations imposed on the special employment security fund for fiscal

21 fiscal year 2017, expenditures may be made by the above agency from the
22 disaster grants – public assistance for fiscal year 2017 from the
23 unencumbered balance as of June 30, 2016, in each existing capital
24 improvement account of the disaster grants – public assistance: *Provided*,
25 That expenditures from the unencumbered balance of any such existing
26 capital improvement account shall not exceed the amount of the
27 unencumbered balance in such account on June 30, 2016: *Provided*
28 *further*, That all expenditures from the unencumbered balance of any such
29 account shall be in addition to any expenditure limitations imposed on the
30 disaster grants – public assistance for fiscal year 2017 and shall be in
31 addition to any other expenditure limitations imposed on any such account
32 of the disaster grants – public assistance for fiscal year 2017.

33 (hh) In addition to the other purposes for which expenditures may be
34 made by the above agency from the nonfederal grants fund for fiscal year
35 2017, expenditures may be made by the above agency from the
36 unencumbered balance as of June 30, 2016, in each capital improvement
37 account of the nonfederal grants fund: *Provided*, That expenditures from
38 the unencumbered balance of any such existing capital improvement
