### AMENDMENTS TO SENATE BILL 600, AS AMENDED

#### AMENDMENT NO. 1

On page 1 of the House Judiciary Committee Amendments (SB0600/602810/1), in line 7 of Amendment No. 1, strike "<u>incident involving the death of a person caused by a police officer</u>" and substitute "<u>police-involved death of a civilian</u>"; in lines 11 and 12, strike "<u>incidents involving the death of a person caused by a police officer</u>" and substitute "<u>police-involved deaths of civilians</u>; <u>authorizing the Independent</u> <u>Investigative Unit to investigate certain crimes related to police misconduct</u>; providing <u>that the Independent Investigative Unit shall have the authority to act in a certain</u> <u>manner when conducting a certain investigation</u>"; and in line 13, after "<u>time</u>;" insert "<u>requiring</u>, <u>subject to a certain exception</u>, that a certain report remain confidential <u>through the adjudication of a certain criminal case</u>;".

#### AMENDMENT NO. 2

On page 4 of the House Judiciary Committee Amendments, in lines 7 and 8 and 12 and 13 of Amendment No. 2, in each instance, strike "<u>INCIDENT INVOLVING THE</u> <u>DEATH OF A PERSON CAUSED BY A POLICE OFFICER</u>" and substitute "<u>POLICE–</u> <u>INVOLVED DEATH OF A CIVILIAN</u>"; and in line 12, strike "<u>AN</u>" and substitute "<u>A</u>".

On page 4 of the House Judiciary Committee Amendments, in line 4 of Amendment No. 3, after "<u>(C)</u>" insert "<u>(1)</u>"; in lines 5 and 6, strike "<u>INCIDENTS</u> <u>INVOLVING THE DEATH OF A PERSON CAUSED BY A POLICE OFFICER.</u>" and substitute "<u>POLICE-INVOLVED DEATHS OF CIVILIANS.</u>

## (2) <u>THE INDEPENDENT INVESTIGATIVE UNIT MAY INVESTIGATE</u> ANY OTHER CRIMES RELATED TO POLICE MISCONDUCT THAT ARE DISCOVERED DURING AN INVESTIGATION UNDER PARAGRAPH (1) OF THIS SUBSECTION.

(D) IN CONDUCTING AN INVESTIGATION UNDER SUBSECTION (C) OF THIS SECTION, THE INDEPENDENT INVESTIGATIVE UNIT MAY ACT WITH THE FULL POWERS, RIGHTS, PRIVILEGES, AND DUTIES OF A STATE'S ATTORNEY, INCLUDING THE USE OF A GRAND JURY IN ANY COUNTY.";

and in line 7, strike "(D)" and substitute "(E) (1)".

On page 5 of the House Judiciary Committee Amendments, in line 1 of Amendment No. 3, strike "<u>CONFIDENTIAL</u>"; in the same line, after "<u>REPORT</u>" insert "<u>CONTAINING DETAILED INVESTIGATIVE FINDINGS</u>"; in line 2, strike "<u>THAT</u>:" and substitute a period; strike in their entirety lines 3 through 11, inclusive, and substitute:

# "(2) EXCEPT AS OTHERWISE PROVIDED BY LAW, THE REPORT UNDER THIS SUBSECTION SHALL REMAIN CONFIDENTIAL THROUGH ADJUDICATION OF ANY ASSOCIATED CRIMINAL CASE AT THE TRIAL COURT LEVEL.";

and in line 12, strike "<u>(E)</u>" and substitute "<u>(F)</u>".

On page 6 of the House Judiciary Committee Amendments, in line 1 of Amendment No. 3, strike "(F)" and substitute "(G)".
