4 FOR the purpose of requiring the ~~Secretary of Health and Mental Hygiene to establish~~
5 ~~a registry that includes certain information on certain employees of health care~~
6 ~~facilities who provide services to certain individuals and who were terminated~~
7 ~~for certain reasons; requiring the placement of a certain employee on the~~
8 ~~registry under certain circumstances; authorizing certain health care facilities~~
9 ~~to submit the names of former employees to the Secretary for inclusion in the~~
10 ~~registry; authorizing certain health care facilities to have access to the registry;~~
11 ~~prohibiting a health care facility from allowing an employee to access the~~
12 ~~registry except under certain circumstances; authorizing a person responsible~~
13 ~~for a certain individual to access the registry; requiring a health care facility to~~
14 ~~adopt a certain procedure, provide certain employee training, and implement a~~
15 ~~certain quality assurance program; prohibiting a health care facility from hiring~~

28 (a) The Office of Health Care Quality shall reconvene the Abuser Registry
29 Workgroup originally convened in 2012.

30 (b) The Abuser Registry Workgroup shall:

1 (1) review the previous work of the Abuser Registry Workgroup and
2 the alternative approach described in the January 14, 2013, letter from the Acting
3 Executive Director of the Office of Health Care Quality to the sponsors of Senate Bill
4 316 and House Bill 382 of 2012;

5 (2) monitor the implementation of recommendations included in the
6 January 23, 2013, letter from the Acting Executive Director of the Office of Health
7 Care Quality to the House Health and Government Operations Committee relating to:

8 (i) initiating a National Background Check Program supported
9 by a federal grant;

10 (ii) educating the provider community about best practices for
11 managing abuse and neglect and utilizing the criminal justice system in cases of abuse
12 and neglect;

13 (iii) assisting law enforcement in the development of outreach
14 and training concerning abuse and neglect in health care settings; and

15 (iv) exploring the need to strengthen statutory law relating to
16 criminal history records checks of employees who are not licensed or certified under
17 the Health Occupations Article; and

18 (3) recommend changes in statutory law, regulations, or procedures to
19 deter abuse and neglect in health care settings.

20 (c) On or before January 1, 2014, the Office of Health Care Quality shall
21 report to the Governor and, in accordance with § 2-1246 of the State Government
22 Article, the Senate Finance Committee and the House Health and Government
23 Operations Committee on the findings and recommendations of the Abuser Registry
24 Workgroup.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 ~~October~~ June 1, 2013. It shall remain effective for a period of 1 year and 1 month and,
27 at the end of June 30, 2014, with no further action required by the General Assembly,
28 this Act shall be abrogated and of no further force and effect.
