1.14	Section 1. Minnesota Statutes 2014, section 97B.015, subdivision 1, is amended to read:
1.15	Subdivision 1. Establishment. The commissioner shall establish a statewide
1.16	course in the safe use and storage of firearms and identification of wild mammals and
1.17	birds. A course may be held in a school district. The courses must be conducted by the
1.18	commissioner in cooperation with other organizations. The courses must instruct youths
1.19	students in commonly accepted principles of safety in hunting and, the proper handling
1.20	of common hunting firearms, fundamental legal aspects of firearms ownership and use,

and identification of various species of wild mammals and birds by sight and other unique 1.21

characteristics. 1.22

Sec. 2. Minnesota Statutes 2014, section 624.7131, subdivision 5, is amended to read: 1.23 Subd. 5. Granting of permits. The chief of police or sheriff shall issue a transferee 1.24 permit or deny the application within seven 28 days of application for the permit. The chief 1.25

- of police or sheriff shall provide an applicant with written notification of a denial and the 2.1 specific reason for the denial. The permits and their renewal shall be granted free of charge. 2.2 Sec. 3. Minnesota Statutes 2014, section 624.7132, is amended by adding a subdivision 2.3 to read: 2.4 Subd. 7a. Transfer by or to licensed dealers only. No person shall transfer a pistol 2.5 or semiautomatic military-style assault weapon unless the transferor or the transferee 2.6 is a federally licensed firearms dealer. - 4.12 (a) Prior to transferring a firearm, the transferee must provide the transferor with
- 4.13 proof of firearms training completed within five years of the date of transfer. A certificate
- 4.14 issued under section 97B.015, a valid permit to carry a handgun issued under section
- 4.15 <u>624.714</u>, or another document that establishes that the transferee has timely satisfied the
- 4.16 <u>training requirements of section 624.714</u>, subdivision 2a, paragraph (b), is acceptable
- 4.17 proof of firearms training for purposes of this section.
- 4.18 (b) It is a misdemeanor for a person to transfer or receive a firearm without
- 4.19 <u>complying with paragraph (a).</u>
- 4.20 (c) It is a felony for a transferee to receive a firearm from a transferor after providing
 4.21 a false certificate of training to the transferor.

4.23 Subd. 2a. Training in safe use and storage of a pistol. (a) An applicant must
4.24 present evidence that the applicant received training in the safe use and safe storage of
4.25 a pistol within one year of the date of an original or renewal application. Training may
4.26 be demonstrated by:
4.27 (1) employment as a peace officer in the state of Minnesota within the past year; or

- 4.28 (2) completion of a firearms safety or training course providing basic training in the4.29 safe use of a pistol and conducted by a certified instructor.
- 4.30 (b) Basic training must include:
- 4.31 (1) instruction in the fundamentals of pistol use <u>and safe storage</u>;
- 4.32 (2) successful completion of an actual shooting qualification exercise; and
- 4.33 (3) instruction in the fundamental legal aspects of pistol possession, carry, and use,
 4.34 including self-defense and the restrictions on the use of deadly force.

5.2	a firearms safety or training course described in paragraph (b). The certificate must be
5.3	signed by the instructor and attest that the person attended and completed the course.
5.4	(d) A person qualifies as a certified instructor if the person is certified as a firearms
5.5	instructor within the past five years by an organization or government entity that has been
5.6	approved by the Department of Public Safety in accordance with the department's standards.
5.7	(e) A sheriff must accept the training described in this subdivision as meeting the
5.8	requirement in subdivision 2, paragraph (b), for training in the safe use of a pistol. A
5.9	sheriff may also accept other satisfactory evidence of training in the safe use of a pistol.
5.10	Sec. 8. [624.7163] FIREARM AND AMMUNITION STORAGE
5.11	REQUIREMENTS.
5.12	Subdivision 1. Storage. The owner of a firearm must take reasonable action to
5.13	secure the firearm when it is not in use. For this purpose, reasonable action requires storage
5.14	of a firearm, unloaded, with a locking device, and stored separately from its ammunition.
5.15	Subd. 2. Transfer. No person shall transfer a firearm to another without an
5.16	appropriate locking device, unless the transferee provides proof of ownership of a locking
5.17	device capable of storing the firearm in compliance with subdivision 1. The transferee must
5.18	own a sufficient number of locking devices to secure each firearm the transferee owns.
5.19	Subd. 3. Penalty. A person who violates this section is guilty of a misdemeanor.
5.20	Subd. 4. Definitions. For purposes of this section, "locking device" means a device
5.21	that renders the firearm inaccessible, and includes without limitation the following: a
5.22	trigger lock; a barrel lock; a cylinder lock; a gun vault; a locked cabinet; a locked box;
5.23	or any other appropriate locked container.

APPENDIX Repealed Minnesota Statutes: 16-5602

609.66 DANGEROUS WEAPONS.

Subd. 1f. **Gross misdemeanor; transferring firearm without background check.** A person, other than a federally licensed firearms dealer, who transfers a pistol or semiautomatic military-style assault weapon to another without complying with the transfer requirements of section 624.7132, is guilty of a gross misdemeanor if the transferee possesses or uses the weapon within one year after the transfer in furtherance of a felony crime of violence, and if:

(1) the transferee was prohibited from possessing the weapon under section 624.713 at the time of the transfer; or

(2) it was reasonably foreseeable at the time of the transfer that the transferee was likely to use or possess the weapon in furtherance of a felony crime of violence.

624.7132 REPORT OF TRANSFER.

Subd. 14. **Transfer to unknown party.** (a) No person shall transfer a pistol or semiautomatic military-style assault weapon to another who is not personally known to the transferor unless the proposed transferee presents evidence of identity to the transferor.

(b) No person who is not personally known to the transferor shall become a transferee of a pistol or semiautomatic military-style assault weapon unless the person presents evidence of identity to the transferor.

(c) The evidence of identity shall contain the name, residence address, date of birth, and photograph of the proposed transferee; must be made or issued by or under the authority of the United States government, a state, a political subdivision of a state, a foreign government, a political subdivision of a foreign government, an international governmental or an international quasi-governmental organization; and must be of a type commonly accepted for the purpose of identification of individuals.

(d) A person who becomes a transferee of a pistol or semiautomatic military-style assault weapon in violation of this subdivision is guilty of a misdemeanor.
