publish the reported data on the department Web site in a format that facilitates public access to the aggregated data and include links to both the United States Department of State's Consular Information Program that informs the public of conditions abroad that may affect students' safety and security and publicly available reports on sexual assaults and other criminal acts affecting students participating in a foreign exchange or study or other travel abroad program. (d) School districts and charter schools with enrolled students who participate in foreign exchange or study or other travel abroad programs are encouraged to adopt policies supporting the programs and to include program standards to ensure students' health and safety. Subd. 2. **Registration**; **report.** (a) To be eligible to provide a foreign exchange or study or other travel abroad program to students enrolled in a school district or charter school, a program provider must register with the secretary of state in the form and manner prescribed by the secretary of state. Program providers, annually by August 1, must provide the data required under subdivision 1, paragraph (a), clauses (1) to (3), to the districts and charter schools with enrolled students participating in the provider's program. (b) Registration with the secretary of state must not be considered or represented as an endorsement of the program provider by the secretary of state.
