 1.3 reporting, and other regulatory provisions; making technical, clarifying, and
 1.4 conforming changes; amending Minnesota Statutes 2014, sections 349.12,

1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2014, section 349.12, subdivision 3c, is amended to read:

1.13 Subd. 3c. **Bar bingo.** "Bar bingo" is a bingo occasion conducted at a permitted
 1.14 premises in an area where on-sale intoxicating liquor or on-sale 3.2 percent malt beverages
 1.15 are sold and where ~~the~~ a licensed organization conducts another form of lawful gambling
 1.16 and consents to the conduct of bar bingo on the premises. Bar bingo does not include
 1.17 bingo games linked to other permitted premises.

1.18 **EFFECTIVE DATE.** This section is effective July 1, 2015.

1.19 Sec. 2. Minnesota Statutes 2014, section 349.12, subdivision 18, is amended to read:

1.20 Subd. 18. **Gambling equipment.** "Gambling equipment" means gambling
 1.21 equipment that is either disposable or permanent gambling equipment.

1.22 (a) Disposable gambling equipment includes the following:

1.23 (1) bingo hard cards or paper sheets, including linked bingo paper sheets;

1.24 (2) paper and electronic pull-tabs;

1.25 (3) jar tickets;

- 2.1 (4) paddle tickets and paddle ticket cards;
- 2.2 (5) tipboards and tipboard tickets; ~~and~~
- 2.3 (6) promotional tickets that mimic a pull-tab or tipboard; and
- 2.4 (7) application software and those computer programs provided by a licensed
- 2.5 manufacturer in the production, play, and reporting of board-approved electronic pull-tab
- 2.6 games or electronic bingo games.

2.7 (b) Permanent gambling equipment includes the following:

- 2.8 (1) devices for selecting bingo numbers;
- 2.9 (2) electronic bingo devices;
- 2.10 (3) electronic pull-tab devices;
- 2.11 (4) pull-tab dispensing devices;
- 2.12 (5) programmable electronic devices that have no effect on the outcome of a game
- 2.13 and are used to provide a visual or auditory enhancement of a game;
- 2.14 (6) paddlewheels; and
- 2.15 (7) paddlewheel tables.

2.19 Subd. 2a. **Merged organizations.** If two or more organizations merge or otherwise

2.20 join together to form a new organization and at least one of the organizations has an active

2.21 lawful gambling license, the board shall consider the new organization to have been in

2.22 existence for the most recent three years if all other requirements of subdivision 2 are met.

2.25 to read:

2.26 Subd. 9. **Distributor license termination plan.** (a) A licensed distributor that

2.27 surrenders, withdraws, or otherwise terminates its license must submit to the board, in

2.28 writing, a termination plan. Termination of a license may occur due to revocation or

2.29 denial of the license by the board, or by the distributor voluntarily quitting its business.

2.30 Termination plans must be approved by the executive director.

2.31 (b) The termination plan must include a certified physical inventory in a format

2.32 prescribed by the board. The certified physical inventory must also be submitted to the

3.1 commissioner of revenue. The certified physical inventory must include the following
3.2 information:

3.3 (1) an inventory of all gambling equipment as of the date the form is prepared,
3.4 including name, form number, bar code information, and quantity of all gambling
3.5 equipment in the distributor's inventory; and

3.6 (2) plans for disposal of all gambling equipment by the date of termination. After
3.7 the date on which a license is terminated, it is illegal for a distributor to possess gambling
3.8 equipment.

3.11 has been terminated.

3.12 **EFFECTIVE DATE.** This section is effective July 1, 2015.

3.14 Subd. 9. **Sales required.** No licensed manufacturer may refuse to sell gambling
3.15 equipment to a licensed distributor unless:

3.16 (1) a specific type of gambling equipment sold on an exclusive basis is at issue;

3.17 (2) the manufacturer does not sell gambling equipment to any distributor in
3.18 Minnesota;

3.19 (3) a Minnesota statute or rule prohibits the sale; or

3.20 (4) the distributor is delinquent on any payment owed to the manufacturer.

3.21 This subdivision does not apply to application software and those computer
3.22 programs used by a licensed manufacturer in the production, play, and reporting of

3.29 writing, a termination plan. Termination of a license may occur due to revocation or
3.30 denial of the license by the board, or by the manufacturer voluntarily quitting its business.
3.31 Termination plans must be approved by the executive director.

4.1 (b) The license termination plan must include the manufacturer's agreement to
4.2 accept returned defective equipment and issue credit for defective products up to six
4.3 months after the license termination date.

4.4 (c) The manufacturer or its designated agent must keep all invoices and other
4.5 required documentation related to the sale or disposal of gambling equipment for 3-1/2
4.6 years after the license has been terminated.

4.10 **Subd. 6. Linked bingo game provider license termination plan.** (a) A linked
4.11 bingo game provider that surrenders, withdraws, or otherwise terminates its license must
4.12 submit to the board, in writing, a termination plan. Termination of a license may occur
4.13 due to revocation or denial of the license by the board, or by the linked bingo game
4.14 provider voluntarily quitting its business. Termination plans must be approved by the
4.15 executive director.

4.16 (b) The license termination plan must include the reconciliation and refund of all
4.17 unredeemed prize pool contributions to organizations and the disposal of equipment.

4.18 (c) The linked bingo game provider or its designated agent must keep all invoices
4.19 and other required documentation related to the sale or disposal of gambling equipment
4.20 for 3-1/2 years after the license has been terminated.

4.23 **349.1641 LICENSES; SUMMARY SUSPENSION.**

4.24 (a) The board may (1) summarily suspend the license of an organization that is more
4.25 than 45 days late in filing a monthly report required to be submitted to the board under this
4.26 chapter or board rule or a tax return or in paying a tax required under chapter 297E and
4.27 may keep the suspension in effect until all required returns are filed and required taxes are
4.28 paid; (2) summarily suspend for not more than 90 days any license issued by the board or
4.29 director for what the board determines are actions detrimental to the integrity of lawful
4.30 gambling in Minnesota; (3) summarily suspend the license of a gambling manager who
4.31 has failed to receive the training required under section 349.167, subdivision 4, clause (2),
4.32 and may keep the suspension in effect until the gambling manager passes an examination
4.33 prepared and administered by the board. The examination does not qualify as continuing

5.1 education credit for the next calendar year; and (4) summarily suspend the license of an

5.4 (b) The board must notify the licensee at least 14 days before suspending the license
5.5 under this section. If a license is summarily suspended under this section, a contested
5.6 case hearing on the merits must be held within 20 days of the issuance of the order
5.7 of suspension, unless the parties agree to a later hearing date. The administrative law
5.8 judge's report must be issued within 20 days after the close of the hearing record. In all
5.9 cases involving summary suspension, the board must issue its final decision within 30
5.10 days after receipt of the report of the administrative law judge and subsequent exceptions
5.11 and argument under section 14.61. When an organization's license is suspended under
5.12 this section, the board shall within three days notify all municipalities in which the
5.13 organization's gambling premises are located and all licensed distributors in the state.

5.20 each event up to 12 events in a calendar year ~~in connection with a county fair, the State~~
5.21 ~~Fair, a church festival, or a civic celebration~~, not to exceed three days per event.

5.22 (b) No lease is required for the conduct of a raffle.

5.23 (c) No fee may be assessed for an off-site permit by the board or by local authority

5.27 **349.166 EXCLUSIONS; EXEMPTIONS.**

5.28 Subdivision 1. **Exclusions.** (a) Bingo, with the exception of linked bingo games, may
5.29 be conducted without a license and without complying with sections 349.168, subdivisions
5.30 1 and 2; 349.17, subdivisions 4 and 5; 349.18, subdivision 1; and 349.19, if it is conducted:

5.31 (1) by an organization in connection with a county fair, the state fair, or a civic
5.32 celebration and is not conducted for more than 12 consecutive days and is limited to no more
5.33 than four separate applications for activities applied for and approved in a calendar year; or

6.1 (2) by an organization that conducts bingo on four or fewer days in a calendar year.

6.2 An organization that holds a license to conduct lawful gambling under this chapter
6.3 may not conduct bingo under this subdivision.

6.17 exceed \$1,500 or, if the organization is a 501(c)(3) organization, if the value of all raffle
6.18 prizes awarded by the organization at one event in a calendar year does not exceed \$5,000.

6.19 (d) Except as provided in paragraph (b), the organization must maintain all required
6.20 records of excluded gambling activity for 3-1/2 years.

6.21 Subd. 2. **Exemptions.** (a) Lawful gambling, with the exception of linked bingo
6.22 games, may be conducted by an organization without a license and without complying
6.23 with sections 349.168, subdivisions 1 and 2; 349.17, subdivision 4; 349.18, subdivision 1;
6.24 and 349.19 if:

6.25 (1) the organization conducts lawful gambling on five or fewer days in a calendar year;

6.32 location of the occasion, the types of lawful gambling to be conducted, and the prizes
6.33 to be awarded;

6.35 gambling occasion, or 60 days for an occasion held in a city of the first class;

7.1 (5) the organization purchases all gambling equipment and supplies from a licensed
7.2 distributor; and

7.3 (6) the organization reports to the board, on a single-page form prescribed by the
7.4 board, within 30 days of each gambling occasion, the gross receipts, prizes, expenses,
7.5 expenditures of net profits from the occasion, and the identification of the licensed
7.6 distributor from whom all gambling equipment was purchased.

7.7 (b) No more than one organization exempted or excluded from licensing
7.8 requirements may conduct an individual raffle.

7.10 (2) Raffle tickets must not be attached to or combined with other exempted or
7.11 excluded organizations' raffle tickets and must be sold separately from other exempted
7.12 or excluded organizations' raffle tickets.

7.13 ~~(b)~~ (c) If the organization fails to file a timely report as required by paragraph (a),
7.14 clause (6), the board shall not issue any authorization, license, or permit to the organization
7.15 to conduct lawful gambling on an exempt, excluded, or licensed basis until the report has
7.16 been filed and the organization may be subject to penalty as determined by the board. The
7.17 board may refuse to issue any authorization, license, or permit if a report or application is
7.18 determined to be incomplete or knowingly contains false or inaccurate information.

7.20 ~~(d)~~ (e) Organizations that qualify to conduct exempt raffles under paragraph (a);
7.21 are exempt from section 349.173, paragraph (b), clause (2), if the raffle tickets are sold
7.22 only in combination with an organization's membership or a ticket for an organization's
7.23 membership dinner and are not included with any other raffle conducted under the exempt
7.24 permit.

7.25 ~~(e)~~ (f) Unused pull-tab and tipboard deals must be returned to the distributor within
7.26 seven working days after the end of the lawful gambling occasion. The distributor must
7.27 accept and pay a refund for all returns of unopened and undamaged deals returned under
7.28 this paragraph.

7.29 ~~(f)~~ (g) The organization must maintain all required records of exempt gambling
7.30 activity for 3-1/2 years.

7.31 **EFFECTIVE DATE.** This section is effective the day following final enactment for
7.32 all permits with an effective date of July 1, 2015, or later.

8.1 Subd. 8. **Compensation paid.** (a) A licensed organization may pay a percentage of
8.2 the gross profit from raffle ticket sales to a nonprofit organization that sells raffle tickets
8.3 for the licensed organization.

8.4 (b) A licensed organization may compensate an employee of the organization for
8.5 the sale of gambling equipment at a bar operation if the frequency of the activity is one
8.6 day or less per week and the games are limited to 32 chances or less per game. For
8.7 purposes of this paragraph, an employee must not be a lessor, employee of the lessor, or an
8.8 immediate family member of the lessor.

8.9 (c) An organization that leases a premises may not pay compensation to the lessor,
8.10 a member of the lessor's immediate family, or the lessor's employees, other than as a
8.11 seller of pull-tabs and tipboards within a booth operation on the premises. An employee
8.12 of the lessor or a member of the lessor's immediate family may be compensated by an
8.13 organization for the conduct of gambling at other sites not owned by the lessor.

8.19 ~~the director a list of all gambling equipment that the prices at which the manufacturer,~~
8.20 ~~distributor, or linked bingo game provider will sell all gambling equipment currently~~
8.21 ~~offered for sale by that manufacturer, distributor, or linked bingo game provider sold or~~

9.4 payment for a ~~progressive prize or a linked bingo prize~~ of \$200 or more must be delivered
9.5 within three business days of the day on which the occasion was conducted.

Subd. 9b. **Accounting manual.** The board must prepare and distribute to each organization licensed under this chapter a manual designed to facilitate compliance with section 349.19, subdivision 9a. The manual must include a clear description of the processes needed to maintain the records required in section 349.19, subdivision 9a. The board may contract for preparation of the manual.
