2.41 **INCOME AND CORPORATE FRANCHISE TAXES**

2.42 Section 1. Minnesota Statutes 2022, section 13.4967, is amended by adding a subdivision
 2.43 to read:

2.44 Subd. 9. New markets tax credit. Disclosure of information regarding issuance of new
 2.45 market tax credit certificates is governed under section 270B.14, subdivision 2, paragraph
 2.46 (a), clause (4).

2.47 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.1 Sec. 2. Minnesota Statutes 2022, section 41B.0391, subdivision 1, is amended to read:

3.2 Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms have
3.3 the meanings given.

3.4 (b) "Agricultural assets" means agricultural land, livestock, facilities, buildings, and
3.5 machinery used for farming in Minnesota.

3.6 (c) "Beginning farmer" means an individual who:

3.7 (1) is a resident of Minnesota;

3.8 (2) is seeking entry, or has entered within the last ten years, into farming;

3.9 (3) intends to farm land located within the state borders of Minnesota;

3.10 (4) except as provided in subdivision 2, paragraph (f), is not and whose spouse is not a
3.11 family member of the owner of the agricultural assets from whom the beginning farmer is
3.12 seeking to purchase or rent agricultural assets;

3.13 (5) except as provided in subdivision 2, paragraph (f), is not and whose spouse is not a
3.14 family member of a partner, member, shareholder, or trustee of the owner of agricultural
3.15 assets from whom the beginning farmer is seeking to purchase or rent agricultural assets;
3.16 and

3.17 (6) meets the following eligibility requirements as determined by the authority:

3.18 (i) has a net worth that does not exceed the limit provided under section 41B.03,
3.19 subdivision 3, paragraph (a), clause (2);

3.20 (ii) provides the majority of the day-to-day physical labor and management of the farm;

3.21 (iii) has, by the judgment of the authority, adequate farming experience or demonstrates
3.22 knowledge in the type of farming for which the beginning farmer seeks assistance from the
3.23 authority;

3.24 (iv) demonstrates to the authority a profit potential by submitting projected earnings
3.25 statements;

3.26 (v) asserts to the satisfaction of the authority that farming will be a significant source
3.27 of income for the beginning farmer;

3.28 (vi) is enrolled in or has completed within ten years of their first year of farming a
3.29 financial management program approved by the authority or the commissioner of agriculture;

4.1 (vii) agrees to notify the authority if the beginning farmer no longer meets the eligibility
4.2 requirements within the three-year certification period, in which case the beginning farmer
4.3 is no longer eligible for credits under this section; and

4.4 (viii) has other qualifications as specified by the authority.

4.5 The authority may waive the requirement in item (vi) if the participant requests a waiver
4.6 and has a four-year degree in an agricultural program or related field, reasonable agricultural
4.7 job-related experience, or certification as an adult farm management instructor.

4.8 (d) "Family member" means a family member within the meaning of the Internal Revenue
4.9 Code, section 267(c)(4).

4.10 (e) "Farm product" means plants and animals useful to humans and includes, but is not
4.11 limited to, forage and sod crops, oilseeds, grain and feed crops, dairy and dairy products,
4.12 poultry and poultry products, livestock, fruits, and vegetables.

4.13 (f) "Farming" means the active use, management, and operation of real and personal
4.14 property for the production of a farm product.

4.15 (g) "Owner of agricultural assets" means an individual, trust, or pass-through entity that
4.16 is the owner in fee of agricultural land or has legal title to any other agricultural asset. Owner
4.17 of agricultural assets does not mean an equipment dealer, livestock dealer defined in section
4.18 17A.03, subdivision 7, or comparable entity that is engaged in the business of selling
4.19 agricultural assets for profit and that is not engaged in farming as its primary business
4.20 activity. An owner of agricultural assets approved and certified by the authority under
4.21 subdivision 4 must notify the authority if the owner no longer meets the definition in this
4.22 paragraph within the three year certification period and is then no longer eligible for credits
4.23 under this section.

4.24 (h) "Resident" has the meaning given in section 290.01, subdivision 7.

4.25 (i) "Share rent agreement" means a rental agreement in which the principal consideration
4.26 given to the owner of agricultural assets is a predetermined portion of the production of
4.27 farm products produced from the rented agricultural assets and which provides for sharing
4.28 production costs or risk of loss, or both.

4.29 **EFFECTIVE DATE.** This section is effective for taxable years beginning after December
4.30 31, 2022.

5.1 Sec. 3. Minnesota Statutes 2022, section 41B.0391, subdivision 2, is amended to read:

5.2 Subd. 2. **Tax credit for owners of agricultural assets.** (a) An owner of agricultural
5.3 assets may take a credit against the tax due under chapter 290 for the sale or rental of
5.4 agricultural assets to a beginning farmer in the amount allocated by the authority under
5.5 subdivision 4. An owner of agricultural assets is eligible for allocation of a credit equal to:

5.6 (1) ~~five~~ eight percent of the lesser of the sale price or the fair market value of the
5.7 agricultural asset, up to a maximum of ~~\$32,000~~ \$50,000;

5.8 (2) ten percent of the gross rental income in each of the first, second, and third years of
5.9 a rental agreement, up to a maximum of \$7,000 per year; or

5.10 (3) 15 percent of the cash equivalent of the gross rental income in each of the first,
5.11 second, and third years of a share rent agreement, up to a maximum of \$10,000 per year.

5.12 (b) A qualifying rental agreement includes cash rent of agricultural assets or a share rent
5.13 agreement. The agricultural asset must be rented at prevailing community rates as determined
5.14 by the authority.

5.15 (c) The credit may be claimed only after approval and certification by the authority, and
5.16 is limited to the amount stated on the certificate issued under subdivision 4. An owner of
5.17 agricultural assets must apply to the authority for certification and allocation of a credit, in
5.18 a form and manner prescribed by the authority.

5.19 (d) An owner of agricultural assets or beginning farmer may terminate a rental agreement,
5.20 including a share rent agreement, for reasonable cause upon approval of the authority. If a
5.21 rental agreement is terminated without the fault of the owner of agricultural assets, the tax
5.22 credits shall not be retroactively disallowed. In determining reasonable cause, the authority
5.23 must look at which party was at fault in the termination of the agreement. If the authority
5.24 determines the owner of agricultural assets did not have reasonable cause, the owner of
5.25 agricultural assets must repay all credits received as a result of the rental agreement to the
5.26 commissioner of revenue. The repayment is additional income tax for the taxable year in
5.27 which the authority makes its decision or when a final adjudication under subdivision 5,
5.28 paragraph (a), is made, whichever is later.

5.29 (e) The credit is limited to the liability for tax as computed under chapter 290 for the
5.30 taxable year. If the amount of the credit determined under this section for any taxable year
5.31 exceeds this limitation, the excess is a beginning farmer incentive credit carryover according
5.32 to section 290.06, subdivision 37.

6.1 (f) For purposes of the credit for the sale of agricultural land only, the family member
 6.2 definitional exclusions in subdivision 1, paragraph (c), clauses (4) and (5), do not apply.
 6.3 For a sale to a family member to qualify for the credit, the sales price of the agricultural
 6.4 land must equal or exceed the assessed value of the land as of the date of the sale. For
 6.5 purposes of this paragraph, "sale to a family member" means a sale to a beginning farmer
 6.6 in which the beginning farmer or the beginning farmer's spouse is a family member of:

6.7 (1) the owner of the agricultural land; or

6.8 (2) a partner, member, shareholder, or trustee of the owner of the agricultural land.

6.9 (g) For a sale to a socially disadvantaged farmer or rancher, the credit rate under paragraph
 6.10 (a), clause (1), is twelve percent rather than eight percent. For the purposes of this section,
 6.11 "socially disadvantaged farmer or rancher" has the meaning given in United States Code,
 6.12 title 7, section 2279(a)(5).

6.13 **EFFECTIVE DATE.** This section is effective for taxable years beginning after December
 6.14 31, 2022.

6.15 Sec. 4. Minnesota Statutes 2022, section 41B.0391, subdivision 4, is amended to read:

6.16 Subd. 4. **Authority duties.** (a) The authority shall:

6.17 (1) approve and certify or recertify beginning farmers as eligible for the program under
 6.18 this section;

6.19 (2) approve and certify or recertify owners of agricultural assets as eligible for the tax
 6.20 credit under subdivision 2 subject to the allocation limits in paragraph (c);

6.21 (3) provide necessary and reasonable assistance and support to beginning farmers for
 6.22 qualification and participation in financial management programs approved by the authority;

6.23 (4) refer beginning farmers to agencies and organizations that may provide additional
 6.24 pertinent information and assistance; and

6.25 (5) notwithstanding section 41B.211, the Rural Finance Authority must share information
 6.26 with the commissioner of revenue to the extent necessary to administer provisions under
 6.27 this subdivision and section 290.06, subdivisions 37 and 38. The Rural Finance Authority
 6.28 must annually notify the commissioner of revenue of approval and certification or
 6.29 recertification of beginning farmers and owners of agricultural assets under this section.

6.30 For credits under subdivision 2, the notification must include the amount of credit approved
 6.31 by the authority and stated on the credit certificate.

7.1 (b) The certification of a beginning farmer or an owner of agricultural assets under this
 7.2 section is valid for the year of the certification and the two following years, after which
 7.3 time the beginning farmer or owner of agricultural assets must apply to the authority for
 7.4 recertification.

7.5 (c) For credits for owners of agricultural assets allowed under subdivision 2, the authority
 7.6 must not allocate more than ~~\$5,000,000 for taxable years beginning after December 31,~~
 7.7 ~~2017, and before January 1, 2019, and must not allocate more than \$6,000,000 for taxable~~
 7.8 ~~years beginning after December 31, 2018~~ \$4,000,000 for each taxable year. The authority
 7.9 must allocate credits on a first-come, first-served basis beginning on January 1 of each year,
 7.10 except that recertifications for the second and third years of credits under subdivision 2,
 7.11 paragraph (a), clauses (1) and (2), have first priority. Any amount authorized but not allocated
 7.12 for taxable years ending before January 1, 2024, are canceled and are not allocated for future

7.19 Subd. 6. **Report to legislature.** (a) No later than February 1, ~~2022~~ 2024, the Rural
 7.20 Finance Authority, in consultation with the commissioner of revenue, must provide a report
 7.21 to the chairs and ranking minority members of the legislative committees having jurisdiction
 7.22 over agriculture, economic development, rural development, and taxes, in compliance with
 7.23 sections 3.195 and 3.197, on the beginning farmer tax credits under this section issued in
 7.24 tax years beginning after December 31, 2017, and before January 1, ~~2022~~ 2024.

7.25 (b) The report must include background information on beginning farmers in Minnesota
 7.26 and any other information the commissioner and authority find relevant to evaluating the
 7.27 effect of the credits on increasing opportunities for and the number of beginning farmers.

7.28 (c) For credits issued under subdivision 2, paragraph (a), clauses (1) to (3), the report
 7.29 must include:

7.30 (1) the number and amount of credits issued under each clause;

7.32 (3) the type of agricultural assets for which credits were issued under clause (1);

8.1 (4) the number and geographic distribution of beginning farmers whose purchase or
8.2 rental of assets resulted in credits for the seller or owner of the asset;

8.3 (5) the number and amount of credits disallowed under subdivision 2, paragraph (d);

8.4 (6) data on the number of beginning farmers by geographic region in calendar years
8.5 2017 through ~~2021~~ 2023, including:

8.6 (i) the number of beginning farmers by race and ethnicity, as those terms are applied in
8.7 the 2020 United States Census; and

8.8 (ii) to the extent available, the number of beginning farmers who are members of a
8.9 socially disadvantaged group, as defined in United States Code, title 7, section 2279(a)(6);

8.11 (7) the number and amount of credit applications that exceeded the allocation available

8.13 (d) For credits issued under subdivision 3, the report must include:

8.14 (1) the number and amount of credits issued;

8.15 (2) the geographic distribution of credits;

8.16 (3) a listing and description of each approved financial management program for which
8.17 credits were issued; and

8.18 (4) a description of the approval procedure for financial management programs not on
8.19 the list maintained by the authority, as provided in subdivision 3, paragraph (a).

8.20 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.21 Sec. 6. Minnesota Statutes 2022, section 116J.401, subdivision 3, is amended to read:

8.22 Subd. 3. **Classification and release of data on individuals.** (a) Data collected on
8.23 individuals pursuant to a program operated by the commissioner are private data on
8.24 individuals as defined in section 13.02, subdivision 12, unless more restrictively classified
8.25 by law.

8.26 (b) The commissioner may release to the Department of Revenue data on individuals to
8.27 the extent required to administer the new markets tax credit under chapter 116X and sections
8.28 290.0693 and 297I.20, subdivision 6.

8.29 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.1 Sec. 7. Minnesota Statutes 2022, section 116J.8737, subdivision 5, is amended to read:

9.2 Subd. 5. **Credit allowed.** (a) A qualified investor or qualified fund is eligible for a credit
9.3 equal to 25 percent of the qualified investment in a qualified small business. Investments
9.4 made by a pass-through entity qualify for a credit only if the entity is a qualified fund. The
9.5 commissioner must not allocate to qualified investors or qualified funds more than the dollar
9.6 amount in credits allowed for the taxable years listed in paragraph (i). For each taxable year,
9.7 50 percent must be allocated to credits for qualified investments in qualified greater
9.8 Minnesota businesses and minority-owned, women-owned, or veteran-owned qualified
9.9 small businesses in Minnesota. Any portion of a taxable year's credits that is reserved for
9.10 qualified investments in greater Minnesota businesses and minority-owned, women-owned,
9.11 or veteran-owned qualified small businesses in Minnesota that is not allocated by September
9.12 30 of the taxable year is available for allocation to other credit applications beginning on
9.13 October 1. Any portion of a taxable year's credits that is not allocated by the commissioner
9.14 does not cancel and may be carried forward to subsequent taxable years until all credits
9.15 have been allocated.

9.16 (b) The commissioner may not allocate more than a total maximum amount in credits
9.17 for a taxable year to a qualified investor for the investor's cumulative qualified investments
9.18 as an individual qualified investor and as an investor in a qualified fund; for married couples
9.19 filing joint returns the maximum is \$250,000, and for all other filers the maximum is
9.20 \$125,000. The commissioner may not allocate more than a total of \$1,000,000 in credits
9.21 over all taxable years for qualified investments in any one qualified small business.

9.22 (c) The commissioner may not allocate a credit to a qualified investor either as an
9.23 individual qualified investor or as an investor in a qualified fund if, at the time the investment
9.24 is proposed:

9.25 (1) the investor is an officer or principal of the qualified small business; or

9.26 (2) the investor, either individually or in combination with one or more members of the
9.27 investor's family, owns, controls, or holds the power to vote 20 percent or more of the
9.28 outstanding securities of the qualified small business.

9.29 A member of the family of an individual disqualified by this paragraph is not eligible for a
9.30 credit under this section. For a married couple filing a joint return, the limitations in this
9.31 paragraph apply collectively to the investor and spouse. For purposes of determining the
9.32 ownership interest of an investor under this paragraph, the rules under section 267(c) and
9.33 267(e) of the Internal Revenue Code apply.

10.1 (d) Applications for tax credits must be made available on the department's website by
10.2 November 1 of the preceding year.

10.3 (e) Qualified investors and qualified funds must apply to the commissioner for tax credits.
10.4 Tax credits must be allocated to qualified investors or qualified funds in the order that the
10.5 tax credit request applications are filed with the department. The commissioner must approve
10.6 or reject tax credit request applications within 15 days of receiving the application. The
10.7 investment specified in the application must be made within 60 days of the allocation of
10.8 the credits. If the investment is not made within 60 days, the credit allocation is canceled
10.9 and available for reallocation. A qualified investor or qualified fund that fails to invest as
10.10 specified in the application, within 60 days of allocation of the credits, must notify the
10.11 commissioner of the failure to invest within five business days of the expiration of the
10.12 60-day investment period.

10.13 (f) All tax credit request applications filed with the department on the same day must
10.14 be treated as having been filed contemporaneously. If two or more qualified investors or

(b) "Appropriation bond" means a bond, note, or other similar instrument of the state payable during a biennium from one or more of the following sources:

(1) money appropriated by law from the general fund in any biennium for debt service due with respect to obligations described in subdivision 2, paragraph (b);

(2) proceeds of the sale of obligations described in subdivision 2, paragraph (b);

(3) payments received for that purpose under agreements and ancillary arrangements described in subdivision 2, paragraph (d); and

(4) investment earnings on amounts in clauses (1) to (3).

(c) "Debt service" means the amount payable in any biennium of principal, premium, if any, and interest on appropriation bonds.

Subd. 2. **Authorization to issue appropriation bonds.** (a) Subject to the limitations of this subdivision, the commissioner may sell and issue appropriation bonds of the state under this section for public purposes as provided by law, including, in particular, the financing of all or a portion of the acquisition, construction, improving, and equipping of the stadium project of the Minnesota Sports Facilities Authority as provided by chapter 473J. Proceeds of the appropriation bonds must be credited to a special appropriation stadium bond proceeds fund in the state treasury. Net income from investment of the proceeds, as estimated by the commissioner, must be credited to the special appropriation stadium bond proceeds fund.

(b) Appropriation bonds may be sold and issued in amounts that, in the opinion of the commissioner, are necessary to provide sufficient funds, not to exceed \$498,000,000 net of costs of issuance, revenue generated under section 297E.021, and allocated by the commissioner of management and budget for this purpose and costs of credit enhancement for achieving the purposes authorized as provided under paragraph (a), and pay debt service including capitalized interest, pay costs of issuance, make deposits to reserve funds, pay the costs of credit enhancement, or make payments under other agreements entered into under paragraph (d); provided, however, that appropriation bonds issued and unpaid shall not exceed \$600,000,000 in principal amount, excluding refunding bonds sold and issued under subdivision 4.

(c) Appropriation bonds may be issued from time to time in one or more series on the terms and conditions the commissioner determines to be in the best interests of the state, but the term on any series of appropriation bonds may not exceed 30 years. The appropriation bonds of each issue and series thereof shall be dated and bear interest, and may be includable in or excludable from the gross income of the owners for federal income tax purposes.

(d) At the time of, or in anticipation of, issuing the appropriation bonds, and at any time thereafter, so long as the appropriation bonds are outstanding, the commissioner may enter into agreements and ancillary arrangements relating to the appropriation bonds, including but not limited to trust indentures, grant agreements, lease or use agreements, operating agreements, management agreements, liquidity facilities, remarketing or dealer agreements, letter of credit agreements, insurance policies, guaranty agreements, reimbursement agreements, indexing agreements, or interest exchange agreements. Any payments made or received according to the agreement or ancillary arrangement shall be made from or deposited as provided in the agreement or ancillary arrangement. The determination of the commissioner included in an interest exchange agreement that the agreement relates to an appropriation bond shall be conclusive.

(e) The commissioner may enter into written agreements or contracts relating to the continuing disclosure of information necessary to comply with, or facilitate the issuance of appropriation bonds in accordance with federal securities laws, rules, and regulations, including Securities and Exchange Commission rules and regulations in Code of Federal Regulations, title 17, section 240.15c 2-12. An agreement may be in the form of covenants with purchasers and holders of appropriation bonds set forth in the order or resolution authorizing the issuance of the appropriation bonds, or a separate document authorized by the order or resolution.

(f) The appropriation bonds are not subject to chapter 16C.

Subd. 3. **Form; procedure.** (a) Appropriation bonds may be issued in the form of bonds, notes, or other similar instruments, and in the manner provided in section 16A.672. In the event that any provision of section 16A.672 conflicts with this section, this section shall control.

(b) Every appropriation bond shall include a conspicuous statement of the limitation established in subdivision 6.

(c) Appropriation bonds may be sold at either public or private sale upon such terms as the commissioner shall determine are not inconsistent with this section and may be sold at any price or percentage of par value. Any bid received may be rejected.

(d) Appropriation bonds must bear interest at a fixed or variable rate.

(e) Notwithstanding any other law, appropriation bonds issued under this section shall be fully negotiable.

Subd. 4. **Refunding bonds.** The commissioner from time to time may issue appropriation bonds for the purpose of refunding any appropriation bonds then outstanding, including the payment of any redemption premiums on the bonds, any interest accrued or to accrue to the redemption date, and costs related to the issuance and sale of the refunding bonds. The proceeds of any refunding bonds may, in the discretion of the commissioner, be applied to the purchase or payment at maturity of the appropriation bonds to be refunded, to the redemption of the outstanding appropriation bonds on any redemption date, or to pay interest on the refunding bonds and may, pending application, be placed in escrow to be applied to the purchase, payment, retirement, or redemption. Any escrowed proceeds, pending such use, may be invested and reinvested in obligations that are authorized investments under section 11A.24. The income earned or realized on the investment may also be applied to the payment of the appropriation bonds to be refunded or interest or premiums on the refunded appropriation bonds, or to pay interest on the refunding bonds. After the terms of the escrow have been fully satisfied, any balance of the proceeds and any investment income may be returned to the general fund or, if applicable, the special appropriation stadium bond proceeds fund for use in any lawful manner. All refunding bonds issued under this subdivision must be prepared, executed, delivered, and secured by appropriations in the same manner as the appropriation bonds to be refunded.

Subd. 5. **Appropriation bonds as legal investments.** Any of the following entities may legally invest any sinking funds, money, or other funds belonging to them or under their control in any appropriation bonds issued under this section:

(1) the state, the investment board, public officers, municipal corporations, political subdivisions, and public bodies;

(2) banks and bankers, savings and loan associations, credit unions, trust companies, savings banks and institutions, investment companies, insurance companies, insurance associations, and other persons carrying on a banking or insurance business; and

(3) personal representatives, guardians, trustees, and other fiduciaries.

Subd. 6. **No full faith and credit; state not required to make appropriations.** The appropriation bonds are not public debt of the state, and the full faith, credit, and taxing powers of the state are not pledged to the payment of the appropriation bonds or to any payment that the state agrees to make under this section. Appropriation bonds shall not be obligations paid directly, in whole or in part, from a tax of statewide application on any class of property, income, transaction, or privilege. Appropriation bonds shall be payable in each fiscal year only from amounts that the legislature may appropriate for debt service for any fiscal year, provided that nothing in this section shall be construed to require the state to appropriate funds sufficient to make debt service payments with respect to the appropriation bonds in any fiscal year. Appropriation bonds shall be canceled and shall no longer be outstanding on the earlier of (1) the first day of a fiscal year for which the legislature shall not have appropriated amounts sufficient for debt service, or (2) the date of final payment of the principal of and interest on the appropriation bonds.

Subd. 7. **Appropriation of proceeds.** The proceeds of appropriation bonds and interest credited to the special appropriation stadium bond proceeds fund are appropriated to the commissioner for payment of capital expenses including capitalized interest, debt service on outstanding indebtedness of the state, and for the operating and capital reserves of the authority, each as permitted by state and federal law, and nonsalary expenses incurred in conjunction with the sale of the appropriation bonds, and such proceeds may be granted, loaned, or otherwise provided to the authority for the public purpose provided by subdivision 2, paragraph (a).

Subd. 9. **Waiver of immunity.** The waiver of immunity by the state provided for by section 3.751, subdivision 1, shall be applicable to the appropriation bonds and any ancillary contracts to which the commissioner is a party.

Subd. 10. **Validation.** (a) Appropriation bonds issued under this section may be validated in the manner provided by this subdivision. If comparable appropriation bonds are judicially determined to be valid, nothing in this subdivision shall be construed to prevent the sale or delivery of any appropriation bonds or notes without entry of a judgment of validation by the Minnesota Supreme Court pursuant to this subdivision with respect to the appropriation bonds authorized under this section.

(b) Any appropriation bonds issued under this section that are validated shall be validated in the manner provided by this subdivision.

(c) The Minnesota Supreme Court shall have original jurisdiction to determine the validation of appropriation bonds and all matters connected therewith.

(d) The commissioner may determine the commissioner's authority to issue appropriation bonds and the legality of all proceedings in connection with issuing bonds. For this purpose, a complaint shall be filed by the commissioner in the Minnesota Supreme Court against the state and the taxpayers and citizens.

(e) As a condition precedent to filing of a complaint for the validation of appropriation bonds, the commissioner shall take action providing for the issuance of appropriation bonds in accordance with law.

(f) The complaint shall set out the state's authority to issue appropriation bonds, the action or proceeding authorizing the issue and its adoption, all other essential proceedings had or taken in connection with issuing bonds, the amount of the appropriation bonds to be issued and the maximum interest they are to bear, and all other pertinent matters.

(g) The Minnesota Supreme Court shall issue an order directed against the state and taxpayers, citizens, and others having or claiming any right, title, or interest affected by the issuance of appropriation bonds, or to be affected by the bonds, allowing all persons, in general terms and without naming them, and the state through its attorney general, to appear before the Minnesota Supreme Court at a designated time and place and show why the complaint should not be granted and the proceedings and appropriation bonds validated. A copy of the complaint and order shall be served on the attorney general at least 20 days before the time fixed for hearing. The attorney general shall examine the complaint, and, if it appears or there is reason to believe that it is defective, insufficient, or untrue, or if in the opinion of the attorney general the issuance of the appropriation bonds in question has not been duly authorized, defense shall be made by the attorney general as the attorney general deems appropriate.

(h) Before the date set for hearing, as directed by the Minnesota Supreme Court, either the clerk of the Minnesota appellate courts or the commissioner shall publish a copy of the order in a legal newspaper of general circulation in Ramsey County and the state, at least once each week for two consecutive weeks, commencing with the first publication, which shall not be less than 20 days before the date set for hearing. By this publication, all taxpayers, citizens, and others having or claiming any right, title, or interest in the state, are made parties defendant to the action and the Minnesota Supreme Court has jurisdiction of them to the same extent as if named as defendants in the complaint and personally served with process.

(i) Any taxpayer, citizen, or person interested may become a party to the action by moving against or pleading to the complaint at or before the time set for hearing. The Minnesota Supreme Court shall determine all questions of law and fact and make orders that will enable it to properly try and determine the action and render a final judgment within 30 days of the hearing with the least possible delay.

(j) If the judgment validates appropriation bonds, the judgment is forever conclusive as to all matters adjudicated and as against all parties affected and all others having or claiming any right, title, or interest affected by the issuance of appropriation bonds, or to be affected in any way by issuing the bonds, and the validity of appropriation bonds or of any revenues pledged for the payment

of the bonds, or of the proceedings authorizing the issuance of the bonds, including any remedies provided for their collection, shall never be called in question in any court by any person or party.

(k)(1) Appropriation bonds, when validated under this section, shall have stamped or written on the bonds, by the proper officers of the state issuing them, a statement in substantially the following form: "This appropriation bond is one of a series of appropriation bonds which were validated by judgment of the Supreme Court of the State of Minnesota, rendered on , (year)".

(2) A certified copy of the judgment or decree shall be received as evidence in any court in this state.

(l) The costs shall be paid by the state, except when a taxpayer, citizen, or other person contests the action or intervenes, the court may tax the whole or any part of the costs against the person that is equitable.

(m) A justice of the Minnesota Supreme Court is not disqualified in any validation action because the justice is a landowner or taxpayer of the state.

290.0681 CREDIT FOR HISTORIC STRUCTURE REHABILITATION.

Subd. 10. **Sunset.** This section expires after fiscal year 2022, except that the office's authority to issue credit certificates under subdivision 4 based on allocation certificates that were issued before fiscal year 2023 remains in effect through 2025, and the reporting requirements in subdivision 9 remain in effect through the year following the year in which all allocation certificates have either been canceled or resulted in issuance of credit certificates, or 2026, whichever is earlier.

297E.021 SPECIAL ALLOCATION OF REVENUES.

Subdivision 1. **Application; revenues not pledged.** The provisions of this subdivision apply only after the issuance of appropriation bonds under section 16A.965, subdivision 2, but do not constitute a pledge of available revenues as security for payment of principal and interest on appropriation bonds issued under section 16A.965.

Subd. 2. **Determination of revenue increase.** By March 15 of each fiscal year, the commissioner of management and budget, in consultation with the commissioner, shall determine the estimated increase in revenues received from taxes imposed under this chapter over the estimated revenues under the February 2012 state budget forecast for that fiscal year. For fiscal years after fiscal year 2015, the commissioner of management and budget shall use the February 2012 state budget forecast for fiscal year 2015 as the baseline. All calculations under this subdivision must be made net of estimated refunds of the taxes required to be paid.

Subd. 3. **Available revenues.** For purposes of this section, "available revenues" equals the amount determined under subdivision 2, plus up to \$20,000,000 each fiscal year from the taxes imposed under section 290.06, subdivision 1:

(1) reduced by the following amounts paid for the fiscal year under:

(i) the appropriation to principal and interest on appropriation bonds under section 16A.965, subdivision 8;

(ii) the appropriation from the general fund to make operating expense payments under section 473J.13, subdivision 2, paragraph (b);

(iii) the appropriation for contributions to the capital reserve fund under section 473J.13, subdivision 4, paragraph (c);

(iv) the appropriations under Laws 2012, chapter 299, article 4, for administration and any successor appropriation;

(v) the reduction in revenues resulting from the sales tax exemptions under section 297A.71, subdivision 43;

(vi) reimbursements authorized by section 473J.15, subdivision 2, paragraph (d);

(vii) the compulsive gambling appropriations under section 297E.02, subdivision 3, paragraph (c), and any successor appropriation; and

(2) increased by the revenue deposited in the general fund under section 297A.994, subdivision 4, clauses (1) to (3), for the fiscal year.

Subd. 4. Appropriation; general reserve account. To the extent the commissioner determines that revenues are available under subdivision 3 for the fiscal year, those amounts are appropriated from the general fund for deposit in a general reserve account established by order of the commissioner of management and budget. Amounts in this reserve are appropriated as necessary for application against any shortfall in the amounts deposited to the general fund under section 297A.994 or, after consultation with the Legislative Commission on Planning and Fiscal Policy, amounts in this reserve are appropriated to the commissioner of management and budget for other uses related to the stadium authorized under section 473J.03, subdivision 8, that the commissioner deems financially prudent including but not limited to reimbursements for capital and operating costs relating to the stadium, refundings, and prepayment of debt. In no event, shall available revenues be pledged, nor shall the appropriations of available revenues made by this section constitute a pledge of available revenues as security for the prepayment of principal and interest on the appropriation bonds under section 16A.965.

477A.011 DEFINITIONS.

Subd. 30a. Percent of housing built between 1940 and 1970. "Percent of housing built between 1940 and 1970" is equal to 100 times the most recent count by the United States Bureau of the Census of all housing units in the city built after 1939 but before 1970, divided by the total number of all housing units in the city. Housing units includes both occupied and vacant housing units as defined by the federal census.

Subd. 38. Household size. "Household size" means the average number of persons per household in the jurisdiction as most recently estimated and reported by the state demographer and Metropolitan Council as of July 15 of the aid calculation year. A revision to an estimate or enumeration is effective for these purposes only if it is certified to the commissioner on or before July 15 of the aid calculation year. Clerical errors in the certification or use of estimates and counts established as of July 15 in the aid calculation year are subject to correction within the time periods allowed under section 477A.014.

Subd. 42. Jobs per capita in the city. "Jobs per capita in the city" means (1) the average annual number of employees in the city based on the data from the Quarterly Census of Employment and Wages, as reported by the Department of Employment and Economic Development, for the most recent calendar year available November 1 of every odd-numbered year, divided by (2) the city's population for the same calendar year as the employment data. The commissioner of the Department of Employment and Economic Development shall certify to the city the average annual number of employees for each city by January 1 of every even-numbered year beginning with January 1, 2014. A city may challenge an estimate under this paragraph by filing its specific objection, including the names of employers that it feels may have misreported data, in writing with the commissioner by December 1 of every odd-numbered year. The commissioner shall make every reasonable effort to address the specific objection and adjust the data as necessary. The commissioner shall certify the estimates of the annual employment to the commissioner of revenue by January 1 of all even-numbered years, including any estimates still under objection.

Subd. 45. Sparsity adjustment. For a city with a population of 10,000 or more, the sparsity adjustment is 100 for any city with an average population density less than 150 per square mile, according to the most recent federal census. For a city with a population less than 10,000, the sparsity adjustment is 200 for any city with an average population density less than 30 per square mile, according to the most recent federal census. The sparsity adjustment is zero for all other cities.

477A.013 MUNICIPAL GOVERNMENT DISTRIBUTIONS.

Subd. 13. Certified aid adjustments. (a) A city that received an aid base increase under Minnesota Statutes 2012, section 477A.011, subdivision 36, paragraph (e), shall have its total aid under subdivision 9 increased by an amount equal to \$150,000 for aids payable in 2014 through 2018.

(b) A city that received an aid base increase under Minnesota Statutes 2012, section 477A.011, subdivision 36, paragraph (r), shall have its total aid under subdivision 9 increased by an amount equal to \$160,000 for aids payable in 2014 and thereafter.

(c) A city that received a temporary aid increase under Minnesota Statutes 2012, section 477A.011, subdivision 36, paragraph (o), shall have its total aid under subdivision 9 increased by an amount equal to \$1,000,000 for aids payable in 2014 only.

477B.02 QUALIFYING FOR FIRE STATE AID.

Subd. 4. **Equipment requirements.** The fire department must have all of the following equipment, or the equivalent as determined by the state fire marshal, by December 31 of the year preceding the certification required in subdivision 8:

- (1) a motorized fire truck equipped with:
 - (i) a motorized pump;
 - (ii) a 250-gallon or larger water tank;
 - (iii) 300 feet of one inch or larger fire hose in two lines with combination spray and straight stream nozzles;
 - (iv) five-gallon hand pumps - tank extinguisher or equivalent;
 - (v) a dry chemical extinguisher or equivalent;
 - (vi) ladders;
 - (vii) extension ladders;
 - (viii) pike poles;
 - (ix) crowbars;
 - (x) axes;
 - (xi) lanterns; and
 - (xii) fire coats, helmets, and boots;
- (2) the items in clause (1) suitably housed in a building of good construction with facilities for care of hoses and equipment;
- (3) a reliable and adequate method of receiving fire alarms by telephone or with electric siren and suitable means of sounding an alarm; and
- (4) if response is to be provided outside the corporate limits of the municipality where the fire department is located, another piece of motorized apparatus to make the response.

477B.03 CALCULATION OF FIRE STATE AID; APPEAL.

Subd. 6. **Corrective aid adjustments.** Any adjustments needed to correct prior misallocations must be made to subsequent fire state aid apportionments.
