AMEND House Committee Substitute for House Bill No. 307, Page 5, Section 300.010, Line 141, by inserting after all of said section and line the following:
"300.155. Whenever traffic is controlled by traffic control signals exhibiting different
colored lights, or colored lighted arrows, successively one at a time or in combination, only the colors green, red and yellow shall be used, except for special pedestrian signals carrying a word
legend, and said lights shall indicate and apply to drivers of vehicles and pedestrians as follows:
(1) Green indication
(a) Vehicular traffic facing a circular green signal may proceed straight through or turn right
or left unless a sign at such place prohibits either such turn. But vehicular traffic, including vehicle
turning right or left, shall yield the right-of-way to other vehicles and to pedestrians lawfully within
the intersection or an adjacent crosswalk at the time such signal is exhibited;
(b) Vehicular traffic facing a green arrow signal, shown alone or in combination with
another indication, may cautiously enter the intersection only to make the movement indicated by such arrow, or such other movement as is permitted by other indications shown at the same time.
Such vehicular traffic shall yield the right-of-way to pedestrians lawfully within an adjacent
crosswalk and to other traffic lawfully using the intersection;
(c) Unless otherwise directed by a pedestrian control signal as provided in section 300.160
pedestrians facing any green signal, except when the sole green signal is a turn arrow, may proceed
across the roadway within any marked or unmarked crosswalk.
(2) Steady yellow indication
(a) Vehicular traffic facing a steady yellow signal is thereby warned that the related green
movement is being terminated or that a red indication will be exhibited immediately thereafter wh
vehicular traffic shall not enter the intersection;
(b) Pedestrians facing a steady yellow signal, unless otherwise directed by a pedestrian
control signal as provided in section 300.160, are thereby advised that there is insufficient time to
cross the roadway before a red indication is shown and no pedestrian shall then start to cross the
roadway.
(3) Steady red indication(a) Vehicular traffic facing a steady red signal alone shall stop before entering the crosswa
on the near side of the intersection or, if none, then before entering the intersection and shall remain
standing until a green indication is shown except as provided in paragraph (b) of this subdivision;
(b) The driver of a vehicle which is stopped as close as practicable at the entrance to the
crosswalk on the near side of the intersection or, if none, then at the entrance to the intersection in
obedience to a red signal, may cautiously enter the intersection to make a right turn but shall yield
the right-of-way to pedestrians and other traffic proceeding as directed by the signal at the

intersection, except that the state highways and transportation commission with reference to an 1 2 intersection involving a state highway, and local authorities with reference to an intersection 3 involving other highways under their jurisdiction, may prohibit any such right turn against a red 4 signal at any intersection where safety conditions so require, said prohibition shall be effective when 5 a sign is erected at such intersection giving notice thereof;

6 (c) The driver of a vehicle which is in the left-most lane on a one-way street and stopped as 7 close as practicable at the entrance to the crosswalk on the near side of the intersection or, if none, 8 then at the entrance to the intersection in obedience to a red signal, may cautiously enter the 9 intersection to make a left turn onto a one-way street but shall yield the right-of-way to pedestrians 10 and other traffic proceeding as directed by the signal at the intersection, except that the state highways and transportation commission with reference to an intersection involving a state highway, 11 12 and local authorities with reference to an intersection involving other highways under their jurisdiction, may prohibit any such left turn against a red signal at any intersection where safety 13 14 conditions so require and such prohibition shall be effective when a sign is erected at such 15 intersection giving notice thereof; 16 (d) Unless otherwise directed by a pedestrian control signal as provided in section 300.160, 17 pedestrians facing a steady red signal alone shall not enter the roadway. 18 (4) In the event an official traffic control signal is erected and maintained at a place other 19 than an intersection, the provisions of this section shall be applicable except as to those provisions 20 which by their nature can have no application. Any stop required shall be made at a sign or marking on the pavement indicating where the stop shall be made, but in the absence of any such sign or 21 22 marking the stop shall be made at the signal."; and 23 24 Further amend said bill, Page 21, Section 304.001, Line 66, by inserting after all of said section and 25 line the following:

27 "304.281. 1. Whenever traffic is controlled by traffic control signals exhibiting different 28 colored lights, or colored lighted arrows, successively one at a time or in combination, only the 29 colors green, red and yellow shall be used, except for special pedestrian signals carrying a word 30 legend, and said lights shall indicate and apply to drivers of vehicles and pedestrians as follows: 31

(1) Green indication

32 (a) Vehicular traffic facing a circular green signal may proceed straight through or turn right 33 or left unless a sign at such place prohibits either such turn. But vehicular traffic, including vehicles 34 turning right or left, shall yield the right-of-way to other vehicles and to pedestrians lawfully within 35 the intersection or an adjacent crosswalk at the time such signal is exhibited;

36 (b) Vehicular traffic facing a green arrow signal, shown alone or in combination with 37 another indication, may cautiously enter the intersection only to make the movement indicated by 38 such arrow, or such other movement as is permitted by other indications shown at the same time. 39 Such vehicular traffic shall yield the right-of-way to pedestrians lawfully within an adjacent 40 crosswalk and to other traffic lawfully using the intersection;

41 (c) Unless otherwise directed by a pedestrian control signal, as provided in section 304.291, 42 pedestrians facing any green signal, except when the sole green signal is a turn arrow, may proceed 43 across the roadway within any marked or unmarked crosswalk.

(2) Steady yellow indication

45 (a) Vehicular traffic facing a steady yellow signal is thereby warned that the related green 46 movement is being terminated or that a red indication will be exhibited immediately thereafter when 47 vehicular traffic shall not enter the intersection;

48 (b) Pedestrians facing a steady yellow signal, unless otherwise directed by a pedestrian 49 control signal as provided in section 304.291, are thereby advised that there is insufficient time to

- 1 cross the roadway before a red indication is shown and no pedestrian shall then start to cross the 2 roadway.
 - (3) Steady red indication

4 (a) Vehicular traffic facing a steady red signal alone shall stop before entering the crosswalk 5 on the near side of the intersection at a clearly marked stop line but, if none, then before entering the 6 intersection and shall remain standing until an indication to proceed is shown except as provided in 7 paragraph (b);

8 (b) The driver of a vehicle which is stopped as close as practicable at the entrance to the 9 crosswalk on the near side of the intersection or, if none, then at the entrance to the intersection in 10 obedience to a red signal, may cautiously enter the intersection to make a right turn but shall yield the right-of-way to pedestrians and other traffic proceeding as directed by the signal at the 11 12 intersection, except that the state highways and transportation commission with reference to an intersection involving a state highway, and local authorities with reference to an intersection 13 14 involving other highways under their jurisdiction, may prohibit any such right turn against a red 15 signal at any intersection where safety conditions so require, said prohibition shall be effective when 16 a sign is erected at such intersection giving notice thereof:

(c) <u>The driver of a vehicle which is in the left-most lane on a one-way street and stopped as</u>
 close as practicable at the entrance to the crosswalk on the near side of the intersection or, if none,
 then at the entrance to the intersection in obedience to a red signal, may cautiously enter the

20 intersection to make a left turn onto a one-way street but shall yield the right-of-way to pedestrians

21 and other traffic proceeding as directed by the signal at the intersection, except that the state

22 highways and transportation commission with reference to an intersection involving a state highway,

23 and local authorities with reference to an intersection involving other highways under their

24 jurisdiction, may prohibit any such left turn against a red signal at any intersection where safety

- 25 conditions so require and such prohibition shall be effective when a sign is erected at such 26 intersection giving notice thereof;
- 27 (d) Unless otherwise directed by a pedestrian control signal as provided in section 304.291,
 28 pedestrians facing a steady red signal alone shall not enter the roadway.

(4) In the event an official traffic control signal is erected and maintained at a place other
than an intersection, the provision of this section shall be applicable except as to those provisions
which by their nature can have no application. Any stop required shall be made at a sign or marking
on the pavement indicating where the stop shall be made, but in the absence of any such sign or
marking the stop shall be made at the signal.

Notwithstanding the provisions of section 304.361, violation of this section is a class C
 misdemeanor."; and
