AMEND House Amendment No. to House Committee Substitute for House Bill No. 876,
 Page 1, Line 4, by deleting said line and inserting in lieu thereof the following:

4 "590.120. 1. There is hereby established within the department of public safety a "Peace" 5 Officer Standards and Training Commission" which shall be composed of eleven members, 6 including a voting public member, appointed by the governor, by and with the advice and consent of 7 the senate, from a list of qualified candidates submitted to the governor by the director of the 8 department of public safety. No more than two members of the POST commission shall reside in 9 the same congressional district as any other at the time of their appointments but this provision shall not apply to the public member. Three members of the POST commission shall be police chiefs, 10 11 three members shall be sheriffs, one member shall represent a state law enforcement agency covered by the provisions of this chapter, two members shall be peace officers at or below the rank of 12 13 sergeant employed by a political subdivision, and one member shall be a chief executive officer of a 14 certified training academy. The public member shall be at the time of appointment a registered voter; a person who is not and never has been a member of any profession certified or regulated 15 under this chapter or the spouse of such person; and a person who does not have and never has had a 16 17 material financial interest in either the providing of the professional services regulated by this 18 chapter, or an activity or organization directly related to any profession certified or regulated under this chapter. Each member of the POST commission shall have been at the time of his appointment 19 20 a citizen of the United States and a resident of this state for a period of at least one year, and 21 members who are peace officers shall be qualified as established by this chapter. No member of the POST commission serving a full term of three years may be reappointed to the POST commission 22 23 until at least one year after the expiration of his most recent term. 2. Three of the original members of the POST commission shall be appointed for terms of 24

25 one year, three of the original members shall be appointed for terms of two years, and three of the original members shall be appointed for terms of three years. Thereafter the terms of the members 26 27 of the POST commission shall be for three years or until their successors are appointed. The 28 director may remove any member of the POST commission for misconduct or neglect of office. Any member of the POST commission may be removed for cause by the director but such member 29 30 shall first be presented with a written statement of the reasons thereof, and shall have a hearing before the POST commission if the member so requests. Any vacancy in the membership of the 31 commission shall be filled by appointment for the unexpired term. No two members of the POST 32 33 commission shall be employees of the same law enforcement agency.

3. Annually the director shall appoint one of the members as chairperson. The POST

- 1 commission shall meet at least twice each year as determined by the director or a majority of the
- 2 members to perform its duties. A majority of the members of the POST commission shall constitute
 3 a quorum.
- 4 4. No member of the POST commission shall receive any compensation for the performance 5 of his official duties.
- 6 5. <u>The director shall employ staff as the director deems necessary including, but not limited</u> 7 to, no fewer than one POST investigator for each administrative hearing commissioner.
- 8 <u>6.</u> The POST commission shall guide and advise the director concerning duties pursuant to 9 this chapter.
