- 1 Section 1. (1) For purposes of this section:
- 2 (a) Ammunition means ammunition for any firearm;
- 3 (b) Department means the Department of Revenue; and
- 4 (c) Firearm has the same meaning as in section 28-1201.
- 5 (2) Any retail sale of ammunition shall be subject to a five percent
- 6 <u>excise tax. The tax shall be collected by the seller and remitted to the</u>
- 7 <u>department in a manner prescribed by the department.</u>
- 8 (3) The department may adopt and promulgate rules and regulations as
- 9 <u>necessary to carry out this section.</u>
- 10 (4) The department shall remit the proceeds of the excise tax
- imposed by this section to the State Treasurer for credit as follows:
