- 5 create a fund; to state intent; to harmonize provisions; and to
- 6 repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 81-3701, Reissue Revised Statutes of Nebraska, is

- 3 81-3701 Sections 81-3701 to 81-3724 and sections 4 and 5 of this act
- 4 shall be known and may be cited as the Nebraska Visitors Development Act.
- 5 Sec. 2. Section 81-3711, Reissue Revised Statutes of Nebraska, is
- 6 amended to read:
- 7 81-3711 The commission shall:
- 8 (1) Administer the Nebraska Visitors Development Act;
- 9 (2) Prepare and approve a budget;
- 10 (3) Elect a chairperson and vice-chairperson;
- 11 (4) Procure and evaluate data and information necessary for the
- 12 proper administration of the act;
- 13 (5) Appoint an executive director <u>at a salary to be fixed by the</u>
- 14 <u>commission</u> to conduct the day-to-day operations of the commission;
- 15 (6) Employ personnel and contract for services which are necessary
- 16 for the proper operation of the commission;
- 17 (7) Establish a means by which any interested person has the
- 18 opportunity at least annually to offer his or her ideas and suggestions
- 19 relative to the commission's duties for the upcoming year;
- 20 (8) Authorize the expenditure of funds and contracting of
- 21 expenditures to carry out the act;
- 22 (9) Keep minutes of its meetings and other books and records which
- 23 clearly reflect all of the actions and transactions of the commission and
- 24 keep such records open to examination during normal business hours; and
- 25 (10) Prohibit any funds appropriated to the commission from being
- 26 expended directly or indirectly to promote or oppose any candidate for
- 27 public office or to influence state or federal legislation.
- 28 Sec. 3. Section 81-3714, Reissue Revised Statutes of Nebraska, is
- 29 amended to read:
- 30 81-3714 The State Visitors Promotion Cash Fund is created. <u>The fund</u>
- 31 shall be administered by the commission. The fund shall consist of

- 1 revenue deposited into the fund pursuant to section 81-3715 and money
- 2 donated as gifts, beguests, or other contributions from public or private
- 3 entities. Funds made available by any department or agency of the United
- 4 States may also be credited to the fund if so directed by such department
- 5 or agency. The commission shall use the proceeds of the fund to generally
- 6 promote, encourage, and attract visitors to and within the State of
- 7 Nebraska, to and enhance the use of travel and tourism facilities within
- 8 the state, and to provide marketing assistance grants to communities and
- 9 organizations. The proceeds of the fund shall be in addition to funds
- 10 appropriated to the commission from the General Fund. Any money in the
- 11 State Visitors Promotion Cash Fund available for investment shall be
- 12 invested by the state investment officer pursuant to the Nebraska Capital
- 13 Expansion Act and the Nebraska State Funds Investment Act.
- 14 Sec. 4. (1) The commission shall develop a program to provide
- 15 marketing assistance grants to communities and organizations hosting
- 16 national or international-caliber events held in Nebraska that have the
- 17 potential to attract a significant percentage of out-of-state visitors
- 18 and to generate favorable national or international press coverage for
- 19 Nebraska.
- 20 (2) A community or organization applying for a grant shall provide a
- 21 plan to the commission that includes: (a) Documentation that the event
- 22 will attract out-of-state visitors; (b) details regarding the type of
- 23 <u>marketing that would be carried out with state funds; (c) methodologies</u>
- 24 used to track the impact of marketing efforts and the number of out-of-
- 25 state visitors attending the event; and (d) details regarding the
- 26 <u>potential national or international press coverage that will be generated</u>
- 27 by the event.
- 28 (3) The executive director shall convene a technical review
- 29 <u>committee of no fewer the three individuals representing the public</u>
- 30 sector, the private sector, and citizens at large. The technical review
- 31 committee and the executive director shall review and score applications

1 and forward recommendations to the commission for approval by the

- 2 commission or a subcommittee of the commission.
- 3 (4) Communities and organizations receiving grants authorized under
- 4 this section shall provide a final report to the commission within ninety
- 5 <u>days after the completion date of the event that includes event</u>
- 6 attendance, the use of funds, and marketing impact information.
- 7 Sec. 5. The Tourism Conference Cash Fund is created. The fund shall
- 8 be administered by the commission. All sums of money received from fees
- 9 from any conference or event held by the commission shall be deposited in
- 10 the fund. The commission shall use the fund to defray expenses related to
- 11 <u>any conference or event sponsored by the commission. Any money in the</u>
- 12 <u>fund available for investment shall be invested by the state investment</u>
- 13 officer pursuant to the Nebraska Capital Expansion Act and the Nebraska
- 14 State Funds Investment Act.
- 15 Sec. 6. It is the intent of the Legislature that any state agency
- 16 operating a grant program intended to encourage tourism and to provide
- 17 support for tourist attractions in Nebraska shall consult with the
- 18 Nebraska Tourism Commission in its grant review process.
- 19 Sec. 7. Original sections 81-3701, 81-3711, and 81-3714, Reissue
- 20 Revised Statutes of Nebraska, are repealed.
