A BILL FOR AN ACT relating to natural resources; to amend sections 1 37-440, 46-740, and 81-15,160, Reissue Revised Statutes of Nebraska, 2 and sections 37-438, 37-451, 37-455, 37-1214, 37-1802, 37-1803, 3 39-891, 39-893, 39-1301, 39-1302, 39-1309, and 39-1320, Revised 4 Statutes Cumulative Supplement, 2024; to adopt the Safe Battery 5 Collection and Recycling Act; to provide penalties; to create and 6 7 change the use of funds; to state and change provisions relating to 8 legislative intent, findings, declarations, and purposes; 9 establish the Home Weatherization Clearinghouse; to provide duties; 10 to change fees; to change provisions relating to the issuance of certain permits under the Game Law; to provide for a mitigation bank 11 or an in-lieu fee program relating to the incidental taking of 12 threatened or endangered species; to provide for payment of a sum in 13 14 lieu of ad valorem taxes lost by the county as prescribed; to change provisions relating to ground water allocation and the use of 15 integrated management plans, rules, or orders; to harmonize 16 17 provisions; and to repeal the original sections.

18 Be it enacted by the people of the State of Nebraska,

Section 1. Sections 1 to 17 of this act shall be known and may be

- 2 <u>cited as the Safe Battery Collection and Recycling Act.</u>
- 3 Sec. 2. For purposes of the Safe Battery Collection and Recycling
- 4 Act:
- 5 (1)(a) Battery containing product means a product that contains or
- 6 is packaged with a covered battery.
- 7 (b) Battery containing product does not include computers, small-
- 8 scale servers, computer monitors, electronic keyboards and mice,
- 9 printers, fax machines, scanners, televisions, digital video disc players
- 10 and recorders, video cassette recorders, digital converter boxes, cable
- 11 <u>receivers, satellite receivers, portable digital music players, and video</u>
- 12 game consoles;
- 13 (2) Battery stewardship organization means an organization
- 14 <u>designated by a producer or a group of five or more producers that</u>
- directly implements a battery stewardship plan approved by the department
- 16 under section 4 of this act;
- 17 (3)(a) Covered battery means a portable battery or a medium format
- 18 <u>battery.</u>
- 19 (b) Covered battery does not include:
- 20 <u>(i) A battery that is contained in a medical device regulated under</u>
- 21 the Federal Food, Drug, and Cosmetic Act, 21 U.S.C. 301 et seq., and that
- 22 is not designed or marketed for sale or resale at retail locations for
- 23 personal use;
- 24 (ii) A battery that contains an electrolyte as a free liquid or a
- 25 product that contains such a battery;
- 26 <u>(iii) A battery designed to power a motor vehicle, part of a motor</u>
- 27 <u>vehicle</u>, <u>or a component part of a motor vehicle assembled by</u>, <u>or for</u>, <u>a</u>
- 28 <u>vehicle manufacturer or franchised dealer, including replacement parts</u>
- 29 <u>for use in a motor vehicle;</u>
- 30 (iv) A battery in a product that is not intended or designed to be
- 31 easily removable from the product;

1 (v) A battery or battery containing product that is being recalled

- 2 <u>for safety reasons; or</u>
- 3 (vi) A battery or battery containing product offered for resale by a
- 4 business that, as part of its operations, offers products for resale to
- 5 other businesses or to consumers;
- 6 (4) Department means the Department of Environment and Energy;
- 7 (5) Medium format battery means any of the following:
- 8 (a) For batteries that are not capable of being recharged, a battery
- 9 that weighs more than four and four-tenths pounds but not more than
- 10 twenty-five pounds; or
- 11 (b) For rechargeable batteries, a battery that weighs more than
- 12 <u>eleven pounds or that has a rating of more than three hundred watt-hours,</u>
- 13 or both, but that does not weigh more than twenty-five pounds or have a
- 14 rating of more than two thousand watt-hours;
- 15 (6) Portable battery means any of the following:
- 16 (a) For batteries that are not capable of being recharged, a battery
- 17 that weighs no more than four and four-tenths pounds; or
- 18 <u>(b) For rechargeable batteries, a battery that weighs no more than</u>
- 19 <u>eleven pounds and that has a rating of no more than three hundred watt-</u>
- 20 hours;
- 21 (7)(a) Producer means a person that sells, offers for sale, or
- 22 distributes for sale a covered battery or battery containing product in
- 23 <u>or into this state and that is any of the following:</u>
- 24 (i) If the covered battery or battery containing product is sold
- 25 under a brand of the battery's or product's manufacturer, the person that
- 26 manufactures the battery or product;
- 27 <u>(ii) If the covered battery or battery containing product is sold</u>
- 28 under a retail brand or under a brand owned by a person other than the
- 29 <u>battery's or product's manufacturer, the person that owns the brand;</u>
- 30 (iii) If subdivisions (7)(a)(i) and (ii) of this section do not
- 31 apply, the person that is the licensee of a brand or trademark under

1 which the covered battery or battery containing product is sold, offered

- 2 for sale, or distributed for sale in or into this state, regardless of
- 3 whether the trademark is registered in this state;
- 4 (iv) If subdivisions (7)(a)(i) through (iii) of this section do not
- 5 apply to any person within the United States, the person that is the
- 6 importer of record for the covered battery or battery containing product
- 7 into the United States for the purpose of selling, offering for sale, or
- 8 <u>distributing for sale the battery or product in or into this state; or</u>
- 9 (v) If subdivisions (7)(a)(i) through (iv) of this section do not
- 10 apply to any person with a commercial presence in this state, the person
- 11 who first sells, offers for sale, or distributes for sale the covered
- 12 <u>battery or battery containing product in or into this state.</u>
- 13 <u>(b) Producer does not include a person that only sells, offers for</u>
- 14 <u>sale</u>, or distributes for sale a battery containing product if the battery
- is supplied by another producer that has designated a battery stewardship
- 16 organization to implement a battery stewardship plan and if the producer
- 17 certifies this fact in writing to the person that only sells, offers for
- 18 sale, or distributes for sale the battery containing product;
- 19 (8) Rechargeable battery means a battery that contains one or more
- 20 <u>voltaic or galvanic cells electrically connected to produce electric</u>
- 21 <u>energy and that is designed to be recharged;</u>
- 22 (9)(a) Recycling means preparing batteries for use in manufacturing
- 23 processes or for recovery of usable materials and delivering the
- 24 materials for use.
- 25 (b) Recycling does not include:
- (i) Destruction by incineration or other processes;
- 27 (ii) Land disposal of recyclable materials; and
- 28 (iii) Reuse, repair, or any other process through which batteries
- 29 are returned in their original form;
- 30 (10) Recycling efficiency rate means the percentage calculated by
- 31 dividing the weight of components and materials recycled by a battery

- 2 <u>the battery stewardship organization; and</u>
- 3 (11) Retailer means a person that sells or offers for sale a covered
- 4 battery in or into this state.
- 5 Sec. 3. (1) Beginning January 1, 2028, no producer or retailer may
- 6 sell, offer for sale, or distribute for sale in or into this state any
- 7 covered battery or battery containing product unless the producer of the
- 8 <u>covered battery or battery containing product is a member of a battery</u>
- 9 stewardship organization operating under a battery stewardship plan
- 10 approved by the department under section 4 of this act. This subsection
- 11 <u>does not apply to a retailer if the website maintained by the department</u>
- 12 <u>under section 9 of this act lists, as of the date a battery or product is</u>
- 13 made available for retail sale, the producer or brand of the battery or
- 14 product as being covered by a battery stewardship plan approved by the
- 15 <u>department under section 4 of this act.</u>
- 16 (2) Beginning January 1, 2028, no producer or retailer may sell,
- 17 offer for sale, or distribute for sale in or into this state any covered
- 18 battery or battery containing product unless the covered battery or
- 19 battery in the battery containing product is marked with an
- 20 identification of the producer of the battery. This subsection does not
- 21 apply if the battery is less than one-half inch in diameter or does not
- 22 contain a surface with a length that exceeds one-half inch.
- 23 (3) Beginning January 1, 2029, no producer or retailer may sell,
- 24 <u>offer for sale, or distribute for sale in or into this state any</u> covered
- 25 battery or battery containing product unless the covered battery or
- 26 <u>battery in the battery containing product is marked to ensure proper</u>
- 27 collection and recycling by:
- 28 (a) Identifying the chemistry of the battery; and
- 29 (b) Including an indication that the battery should not be disposed
- 30 of as household waste. This subdivision does not apply if the battery is
- 31 less than one-half inch in diameter or does not contain a surface with a

- 1 length that exceeds one-half inch.
- 2 (4) A producer, retailer, or battery stewardship organization may
- 3 not charge a point-of-sale fee to consumers to cover the costs of
- 4 implementing a battery stewardship plan approved by the department under
- 5 section 4 of this act.
- 6 **Sec. 4.** (1) Each battery stewardship organization shall submit a
- 7 battery stewardship plan to the department for review and approval by
- 8 <u>January 1, 2027.</u>
- 9 (2) A battery stewardship plan shall have a term of no more than
- 10 five years and shall include all of the following:
- 11 (a) The names and contact information for each producer member
- 12 <u>covered under a battery stewardship organization's plan;</u>
- 13 <u>(b) The brands of all of the covered batteries that the battery</u>
- 14 stewardship organization's producer members sell, offer for sale, or
- 15 <u>distribute for sale in or into this state</u>. All such brands shall be
- 16 covered by the battery stewardship plan;
- 17 <u>(c) Performance goals under the plan and a process for achieving</u>
- 18 these goals. Performance goals shall include target recycling efficiency
- 19 rates of at least sixty percent for rechargeable batteries and seventy
- 20 percent for batteries that are not capable of being recharged and goals
- 21 for public awareness, convenience, and accessibility;
- 22 (d) A process for making retailers aware of the prohibitions
- 23 contained in section 3 of this act;
- 24 (e) Consumer awareness goals and a description of the education and
- 25 outreach strategy that the battery stewardship organization will
- 26 implement pursuant to section 7 of this act;
- 27 <u>(f) A process for making available to collection sites, for</u>
- 28 voluntary use, signage, written materials, and other promotional
- 29 materials to inform consumers of the available end-of-life management
- 30 options for covered batteries collected under the battery stewardship
- 31 plan;

- 2 <u>battery collection activities at collection sites, including a</u>
- 3 <u>description of operating protocols to reduce risks of spills or fires,</u>
- 4 response protocols in the event of a spill or fire, and protocols for
- 5 safe management of damaged batteries that are returned to collection
- 6 sites;
- 7 <u>(h) A method for fully funding the battery stewardship</u>
- 8 <u>organization's plan in a manner that equitably distributes the plan's</u>
- 9 costs among the members of the battery stewardship organization;
- 10 (i) Provisions for collecting covered batteries at no cost,
- 11 regardless of the brand or producer of the covered battery, on a
- 12 <u>continuous, convenient, visible, and accessible basis and a description</u>
- 13 of how the battery stewardship organization will comply with section 6 of
- 14 this act;
- 15 (j) The addresses of collection sites that will accept covered
- 16 batteries under the plan and the criteria used to determine whether an
- 17 entity may serve as a collection site;
- 18 (k) The names of proposed service providers, including sorters,
- 19 transporters, and processors, to be used for the final disposition of
- 20 <u>batteries;</u>
- 21 (1) Provisions for recordkeeping, tracking, and documenting the
- 22 management and disposition of collected covered batteries; and
- 23 (m) An explanation for any delay anticipated by the battery
- 24 stewardship organization in managing medium format batteries.
- 25 (3) A battery stewardship organization whose battery stewardship
- 26 plan is approved under this section shall submit a new plan to the
- 27 department for approval no less than once every five years. If the
- 28 performance goals under the previously approved plan have not been met,
- 29 the new plan shall include corrective measures to be implemented by the
- 30 battery stewardship organization to meet those performance goals, which
- 31 may include improvements to the collection site network or increased

- 1 expenditures dedicated to education and outreach.
- 2 (4) A battery stewardship organization whose battery stewardship
- 3 plan is approved under this section shall provide plan amendments to the
- 4 department for approval when proposing any material changes to an
- 5 approved plan.
- 6 (5)(a) Within one hundred twenty days after receiving a proposed
- 7 battery stewardship plan or a proposed amendment described in subsection
- 8 (4) of this section, the department shall approve, conditionally approve,
- 9 <u>or deny the plan or amendment.</u>
- 10 (b) If the department denies the plan or amendment:
- 11 (i) The department shall notify the battery stewardship organization
- 12 <u>of the denial in writing and explain how the proposed plan or amendment</u>
- 13 <u>does not comply with the Safe Battery Collection and Recycling Act;</u>
- 14 (ii) The battery stewardship organization shall submit a revised
- 15 plan or amendment or notice of plan or amendment withdrawal within sixty
- 16 days after the denial; and
- 17 <u>(iii) The department shall approve or deny the revised plan or</u>
- 18 amendment within ninety days after resubmittal. The denial of a revised
- 19 plan or amendment may be appealed, and the appeal shall be in accordance
- 20 <u>with the Administrative Procedure Act.</u>
- 21 <u>(6) A battery stewardship organization operating under a plan</u>
- 22 approved by the department under this section shall notify the department
- 23 within ninety days of a producer beginning or ceasing participation in
- 24 the battery stewardship organization, or within ninety days of adding or
- 25 removing a processor or transporter under the approved plan.
- 26 <u>(7) A battery stewardship organization shall pay a fee to the</u>
- 27 department upon approval of a plan under this section or on January 1,
- 28 2027, whichever is later, and on an annual basis thereafter. The amount
- 29 of the fee shall be set by the department and shall be sufficient to
- 30 cover all costs incurred by the department to administer and enforce the
- 31 Safe Battery Collection and Recycling Act for fiscal year 2027-28 and

1 each fiscal year thereafter. Through June 30, 2027, the department shall

- 2 <u>use the Waste Reduction and Recycling Incentive Fund to pay all costs</u>
- 3 incurred by the department to implement, administer, and enforce the act.
- 4 Fees paid under this subsection shall be remitted to the State Treasurer
- 5 <u>for credit to the Battery Stewardship Cash Fund.</u>
- 6 **Sec. 5.** A battery stewardship organization implementing a battery
- 7 stewardship plan approved under section 4 of this act shall:
- 8 (1) Be responsible for all costs associated with implementing the
- 9 plan;
- 10 (2) Reimburse local governmental units for demonstrable costs
- 11 <u>incurred as a result of a local government facility or solid waste</u>
- 12 <u>facility serving as a collection site under the plan; and</u>
- 13 (3) Collect charges from participating producers sufficient to cover
- 14 the costs of implementation, including battery collection,
- 15 transportation, and processing, education and outreach, program
- 16 evaluation, and payment of the annual fee to the department under section
- 17 4 of this act.
- 18 **Sec. 6.** (1) A battery stewardship organization implementing a
- 19 <u>battery stewardship plan approved under section 4 of this act shall do</u>
- 20 <u>all of the following:</u>
- 21 (a) Provide for the collection of all covered batteries from any
- 22 person, regardless of the chemistry or brand of the battery, on a free,
- 23 continuous, convenient, visible, and accessible basis;
- 24 (b) Provide to collection sites under the plan, at no cost to the
- 25 sites, suitable collection containers for covered batteries that are
- 26 <u>segregated from other solid waste, or make alternative arrangements for</u>
- 27 <u>the collection of such batteries at the site, with the agreement of the</u>
- 28 collection site;
- 29 <u>(c) Ensure that medium format batteries are collected only at</u>
- 30 household hazardous waste collection sites or other staffed collection
- 31 <u>sites that meet applicable federal, state, and local requirements for</u>

- 1 managing medium format batteries;
- 2 (d) Provide for the collection of damaged and defective batteries,
- 3 by persons trained to handle and ship such batteries, at collection sites
- 4 and at each permanent household hazardous waste facility and each
- 5 household hazardous waste collection event provided by the department. As
- 6 used in this subdivision, damaged and defective batteries means batteries
- 7 that have been damaged or that have been identified by the manufacturer
- 8 as being defective for safety reasons and that have the potential to
- 9 produce a dangerous evolution of heat or fire or short circuit;
- 10 (e) Ensure statewide collection opportunities for all covered
- 11 batteries;
- 12 (f) Coordinate activities with others, such as electronic waste
- 13 recyclers and other battery stewardship organizations, to provide
- 14 <u>efficient delivery of services and avoid unnecessary duplication of</u>
- 15 effort and expense. A battery stewardship organization shall use existing
- 16 public and private waste collection services and facilities,
- 17 transporters, consolidators, processors, and retailers if cost effective,
- 18 mutually agreeable, and otherwise practical;
- 19 (g) For portable batteries, provide all of the following within
- 20 three years after approval of the battery stewardship plan:
- 21 (i) At least one permanent collection site within a fifteen-mile
- 22 radius for at least ninety-five percent of state residents; and
- 23 (ii) At least one permanent collection site, collection service, or
- 24 <u>collection event for every thirty thousand residents of a county;</u>
- 25 (h) For medium format batteries, provide all of the following within
- 26 <u>three years after approval of the battery stewardship plan:</u>
- 27 <u>(i) At least ten permanent collection sites in this state. Such</u>
- 28 sites shall be reasonably dispersed throughout the state; and
- 29 <u>(ii) A collection event at least once every three years in each</u>
- 30 county that does not have a permanent collection site, which shall
- 31 provide for the collection of all medium format batteries, including

- 1 damaged and defective medium format batteries; and
- 2 <u>(i) Use as a collection site or the site of a collection event any</u>
- 3 entity that meets the criteria for a collection site or collection event
- 4 under an approved battery stewardship plan and that requests to serve as
- 5 <u>a collection site or collection event, up to the number of collection</u>
- 6 sites required to comply with subdivisions (1)(g) and (h) of this
- 7 section.
- 8 (2) A battery stewardship organization implementing a battery
- 9 stewardship plan approved under section 4 of this act may issue a warning
- 10 to, suspend, or terminate a collection site or service that does not
- 11 <u>comply with the criteria contained in the approved plan or that poses an</u>
- 12 <u>immediate concern to health and safety.</u>
- 13 (3) A battery stewardship organization is not required to provide
- 14 for the collection of battery containing products, covered batteries that
- 15 remain contained in a battery containing product at the time of delivery
- 16 to a collection site or collection event, or batteries or battery
- 17 <u>containing products being recalled for safety reasons. A battery</u>
- 18 stewardship organization may seek reimbursement from the producer of a
- 19 <u>battery or battery containing product being recalled for safety reasons</u>
- 20 for the costs incurred in collecting, transporting, or processing such
- 21 <u>batteries and products.</u>
- 22 **Sec. 7.** A battery stewardship organization implementing a battery
- 23 <u>stewardship plan approved under section 4 of this act shall do all of the</u>
- 24 <u>following to promote the implementation of the plan:</u>
- 25 (1) Develop and maintain a website;
- 26 (2) Develop and place advertisements on social media or other
- 27 relevant media platforms;
- 28 (3) Develop promotional materials about the program and about the
- 29 <u>restrictions on disposing of covered batteries under section 12 of this</u>
- 30 <u>act;</u>
- 31 (4) Develop and distribute collection site safety training

1 procedures to collection sites to help ensure proper management of

- 2 <u>covered batteries at collection sites;</u>
- 3 (5) Provide consumer-focused educational materials, to each
- 4 collection site used under the plan, that are accessible by customers of
- 5 retailers that sell covered batteries or battery containing products;
- 6 (6) Provide safety information related to covered battery collection
- 7 activities to the operator of each collection site used under the plan,
- 8 including appropriate protocols to reduce risks of spills or fires, to
- 9 respond to a spill or fire, and to manage a collected damaged or
- 10 defective battery;
- 11 (7) Provide educational materials to the operator of each collection
- 12 <u>site used under the plan for the management of recalled batteries;</u>
- 13 (8) Upon request by a retailer or other potential collection site,
- 14 provide educational materials describing collection opportunities for
- 15 covered batteries;
- 16 (9) Coordinate with other battery stewardship organizations
- 17 implementing a battery stewardship plan in providing education and
- 18 outreach under this section; and
- 19 <u>(10) Conduct a survey, during the first year of implementing a</u>
- 20 battery stewardship plan and once every five years thereafter, of public
- 21 awareness of the outreach efforts undertaken pursuant to this section.
- 22 The battery stewardship organization shall share the results of the
- 23 surveys with the department.
- 24 Sec. 8. (1) No later than June 1, 2029, and no later than June 1 of
- 25 each year thereafter, a battery stewardship organization implementing a
- 26 <u>battery stewardship plan approved under section 4 of this act shall</u>
- 27 submit to the department a report that includes:
- 28 (a) A summary financial statement documenting the financing of the
- 29 plan and an analysis of plan costs and expenditures, including an
- 30 <u>analysis</u> of the plan's expenses, such as collection, transportation,
- 31 recycling, education, and administrative overhead. The summary financial

1 statement shall be sufficiently detailed to provide transparency that

- 2 <u>funds collected from producers are spent on plan implementation in this</u>
- 3 state;
- 4 (b) The weight, by chemistry, of covered batteries collected under
- 5 the plan;
- 6 (c) The weight of materials recycled from covered batteries
- 7 collected under the plan, in total, and by method of battery recycling;
- 8 (d) A calculation of the recycling efficiency rate under the plan;
- 9 (e) A list of all facilities used in the processing or disposition
- 10 of covered batteries under the plan and a summary of any violations of
- 11 <u>environmental laws and regulations during the previous three years at</u>
- 12 <u>each facility;</u>
- 13 <u>(f) For each facility used for the final disposition of covered</u>
- 14 batteries under the plan, a description of how the facility recycled or
- otherwise managed batteries and battery components;
- 16 (g) The weight and chemistry of covered batteries sent to each
- 17 facility that is used for the final disposition of batteries. This
- 18 <u>information may be approximated based on extrapolations of national or</u>
- 19 regional data for programs in operation in multiple states;
- 20 <u>(h) The estimated aggregate sales, by weight and chemistry, of</u>
- 21 covered batteries, including covered batteries contained in or packaged
- 22 with battery containing products, sold in this state by the battery
- 23 stewardship organization's participating producers for each of the
- 24 <u>previous three calendar years;</u>
- 25 (i) A description of how collected batteries were managed and
- 26 <u>recycled, including a discussion of best available technologies and the</u>
- 27 <u>recycling efficiency rate;</u>
- 28 (j) A description of education and outreach efforts supporting plan
- 29 <u>implementation</u>, including:
- 30 (i) A summary of education and outreach provided to consumers,
- 31 <u>collection sites, manufacturers, distributors, and retailers to promote</u>

- 1 the collection and recycling of covered batteries;
- 2 (ii) A description of how that education and outreach met the
- 3 requirements of section 7 of this act;
- 4 (iii) Samples of education and outreach materials;
- 5 (iv) A summary of coordinated education and outreach efforts with
- 6 <u>any other battery stewardship organizations implementing a battery</u>
- 7 stewardship plan; and
- 8 (v) A summary of any changes made during the previous calendar year
- 9 to education and outreach activities;
- 10 (k) A list of all collection sites used to implement the plan, an
- 11 <u>address for each listed site, a link to the website of each listed site,</u>
- 12 <u>if available, and an up-to-date map indicating the location of each site;</u>
- 13 (1) A description of methods used to collect, transport, and recycle
- 14 covered batteries under the plan;
- 15 (m) A summary of progress made toward the performance goals under
- 16 the plan, and an explanation of why performance goals were not met, if
- 17 applicable;
- 18 <u>(n) An evaluation of the effectiveness of education and outreach</u>
- 19 <u>activities; and</u>
- 20 (o) If a battery stewardship organization has disposed of covered
- 21 batteries through energy recovery, incineration, or landfilling during
- 22 the preceding calendar year of plan implementation, the steps that the
- 23 battery stewardship organization will take to make the recycling of
- 24 covered batteries cost-effective, when possible, or to otherwise increase
- 25 battery recycling efficiency rates achieved by the battery stewardship
- 26 <u>organization</u>.
- 27 (2) After five years of implementation of an approved battery
- 28 stewardship plan, a battery stewardship organization or a producer member
- 29 of such organization shall hire an independent third party to conduct a
- 30 one-time audit of the battery stewardship plan and plan operation. The
- 31 auditor shall examine the effectiveness of the battery stewardship plan

1 in collecting and recycling covered batteries. The auditor shall also

- 2 <u>examine the cost-effectiveness of the plan and compare it to the cost-</u>
- 3 effectiveness of collections plans and programs for covered batteries in

- 31 disbursements not to exceed twenty-five percent of the product's retail

- The director shall give preference to projects which utilize scrap
- 26 tires generated and used in Nebraska.
- 27 (4) Priority for grants made under section 81-15,161 shall be given
- 28 to grant proposals demonstrating a formal public/private partnership
- 29 except for grants awarded from fees collected under subsection (6) of
- 30 section 13-2042.
- 31 (5) Grants awarded from fees collected under subsection (6) of

- 1 section 13-2042 may be renewed for up to a five-year grant period. Such
- 2 applications shall include an updated integrated solid waste management
- 3 plan pursuant to section 13-2032. Annual disbursements are subject to
- 4 available funds and the grantee meeting established grant conditions.
