DISABILITY SERVICES DIVISION)

SUMMARY—Makes various changes relating to the regulation of certain nonmedical and medical services provided to persons with disabilities. (BDR 40-309)

AN ACT relating to public welfare; transferring the powers and duties concerning the certification and regulation of intermediary service organizations from the Aging and Disability Services Division of the Department of Health and Human Services to the Health Division of the Department; transferring the regulatory authority relating to intermediary service organizations from the Aging and Disability Services Division to the State Board of Health; authorizing the provision of certain medical services to persons with disabilities by an agency to provide personal care services in the home under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires the Aging and Disability Services Division of the
2 Department of Health and Human Services to carry out and administer the
3 certification of intermediary service organizations. (NRS 427A.0291,
4 427A.701-427A.745) Existing law further requires the Division to adopt
5 regulations governing the: (1) certification of intermediary service organizations;
6 (2) imposition of administrative sanctions for violations related to such
7 certification; and (3) procedures for appealing the imposition of disciplinary action
8 or administrative sanctions. (NRS 427A.727, 427A.731, 427A.733) **Section 36** of
9 this bill repeals the provisions governing the certification and regulation of



10 intermediary service organizations by the Division. **Sections 2-25** of this bill
11 transfer the powers and duties concerning carrying out and administering the
12 certification of intermediary service organizations from the Aging and Disability
13 Services Division of the Department of Health and Human Services to the Health
14 Division of the Department. **Sections 16, 18 and 19** also transfer the duty to adopt
15 regulations governing intermediary service organizations from the Aging and
16 Disability Services Division to the State Board of Health. **Section 4** excludes a
17 person who is licensed to operate an agency to provide personal care services in the
18 home from the requirement of obtaining a certificate to operate an intermediary
19 service organization.

20 Existing law provides that certain providers of health care may, under certain
21 circumstances, authorize a person to act as a personal assistant to perform specific
22 medical, nursing or home health services for a person with a disability without
23 obtaining a license to perform the service. (NRS 629.091) **Section 26** of this bill
24 authorizes an agency to provide personal care services in the home to provide those
25 medical services authorized pursuant to existing law to persons with disabilities
26 through its employees or by contractual arrangement with other persons.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 449 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 to 26, inclusive, of this
3 act.

4 **Sec. 2.** *As used in sections 2 to 25, inclusive, of this act,*
5 *unless the context otherwise requires, “intermediary service*
6 *organization” means a nongovernmental entity that provides*
7 *services authorized pursuant to section 3 of this act for a person*
8 *with a disability or other responsible person.*

9 **Sec. 3. 1.** *An intermediary service organization that is*
10 *certified pursuant to sections 2 to 25, inclusive, of this act may*
11 *provide services for a person with a disability or other responsible*
12 *person relating to personal assistance received by the person with*
13 *a disability. The services that may be provided by an intermediary*
14 *service organization include, without limitation:*

15 *(a) Obtaining a criminal background check of a personal*
16 *assistant selected by the person with a disability or other*
17 *responsible person to provide nonmedical services and any*
18 *medical services authorized pursuant to NRS 629.091;*

19 *(b) Providing payroll services to pay the personal assistant and*
20 *determine any tax liability;*

21 *(c) Providing services relating to financial management; and*

22 *(d) Providing any other services relating to the employment of*
23 *a personal assistant and any other financial assistance relating to*
24 *the personal assistance for the person with a disability.*

25 **2.** *As used in this section:*

26 *(a) “Other responsible person” means:*



1 (1) *A parent or guardian of, or any other person legally*
2 *responsible for, a person with a disability who is under the age of*
3 *18 years; or*

4 (2) *A parent, spouse, guardian or adult child of a person*
5 *with a disability who suffers from a cognitive impairment.*

6 (b) *“Personal assistance” means the provision of any goods or*
7 *services to help a person with a disability maintain his or her*
8 *independence, personal hygiene and safety, including, without*
9 *limitation, the provision of services by a personal assistant.*

10 (c) *“Personal assistant” means a person who, for*
11 *compensation and under the direction of a person with a disability*
12 *or other responsible person, performs services for a person with a*
13 *disability to help the person maintain his or her independence,*
14 *personal hygiene and safety.*

15 **Sec. 4.** *1. Except as otherwise provided in subsection 2, a*
16 *person shall not operate or maintain in this State an intermediary*
17 *service organization without first obtaining a certificate to operate*
18 *an intermediary service organization as provided in sections 2 to*
19 *25, inclusive, of this act.*

20 *2. A person who is licensed to operate an agency to provide*
21 *personal care services in the home pursuant to this chapter is not*
22 *required to obtain a certificate to operate an intermediary service*
23 *organization as described in this section.*

24 *3. A person who violates the provisions of this section is*
25 *guilty of a misdemeanor.*

26 **Sec. 5.** *Any person wishing to obtain a certificate to operate*
27 *an intermediary service organization pursuant to the provisions of*
28 *sections 2 to 25, inclusive, of this act must file with the Health*
29 *Division an application on a form prescribed, prepared and*
30 *furnished by the Health Division, containing:*

31 *1. The name of the applicant and, if a natural person,*
32 *whether the applicant has attained the age of 21 years.*

33 *2. The location of the intermediary service organization.*

34 *3. The name of the person in charge of the intermediary*
35 *service organization.*

36 *4. Such other information as may be required by the Health*
37 *Division for the proper administration and enforcement of*
38 *sections 2 to 25, inclusive, of this act.*

39 *5. Evidence satisfactory to the Health Division that the*
40 *applicant is of reputable and responsible character. If the*
41 *applicant is a firm, association, organization, partnership,*
42 *business trust, corporation or company, similar evidence must be*
43 *submitted as to the members thereof, and the person in charge of*
44 *the intermediary service organization for which application is*
45 *made.*



1 6. *Evidence satisfactory to the Health Division of the ability*
2 *of the applicant to comply with the provisions of sections 2 to 25,*
3 *inclusive, of this act and the standards and regulations adopted by*
4 *the Board.*

5 **Sec. 6.** *An application for the issuance of a certificate to*
6 *operate an intermediary service organization pursuant to section 5*
7 *of this act must include the social security number of the*
8 *applicant.*

9 **Sec. 7.** *1. An applicant for the issuance or renewal of a*
10 *certificate to operate an intermediary service organization must*
11 *submit to the Health Division the statement prescribed by the*
12 *Division of Welfare and Supportive Services of the Department*
13 *pursuant to NRS 425.520. The statement must be completed and*
14 *signed by the applicant.*

15 *2. The Health Division shall include the statement required*
16 *pursuant to subsection 1 in:*

17 *(a) The application or any other forms that must be submitted*
18 *for the issuance or renewal of the certificate; or*

19 *(b) A separate form prescribed by the Health Division.*

20 *3. A certificate as an intermediary service organization may*
21 *not be issued or renewed by the Health Division if the applicant:*

22 *(a) Fails to submit the statement required pursuant to*
23 *subsection 1; or*

24 *(b) Indicates on the statement submitted pursuant to*
25 *subsection 1 that the applicant is subject to a court order for the*
26 *support of a child and is not in compliance with the order or a*
27 *plan approved by the district attorney or other public agency*
28 *enforcing the order for the repayment of the amount owed*
29 *pursuant to the order.*

30 *4. If an applicant indicates on the statement submitted*
31 *pursuant to subsection 1 that the applicant is subject to a court*
32 *order for the support of a child and is not in compliance with the*
33 *order or a plan approved by the district attorney or other public*
34 *agency enforcing the order for the repayment of the amount owed*
35 *pursuant to the order, the Health Division shall advise the*
36 *applicant to contact the district attorney or other public agency*
37 *enforcing the order to determine the actions that the applicant*
38 *may take to satisfy the arrearage.*

39 **Sec. 8.** *Each application for a certificate to operate an*
40 *intermediary service organization must be accompanied by such*
41 *fee as may be determined by regulation of the Board. The Board*
42 *may, by regulation, allow or require payment of a fee for a*
43 *certificate in installments and may fix the amount of each*
44 *payment and the date on which the payment is due.*



1 **Sec. 9. 1.** *The Health Division shall issue the certificate to*
2 *operate an intermediary service organization to the applicant if,*
3 *after investigation, the Health Division finds that the:*

4 *(a) Applicant is in full compliance with the provisions of*
5 *sections 2 to 25, inclusive, of this act; and*

6 *(b) Applicant is in substantial compliance with the standards*
7 *and regulations adopted by the Board.*

8 **2.** *A certificate applies only to the person to whom it is issued*
9 *and is not transferable.*

10 **Sec. 10.** *Each certificate to operate an intermediary service*
11 *organization issued by the Health Division pursuant to sections 2*
12 *to 25, inclusive, of this act must be in the form prescribed by the*
13 *Health Division and must contain:*

14 **1.** *The name of the person or persons authorized to operate*
15 *the intermediary service organization;*

16 **2.** *The location of the intermediary service organization; and*

17 **3.** *The services offered by the intermediary service*
18 *organization.*

19 **Sec. 11. 1.** *Each certificate to operate an intermediary*
20 *service organization issued pursuant to sections 2 to 25, inclusive,*
21 *of this act expires on December 31 following its issuance and is*
22 *renewable for 1 year upon reapplication and payment of all fees*
23 *required pursuant to section 8 of this act unless the Health*
24 *Division finds, after an investigation, that the intermediary service*
25 *organization has not satisfactorily complied with the provisions of*
26 *sections 2 to 25, inclusive, of this act or the standards and*
27 *regulations adopted by the Board.*

28 **2.** *Each reapplication for an intermediary service*
29 *organization must include, without limitation, a statement that the*
30 *organization is in compliance with the provisions of sections 20*
31 *to 23, inclusive, of this act.*

32 **Sec. 12.** *The Health Division may deny an application for a*
33 *certificate to operate an intermediary service organization or may*
34 *suspend or revoke any certificate issued under the provisions of*
35 *sections 2 to 25, inclusive, of this act upon any of the following*
36 *grounds:*

37 **1.** *Violation by the applicant or the holder of a certificate of*
38 *any of the provisions of sections 2 to 25, inclusive, of this act or of*
39 *any other law of this State or of the standards, rules and*
40 *regulations adopted thereunder.*

41 **2.** *Aiding, abetting or permitting the commission of any*
42 *illegal act.*

43 **3.** *Conduct inimical to the public health, morals, welfare and*
44 *safety of the people of the State of Nevada in the operation of an*
45 *intermediary service organization.*



1 4. *Conduct or practice detrimental to the health or safety of a*
2 *person under contract with or employees of the intermediary*
3 *service organization.*

4 **Sec. 13.** *1. If the Health Division receives a copy of a court*
5 *order issued pursuant to NRS 425.540 that provides for the*
6 *suspension of all professional, occupational and recreational*
7 *licenses, certificates and permits issued to a person who is the*
8 *holder of a certificate to operate an intermediary service*
9 *organization, the Health Division shall deem the certificate issued*
10 *to that person to be suspended at the end of the 30th day after the*
11 *date on which the court order was issued unless the Health*
12 *Division receives a letter issued to the holder of the certificate by*
13 *the district attorney or other public agency pursuant to NRS*
14 *425.550 stating that the holder of the certificate has complied with*
15 *the subpoena or warrant or has satisfied the arrearage pursuant to*
16 *NRS 425.560.*

17 *2. The Health Division shall reinstate a certificate to operate*
18 *an intermediary service organization that has been suspended by a*
19 *district court pursuant to NRS 425.540 if the Health Division*
20 *receives a letter issued by the district attorney or other public*
21 *agency pursuant to NRS 425.550 to the person whose certificate*
22 *was suspended stating that the person whose certificate was*
23 *suspended has complied with the subpoena or warrant or has*
24 *satisfied the arrearage pursuant to NRS 425.560.*

25 **Sec. 14.** *1. The Health Division may cancel a certificate to*
26 *operate an intermediary service organization and issue a*
27 *provisional certificate, effective for a period determined by the*
28 *Health Division, to the intermediary service organization if the*
29 *intermediary service organization:*

30 *(a) Is in operation at the time of the adoption of standards and*
31 *regulations pursuant to the provisions of sections 2 to 25,*
32 *inclusive, of this act and the Health Division determines that the*
33 *intermediary service organization requires a reasonable time*
34 *under the particular circumstances within which to comply with*
35 *the standards and regulations; or*

36 *(b) Has failed to comply with the standards or regulations and*
37 *the Health Division determines that the intermediary service*
38 *organization is in the process of making the necessary changes or*
39 *has agreed to make the changes within a reasonable time.*

40 *2. The provisions of subsection 1 do not require the issuance*
41 *of a certificate or prevent the Health Division from refusing to*
42 *renew or from revoking or suspending any certificate if the Health*
43 *Division deems such action necessary for the health and safety of*
44 *a person for whom the intermediary service organization provides*
45 *services.*



1 **Sec. 15. 1. Money received from the certification of**
2 **intermediary service organizations:**

3 **(a) Must be forwarded to the State Treasurer for deposit in the**
4 **State Treasury;**

5 **(b) Must be accounted for separately in the State General**
6 **Fund; and**

7 **(c) May only be used to carry out the provisions of sections 2**
8 **to 25, inclusive, of this act.**

9 **2. The Health Division shall enforce the provisions of**
10 **sections 2 to 25, inclusive, of this act and may incur any necessary**
11 **expenses not in excess of money appropriated for that purpose by**
12 **the State or received from the Federal Government.**

13 **Sec. 16. 1. The Board shall adopt regulations governing**
14 **the certification of intermediary service organizations and such**
15 **other regulations as it deems necessary to carry out the provisions**
16 **of sections 2 to 25, inclusive, of this act.**

17 **2. The Health Division may:**

18 **(a) Upon receipt of an application for a certificate to operate**
19 **an intermediary service organization, conduct an investigation**
20 **into the qualifications of personnel, methods of operation and**
21 **policies and purposes of any person proposing to engage in the**
22 **operation of an intermediary service organization.**

23 **(b) Upon receipt of a complaint against an intermediary**
24 **service organization, except for a complaint concerning the cost of**
25 **services, conduct an investigation into the qualifications of**
26 **personnel, methods of operation and policies, procedures and**
27 **records of that intermediary service organization or any other**
28 **intermediary service organization which may have information**
29 **pertinent to the complaint.**

30 **(c) Employ such professional, technical and clerical assistance**
31 **as it deems necessary to carry out the provisions of sections 2 to**
32 **25, inclusive, of this act.**

33 **Sec. 17. 1. If an intermediary service organization violates**
34 **any provision related to its certification, including, without**
35 **limitation, any provision of sections 2 to 25, inclusive, of this act**
36 **or any condition, standard or regulation adopted by the Board, the**
37 **Health Division, in accordance with the regulations adopted**
38 **pursuant to section 18 of this act, may, as it deems appropriate:**

39 **(a) Prohibit the intermediary service organization from**
40 **providing services pursuant to section 3 of this act until it**
41 **determines that the intermediary service organization has**
42 **corrected the violation;**

43 **(b) Impose an administrative penalty of not more than \$1,000**
44 **per day for each violation, together with interest thereon at a rate**
45 **not to exceed 10 percent per annum; and**



1 (c) *Appoint temporary management to oversee the operation of*
2 *the intermediary service organization and to ensure the health and*
3 *safety of the persons for whom the intermediary service*
4 *organization performs services, until:*

5 (1) *It determines that the intermediary service organization*
6 *has corrected the violation and has management which is capable*
7 *of ensuring continued compliance with the applicable statutes,*
8 *conditions, standards and regulations; or*

9 (2) *Improvements are made to correct the violation.*

10 2. *If the intermediary service organization fails to pay any*
11 *administrative penalty imposed pursuant to paragraph (b) of*
12 *subsection 1, the Health Division may:*

13 (a) *Suspend the certificate to operate an intermediary service*
14 *organization which is held by the intermediary service*
15 *organization until the administrative penalty is paid; and*

16 (b) *Collect court costs, reasonable attorney's fees and other*
17 *costs incurred to collect the administrative penalty.*

18 3. *The Health Division may require any intermediary service*
19 *organization that violates any provision of sections 2 to 25,*
20 *inclusive, of this act or any condition, standard or regulation*
21 *adopted by the Board, to make any improvements necessary to*
22 *correct the violation.*

23 4. *Any money collected as administrative penalties pursuant*
24 *to this section must be accounted for separately and used to*
25 *protect the health or property of the persons for whom the*
26 *intermediary service organization performs services in accordance*
27 *with applicable federal standards.*

28 **Sec. 18.** *The Board shall adopt regulations establishing the*
29 *criteria for the imposition of each sanction prescribed by section*
30 *17 of this act. These regulations must:*

31 1. *Prescribe the circumstances and manner in which each*
32 *sanction applies;*

33 2. *Minimize the time between identification of a violation and*
34 *the imposition of a sanction;*

35 3. *Provide for the imposition of incrementally more severe*
36 *sanctions for repeated or uncorrected violations; and*

37 4. *Provide for less severe sanctions for lesser violations of*
38 *applicable state statutes, conditions, standards or regulations.*

39 **Sec. 19.** 1. *When the Health Division intends to deny,*
40 *suspend or revoke a certificate to operate an intermediary service*
41 *organization, or to impose any sanction prescribed by section 17 of*
42 *this act, the Health Division shall give reasonable notice to the*
43 *holder of the certificate by certified mail. The notice must contain*
44 *the legal authority, jurisdiction and reasons for the action to be*
45 *taken. Notice is not required if the Health Division finds that the*



1 *public health requires immediate action. In that case, the Health*
2 *Division may order a summary suspension of a certificate or*
3 *impose any sanction prescribed by section 17 of this act, pending*
4 *proceedings for revocation or other action.*

5 *2. If a person wants to contest the action of the Health*
6 *Division, the person must file an appeal pursuant to regulations*
7 *adopted by the Board.*

8 *3. Upon receiving notice of an appeal, the Health Division*
9 *shall hold a hearing pursuant to regulations adopted by the Board.*

10 *4. The Board shall adopt such regulations as are necessary to*
11 *carry out the provisions of this section.*

12 **Sec. 20.** *1. Except as otherwise provided in subsection 2,*
13 *within 10 days after hiring an employee or entering into a contract*
14 *with an independent contractor, the holder of a certificate to*
15 *operate an intermediary service organization shall:*

16 *(a) Obtain a written statement from the employee or*
17 *independent contractor stating whether he or she has been*
18 *convicted of any crime listed in subsection 1 of section 23 of this*
19 *act;*

20 *(b) Obtain an oral and written confirmation of the information*
21 *contained in the written statement obtained pursuant to*
22 *paragraph (a);*

23 *(c) Obtain from the employee or independent contractor two*
24 *sets of fingerprints and a written authorization to forward the*
25 *fingerprints to the Central Repository for Nevada Records of*
26 *Criminal History for submission to the Federal Bureau*
27 *of Investigation for its report; and*

28 *(d) Submit to the Central Repository for Nevada Records of*
29 *Criminal History the fingerprints obtained pursuant to*
30 *paragraph (c).*

31 *2. The holder of a certificate to operate an intermediary*
32 *service organization is not required to obtain the information*
33 *described in subsection 1 from an employee or independent*
34 *contractor who provides proof that an investigation of his or her*
35 *criminal history has been conducted by the Central Repository for*
36 *Nevada Records of Criminal History within the immediately*
37 *preceding 6 months and the investigation did not indicate that the*
38 *employee or independent contractor had been convicted of any*
39 *crime set forth in subsection 1 of section 23 of this act.*

40 *3. The holder of a certificate to operate an intermediary*
41 *service organization shall ensure that the criminal history of each*
42 *employee or independent contractor who works at or for the*
43 *intermediary service organization is investigated at least once*
44 *every 5 years. The holder of the certificate shall:*



1 (a) If the intermediary service organization does not have the
2 fingerprints of the employee or independent contractor on file,
3 obtain two sets of fingerprints from the employee or independent
4 contractor;

5 (b) Obtain written authorization from the employee or
6 independent contractor to forward the fingerprints on file or
7 obtained pursuant to paragraph (a) to the Central Repository for
8 Nevada Records of Criminal History for submission to the Federal
9 Bureau of Investigation for its report; and

10 (c) Submit the fingerprints to the Central Repository for
11 Nevada Records of Criminal History.

12 4. Upon receiving fingerprints submitted pursuant to this
13 section, the Central Repository for Nevada Records of Criminal
14 History shall determine whether the employee or independent
15 contractor has been convicted of a crime listed in subsection 1 of
16 section 23 of this act and immediately inform the Health Division
17 and the holder of the certificate to operate an intermediary service
18 organization for which the person works whether the employee or
19 independent contractor has been convicted of such a crime.

20 5. The Central Repository for Nevada Records of Criminal
21 History may impose a fee upon an intermediary service
22 organization that submits fingerprints pursuant to this section for
23 the reasonable cost of the investigation. The intermediary service
24 organization may recover from the employee or independent
25 contractor not more than one-half of the fee imposed by the
26 Central Repository. If the intermediary service organization
27 requires the employee or independent contractor to pay for any
28 part of the fee imposed by the Central Repository, it shall allow the
29 employee or independent contractor to pay the amount through
30 periodic payments.

31 **Sec. 21.** Each intermediary service organization shall
32 maintain accurate records of the information concerning its
33 employees and independent contractors collected pursuant to
34 section 20 of this act and shall maintain a copy of the fingerprints
35 submitted to the Central Repository for Nevada Records of
36 Criminal History and proof that it submitted two sets of
37 fingerprints to the Central Repository for its report. These records
38 must be made available for inspection by the Health Division at
39 any reasonable time, and copies thereof must be furnished to the
40 Health Division upon request.

41 **Sec. 22.** 1. Upon receiving information from the Central
42 Repository for Nevada Records of Criminal History pursuant to
43 section 20 of this act, or evidence from any other source, that an
44 employee or independent contractor of an intermediary service
45 organization has been convicted of a crime listed in subsection 1



1 of section 23 of this act, the holder of the certificate to operate an
2 intermediary service organization shall terminate the employment
3 or contract of that person after allowing the employee or
4 independent contractor time to correct the information pursuant to
5 subsection 2.

6 2. If an employee or independent contractor believes that the
7 information provided by the Central Repository is incorrect,
8 the employee or independent contractor may immediately inform
9 the intermediary service organization. An intermediary service
10 organization that is so informed shall give the employee or
11 independent contractor a reasonable amount of time of not less
12 than 30 days to correct the information received from the Central
13 Repository before terminating the employment or contract of the
14 person pursuant to subsection 1.

15 3. An intermediary service organization that has complied
16 with section 20 of this act may not be held civilly or criminally
17 liable based solely upon the ground that the intermediary service
18 organization allowed an employee or independent contractor to
19 work:

20 (a) Before it received the information concerning the employee
21 or independent contractor from the Central Repository;

22 (b) During any period required pursuant to subsection 2 to
23 allow the employee or independent contractor to correct that
24 information;

25 (c) Based on the information received from the Central
26 Repository, if the information received from the Central
27 Repository was inaccurate; or

28 (d) Any combination thereof.

29 ↪ An intermediary service organization may be held liable for any
30 other conduct determined to be negligent or unlawful.

31 **Sec. 23.** In addition to the grounds listed in section 12 of this
32 act, the Health Division may deny a certificate to operate an
33 intermediary service organization to an applicant or may suspend
34 or revoke a certificate of a holder of a certificate to operate an
35 intermediary service organization if:

36 1. The applicant for or holder of the certificate has been
37 convicted of:

38 (a) Murder, voluntary manslaughter or mayhem;

39 (b) Assault with intent to kill or to commit sexual assault or
40 mayhem;

41 (c) Sexual assault, statutory sexual seduction, incest, lewdness
42 or indecent exposure, or any other sexually related crime that is
43 punished as a felony;

44 (d) Prostitution, solicitation, lewdness or indecent exposure, or
45 any other sexually related crime that is punished as a



1 *misdemeanor, if the conviction occurred within the immediately*
2 *preceding 7 years;*

3 *(e) Abuse or neglect of a child or contributory delinquency;*

4 *(f) A violation of any federal or state law regulating the*
5 *possession, distribution or use of any controlled substance or any*
