SUMMARY—Regulates operators of unmanned aerial vehicles in this State. (BDR 44-8)

AN ACT relating to aircraft; regulating operators of unmanned aerial vehicles in this State; revising the definition of “aircraft” to include unmanned aerial vehicles; prohibiting the operation or use of an unmanned aerial vehicle under certain circumstances or for certain purposes; authorizing a law enforcement agency to operate an unmanned aerial vehicle at certain locations without a warrant under certain circumstances and for any other lawful purpose; prohibiting a law enforcement agency from operating an unmanned aerial vehicle without first obtaining a warrant under certain circumstances; authorizing a public agency to operate an unmanned aerial vehicle only under certain circumstances; requiring the Department of Public Safety, to the extent that money is available, to establish and maintain a registry of unmanned aerial vehicles that are operated by public agencies in this State; requiring the Department to report certain information to the Legislature with respect to the operation of unmanned aerial vehicles by public agencies in this State; requiring the Department to adopt regulations prescribing the public purposes for which a public agency may operate an unmanned aerial vehicle in this State; providing certain criminal and civil penalties for the unlawful operation or use of an unmanned aerial vehicle in this State; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides for the regulation of aeronautics, including the operation
2 of aircraft, in this State. (Title 44 of NRS) This bill revises the definition of
3 "aircraft" to include unmanned aerial vehicles for the purpose of regulating
4 unmanned aerial vehicles. This bill generally regulates the operators of unmanned
5 aerial vehicles in this State in a manner similar to that of traditional aircraft by: (1)
6 establishing the right to operate an unmanned aerial vehicle in this State, with
7 certain exceptions; (2) clarifying that the provisions of this bill are not to be
8 interpreted in a manner inconsistent with federal law or apply to unmanned aerial
9 vehicles owned or operated by the Federal Government; (3) clarifying the
10 applicability of state law to torts and crimes resulting from the operation of
11 unmanned aerial vehicles; and (4) prohibiting a person from operating or using an
12 unmanned aerial vehicle under certain circumstances or for certain purposes.

13 **Section 18** of this bill prohibits a person from weaponizing an unmanned aerial
14 vehicle. **Section 18.5** of this bill prohibits a person from operating an unmanned
15 aerial vehicle within a certain distance from critical facilities or an airport except
16 under certain circumstances in which the person obtains the consent of the owner of
17 a critical facility or the airport authority of an airport or authorization from the
18 Federal Aviation Administration. **Section 19** of this bill authorizes a person who
19 owns or lawfully occupies real property to bring an action for trespass against the
20 owner or operator of an unmanned aerial vehicle under certain circumstances and
21 provides an exception to bringing such an action against an operator lawfully
22 operating an unmanned aerial vehicle within the scope of a business or for the
23 purposes of surveying land. **Sections 20-22** of this bill prescribe certain restrictions
24 on the operation and use of unmanned aerial vehicles by law enforcement agencies
25 and public agencies. **Section 20** specifically prohibits, with limited exceptions, a
26 law enforcement agency from operating an unmanned aerial vehicle for the purpose
27 of gathering evidence or other information at any location or upon any property in
28 this State at which a person has a reasonable expectation of privacy without first
29 obtaining a warrant. **Section 20** authorizes a law enforcement agency to operate an
30 unmanned aerial vehicle without a warrant: (1) if exigent circumstances exist and
31 there is probable cause to believe that a person has committed, is committing or is
32 about to commit a crime; (2) if a person consents in writing to the activity; (3) for
33 the purpose of conducting search and rescue operations; (4) if the law enforcement
34 agency believes that an imminent threat exists to the life and safety of an individual
35 person or to the public at large, including the threat of an act of terrorism; and (5)
36 upon the declaration of a state of emergency or disaster by the Governor. **Section**
37 **21** authorizes a public agency, other than a law enforcement agency, to operate an
38 unmanned aerial vehicle for certain public purposes as prescribed by regulations
39 adopted by the Department of Public Safety if the public agency registers the
40 unmanned aerial vehicle with the Department. **Sections 20 and 21** provide that any
41 photograph, image, recording or other information acquired unlawfully by a law
42 enforcement agency or public agency, or otherwise acquired in a manner
43 inconsistent with **section 20, and** any evidence that is derived therefrom, is
44 inadmissible in any judicial, administrative or other adjudicatory proceeding and
45 may not be used to establish reasonable suspicion or probable cause as the basis for
46 investigating or prosecuting a crime or offense. **Section 22** requires the
47 Department, to the extent that money is available for this purpose, to establish and
48 maintain a registry of unmanned aerial vehicles that are operated by public agencies
49 in this State and requires the Department to adopt regulations prescribing the public
50 purposes for which an agency may operate an unmanned aerial vehicle. **Section 22**
51 further requires the Department to prepare and submit an annual report to the
52 Legislature outlining the activities of public agencies with respect to the operation
53 of unmanned aerial vehicles in this State. **Section 24.4** of this bill revises provisions
54 relating to the liability of the operator of an aircraft, including an unmanned aerial



55 vehicle, with respect to the operation of the aircraft over heavily populated areas or
56 public gatherings. **Section 24.8** of this bill prohibits a person from operating an
57 unmanned aerial vehicle while intoxicated or in a careless or reckless manner so as
58 to endanger the life or property of another person.

20 **Sec. 18.** *1. A person shall not weaponize an unmanned
21 aerial vehicle or operate a weaponized unmanned aerial vehicle. A
22 person who violates this section is guilty of a category D felony
23 and shall be punished as provided in NRS 193.130.*

24 *2. A person who weaponizes an unmanned aerial vehicle in
25 violation of subsection 1 and who discharges the weapon is guilty
26 of a category C felony and shall be punished as provided in
27 NRS 193.130.*

28 **Sec. 18.5.** *1. A person shall not operate an unmanned
29 aerial vehicle within:*

30 *(a) A horizontal distance of 500 feet or a vertical distance of
31 250 feet from a critical facility without the written consent of the
32 owner of the critical facility.*

33 *(b) Except as otherwise provided in subsection 2, 5 miles of an
34 airport.*

35 *2. A person may operate an unmanned aerial vehicle within 5
36 miles of an airport only if the person obtains the consent of the
37 airport authority or the operator of the airport, or if the person has*



1 otherwise obtained a waiver, exemption or other authorization for
2 such operation pursuant to any rule or regulation of the Federal
3 Aviation Administration. A person who is authorized to operate an
4 unmanned aerial vehicle within 5 miles of an airport pursuant to
5 this subsection shall, at all times during such operation, maintain
6 on his or her person documentation of any waiver, exemption,
7 authorization or consent permitting such operation.

8 3. A person who violates this section is guilty of a
9 misdemeanor.

10 4. As used in this section, "airport" means any area of land
11 or water owned, operated or maintained by an airport authority
12 that is designed and set aside for the landing and taking off of
13 aircraft and that is utilized in the interest of the public for such
14 purposes.

15 **Sec. 19. 1.** Except as otherwise provided in subsection 2, a
16 person who owns or lawfully occupies real property in this State
17 may bring an action for trespass against the owner or operator of
18 an unmanned aerial vehicle that is flown at a height of less than
19 250 feet over the property if:

20 (a) The owner or operator of the unmanned aerial vehicle has
21 flown the unmanned aerial vehicle over the property at a height of
22 less than 250 feet on at least one previous occasion; and

23 (b) The person who owns or occupies the real property notified
24 the owner or operator of the unmanned aerial vehicle that the
25 person did not authorize the flight of the unmanned aerial vehicle
26 over the property at a height of less than 250 feet. For the
27 purposes of this paragraph, a person may place the owner or
28 operator of an unmanned aerial vehicle on notice in the manner
29 prescribed in subsection 2 of NRS 207.200.

30 2. A person may not bring an action pursuant to subsection 1
31 if:

32 (a) The unmanned aerial vehicle is lawfully in the flight path
33 for landing at an airport, airfield or runway.

34 (b) The unmanned aerial vehicle is in the process of taking off
35 or landing.

36 (c) The unmanned aerial vehicle was under the lawful
37 operation of a law enforcement agency in accordance with section
38 20 of this act.

39 (d) The unmanned aerial vehicle was under the lawful
40 operation of a business licensed in this State or a land surveyor if:

41 (1) The operator is licensed or otherwise approved to
42 operate the unmanned aerial vehicle by the Federal Aviation
43 Administration;

44 (2) The unmanned aerial vehicle is being operated within
45 the scope of the lawful activities of the business or surveyor; and



1 (3) *The operation of the unmanned aerial vehicle does not*
2 *unreasonably interfere with the existing use of the real property.*

3 3. *A plaintiff who prevails in an action for trespass brought*
4 *pursuant to subsection 1 is entitled to recover treble damages for*
5 *any injury to the person or the real property as the result of the*
6 *trespass. In addition to the recovery of damages pursuant to this*
7 *subsection, a plaintiff may be awarded reasonable attorney's fees*
8 *and costs and injunctive relief.*

9 **Sec. 20.** 1. *Except as otherwise provided in this section,*
10 *nothing in this section shall be deemed to otherwise prohibit the*
11 *operation of an unmanned aerial vehicle by a law enforcement*
12 *agency for any lawful purpose in this State.*

13 2. *Except as otherwise provided in subsection 3, a law*
14 *enforcement agency shall not operate an unmanned aerial vehicle*
15 *for the purpose of gathering evidence or other information within*
16 *the curtilage of a residence or at any other location or upon any*
17 *property in this State at which a person has a reasonable*
18 *expectation of privacy, unless the law enforcement agency first*
19 *obtains a warrant from a court of competent jurisdiction*
20 *authorizing the use of the unmanned aerial vehicle for that*
21 *purpose. A warrant authorizing the use of an unmanned aerial*
22 *vehicle must specify the period for which operation of the*
23 *unmanned aerial vehicle is authorized. A warrant must not*
24 *authorize the use of an unmanned aerial vehicle for a period of*
25 *more than 10 days. Upon motion and a showing of probable*
26 *cause, a court may renew a warrant after the expiration of the*
27 *period for which the warrant was initially issued.*

28 3. *A law enforcement agency may operate an unmanned*
29 *aerial vehicle without obtaining a warrant issued pursuant to*
30 *subsection 2:*

31 (a) *If the law enforcement agency has probable cause to*
32 *believe that a person has committed a crime, is committing a crime*
33 *or is about to commit a crime, and exigent circumstances exist that*
34 *make it unreasonable for the law enforcement agency to obtain a*
35 *warrant authorizing the use of the unmanned aerial vehicle.*

36 (b) *If a person provides written consent to the law enforcement*
37 *agency authorizing the law enforcement agency to acquire*
38 *information about the person or the real or personal property of*
39 *the person. The written consent must specify the information to be*
40 *gathered and the time, place and manner in which the information*
41 *is to be gathered by the law enforcement agency.*

42 (c) *For the purpose of conducting search and rescue*
43 *operations for persons and property in distress.*

44 (d) *Under circumstances in which the law enforcement agency*
45 *believes that an imminent threat exists to the life and safety of an*



1 individual person or to the public at large, including, without
2 limitation, the threat of an act of terrorism. A law enforcement
3 agency that operates an unmanned aerial vehicle pursuant to this
4 paragraph shall document the factual basis for its belief that such
5 an imminent threat exists and shall, not later than 2 business days
6 after initiating operation, file a sworn statement with a court of
7 competent jurisdiction describing the nature of the imminent
8 threat and the need for the operation of the unmanned aerial
9 vehicle.

10 (e) Upon the declaration of a state of emergency or disaster by
11 the Governor. A law enforcement agency that operates an
12 unmanned aerial vehicle pursuant to this paragraph shall not use
13 the unmanned aerial vehicle outside of the geographic area
14 specified in the declaration or for any purpose other than the
15 preservation of public safety, the protection of property, or the
16 assessment and evaluation of environmental or weather-related
17 damage, erosion or contamination.

18 4. Any photograph, image, recording or other information
19 that is acquired by a law enforcement agency through the
20 operation of an unmanned aerial vehicle in violation of this
21 section, or that is acquired from any other person or governmental
22 entity, including, without limitation, a public agency and any
23 department or agency of the Federal Government, that obtained
24 the photograph, image, recording or other information in a
25 manner inconsistent with the requirements of this section, and any
26 evidence that is derived therefrom:

27 (a) Is not admissible in and must not be disclosed in a judicial,
28 administrative or other adjudicatory proceeding; and

29 (b) May not be used to establish reasonable suspicion or
30 probable cause as the basis for investigating or prosecuting a
31 crime or offense.

32 **Sec. 21. 1. A public agency:**

33 (a) May operate an unmanned aerial vehicle only if:

34 (1) Before the operation of the unmanned aerial vehicle,
35 the public agency registers the unmanned aerial vehicle with the
36 Department pursuant to subsection 2 of section 22 of this act.

37 (2) The public agency operates the unmanned aerial
38 vehicle in accordance with the regulations adopted by the
39 Department pursuant to subsection 4 of section 22 of this act.

40 (b) Must not operate an unmanned aerial vehicle for the
41 purposes of assisting a law enforcement agency with law
42 enforcement or conducting a criminal prosecution.

43 2. Any photograph, image, recording or other information
44 that is acquired by a public agency through the operation of an

1 *unmanned aerial vehicle in violation of this section, and any*
2 *evidence that is derived therefrom:*

3 *(a) Is not admissible in, and must not be disclosed in, a*
4 *judicial, administrative or other adjudicatory proceeding; and*

5 *(b) May not be used to establish reasonable suspicion or*
6 *probable cause as the basis for investigating or prosecuting a*

8 **Sec. 22. 1.** *The Department shall, to the extent that money*
9 *is available for this purpose, establish and maintain a registry of*
10 *unmanned aerial vehicles that are operated by public agencies in*
11 *this State. The Department shall include on its Internet website the*
12 *information that is maintained in the registry.*

13 **2.** *A public agency shall, for each unmanned aerial vehicle*
14 *the public agency intends to operate, submit to the Department, on*
15 *a form provided by the Department, for inclusion in the registry:*

16 *(a) The name of the public agency;*

17 *(b) The name and contact information of each operator of the*
18 *unmanned aerial vehicle;*

19 *(c) Sufficient information to identify the unmanned aerial*
20 *vehicle; and*

21 *(d) A statement describing the use of the unmanned aerial*
22 *vehicle by the public agency.*

23 **3.** *The Department shall, on or before February 1 of each*
24 *year, prepare and submit to the Director of the Legislative Counsel*
25 *Bureau for submission to the Legislature, or to the Legislative*
26 *Commission when the Legislature is not in regular session, a*
27 *report outlining the activities of public agencies with respect to the*
28 *operation of unmanned aerial vehicles in this State.*

29 **4.** *The Department shall adopt regulations prescribing the*
30 *public purposes for which a public agency may operate an*
31 *unmanned aerial vehicle that is registered with the Department*
32 *pursuant to this section, including, without limitation:*

33 *(a) The provision of fire services.*

34 *(b) The provision of emergency medical services.*

35 *(c) The protection of a critical facility that is public property.*

36 *(d) Search and rescue operations conducted for persons and*
37 *property in distress.*

6 operated through the air other than immediately above water, is an

8 2. *"Critical facility" means a petroleum refinery, a petroleum*
9 *or chemical production, transportation, storage or processing*
10 *facility, a chemical manufacturing facility, a pipeline and any*
11 *appurtenance thereto, a water treatment facility, a mine as that*
12 *term is defined in subsection 5 of NRS 512.006, a power*
13 *generating station, plant or substation and any appurtenances*
14 *thereto, any transmission line that is owned in whole or in part by*
15 *an electric utility as that term is defined in subsection 5 of NRS*
16 *704.187, a county, city or town jail or detention facility and any*
17 *prison, facility or institution under the control of the Department*
18 *of Corrections.*

19 3. *"Department" means the Department of Public Safety.*

20 4. *"Law enforcement agency" means an agency, office,*
21 *bureau, board, commission, department or division of this State or*
22 *a political subdivision of this State, the primary duty of which is to*
23 *enforce the law.*

24 5. "Operator" includes aviator, pilot, balloonist and any other
25 person having any part in the operation of aircraft while in flight.

26 ~~13~~ 6. "Passenger" includes any person riding in an aircraft,
27 but having no part in its operation.

28 7. *"Public agency" means an agency, office, bureau, board,*
29 *commission, department or division of this State or a political*
30 *subdivision of this State other than a law enforcement agency.*

31 8. *"Unmanned aerial vehicle" means a powered aircraft of*
32 *any size without a human operator aboard the vehicle and that is*
33 *operated remotely or autonomously.*

39 existing use to which the land or water, or the space over the land or
40 water, is put by the owner.

42 persons or property lawfully on the land or water beneath.

44 *493.010 to 493.120, inclusive, and sections 18 to 22, inclusive, of*

1 2. The landing of an aircraft on the lands or waters of another,
2 without his or her consent, is unlawful, except in the case of a forced
3 landing. For damages caused by a forced landing, the owner, lessee
4 or operator of the aircraft is liable as provided in NRS 493.060.

11 trick or acrobatic flying, or in any acrobatic feat;

13 level as to endanger the persons on the surface beneath; or

14 ~~3.~~ (c) Drops any object ~~except loose water or loose sand~~
15 ~~ballast,~~ *with reckless disregard for the safety of other persons and*
16 *willful indifference to injuries that could reasonably result from*

19 **2.** *The provisions of paragraph (a) of subsection 1 do not*
20 *apply to the operator of an unmanned aerial vehicle in a park*

23 *indifference to injuries that could reasonably result from such*
24 *operation.*

25 **Sec. 24.6.** NRS 493.120 is hereby amended to read as follows:

26 493.120 NRS 493.010 to 493.120, inclusive, *and sections 18 to*
27 *22, inclusive, of this act* shall be so interpreted and construed as to
28 effectuate their general purpose to make uniform the law of those
29 states which enact them, and to harmonize, as far as possible, with
30 federal laws and regulations on the subject of aeronautics. They
31 shall not be interpreted or construed to apply in any manner to
32 aircraft owned and operated by the Federal Government.

33 **Sec. 24.8.** NRS 493.130 is hereby amended to read as follows:

34 493.130 **1.** Any person operating an aircraft in the air, or on
35 the ground or water:

5 **Sec. 25.** The provisions of subsection 1 of NRS 218D.380 do
6 not apply to any provision of this act which adds or revises a
7 requirement to submit a report to the Legislature.

8 **Sec. 26.** This act becomes effective:

9 1. Upon passage and approval for the purpose of adopting
10 regulations and performing any other preparatory administrative
11 tasks necessary to carry out the provisions of this act; and

12 2. On October 1, 2015, for all other purposes.
