AN ACT

RELATING TO PUBLIC PURCHASES; AMENDING SECTIONS OF THE
PROCUREMENT CODE TO PROVIDE FOR QUALIFICATIONS-BASED SERVICES
PROCUREMENT BY ALL PUBLIC BODIES OF SERVICES OF ARCHITECTS,
ENGINEERS, LANDSCAPE ARCHITECTS OR SURVEYORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 13-1-98 NMSA 1978 (being Laws 1984,
Chapter 65, Section 71, as amended by Laws 2013, Chapter 40,
Section 1 and by Laws 2013, Chapter 70, Section 6 and also by
Laws 2013, Chapter 71, Section 1) is amended to read:

"13-1-98. EXEMPTIONS FROM THE PROCUREMENT CODE.--The
provisions of the Procurement Code shall not apply to:

A. procurement of items of tangible personal
property or services by a state agency or a local public body
from a state agency, a local public body or external

16 private conveyance or to meals and lodging;

17 G. purchase of livestock at auction rings or to the
18 procurement of animals to be used for research and
19 experimentation or exhibit;

20 H. contracts with businesses for public school
21 transportation services;

22 I. procurement of tangible personal property or
23 services, as defined by Sections 13-1-87 and 13-1-93 NMSA 1978,
24 by the corrections industries division of the corrections
25 department pursuant to rules adopted by the corrections

8 K. municipalities having adopted home rule charters
9 and having enacted their own purchasing ordinances, except for
10 competitive sealed qualifications-based proposals pursuant to
11 Sections 13-1-120 through 13-1-124 NMSA 1978;

12 L. the issuance, sale and delivery of public
13 securities pursuant to the applicable authorizing statute, with
14 the exception of bond attorneys and general financial
15 consultants;

16 M. contracts entered into by a local public body
17 with a private independent contractor for the operation, or
18 provision and operation, of a jail pursuant to Sections
19 33-3-26 and 33-3-27 NMSA 1978;

20 N. contracts for maintenance of grounds and
21 facilities at highway rest stops and other employment
22 opportunities, excluding those intended for the direct care and
23 support of persons with [~~handicaps~~] disabilities, entered into
24 by state agencies with private, nonprofit, independent
25 contractors who provide services to persons with [~~handicaps~~]

18 public improvements undertaken in improvement districts
19 pursuant to Subsection L of Section 3-33-14.1 NMSA 1978 and in
20 county improvement districts pursuant to Subsection L of
21 Section 4-55A-12.1 NMSA 1978;

22 T. works of art for museums or for display in
23 public buildings or places;

24 U. contracts entered into by a local public body
25 with a person, firm, organization, corporation or association

1 or a state educational institution named in Article 12, Section
2 11 of the constitution of New Mexico for the operation and
3 maintenance of a hospital pursuant to Chapter 3, Article 44
4 NMSA 1978, lease or operation of a county hospital pursuant to
5 the Hospital Funding Act or operation and maintenance of a
6 hospital pursuant to the Special Hospital District Act;

7 V. purchases of advertising in all media, including
8 radio, television, print and electronic;

9 W. purchases of promotional goods intended for
10 resale by the tourism department;

11 X. procurement of printing services for materials
12 produced and intended for resale by the cultural affairs
13 department;

14 Y. procurement by or through the public education
15 department from the federal department of education relating to
16 parent training and information centers designed to increase
17 parent participation, projects and initiatives designed to
18 improve outcomes for students with disabilities and other
19 projects and initiatives relating to the administration of
20 improvement strategy programs pursuant to the federal
21 Individuals with Disabilities Education Act; provided that the
22 exemption applies only to procurement of services not to exceed
23 two hundred thousand dollars (\$200,000);

19 victims of crime, including grants from the federal Victims of
20 Crime Act of 1984 and the federal Violence Against Women Act of

2 SECTION 2. Section 13-1-119 NMSA 1978 (being Laws 1984,
3 Chapter 65, Section 92, as amended) is amended to read:

4 "13-1-119. COMPETITIVE SEALED QUALIFICATIONS-BASED
5 PROPOSALS--ARCHITECTS--ENGINEERS--LANDSCAPE ARCHITECTS--
6 SURVEYORS--ADDITIONAL REQUIREMENTS.--In addition to
7 compliance with the requirements of Sections 13-1-112 through
8 13-1-114 and 13-1-116 through 13-1-118 NMSA 1978, a state
9 agency or local public body, including home rule
10 municipalities, when procuring the services of architects,
11 landscape architects, engineers or surveyors for state public
12 works projects or local public works projects, shall comply
13 with Sections 13-1-120 through 13-1-124 NMSA 1978."
