A MEMORIAL

PROCLAIMING FEBRUARY 3, 2015 "PATRICK GRANGE ALS AWARENESS DAY"  
IN THE SENATE.

WHEREAS, amyotrophic lateral sclerosis, ALS, is better known as Lou Gehrig's disease; and

WHEREAS, ALS is a fatal neurodegenerative disease that is characterized by degeneration of the cell bodies of the lower motor neurons in the gray matter of the anterior horns of the spinal cord; and

WHEREAS, the initial symptom of ALS is weakness of the skeletal muscles, especially those of the extremities; and

WHEREAS, as ALS progresses, the patient experiences difficulty in swallowing, talking and breathing; and

WHEREAS, ALS eventually causes muscles to atrophy, and the patient becomes a functional quadriplegic; and

1           WHEREAS, ALS does not affect a patient's mental capacity,  
2           so the patient remains alert and aware of the patient's loss of  
3           motor functions and of the inevitable outcome of continued  
4           deterioration and death; and

5           WHEREAS, on average, patients diagnosed with ALS only  
6           survive two to five years from the time of diagnosis; and

7           WHEREAS, research indicates that military veterans have a  
8           fifty percent greater risk of developing ALS than those who  
9           have not served in the military; and

10          WHEREAS, ALS has no known cause, no means of prevention  
11          and no cure; and

12          WHEREAS, an estimated one hundred fifty New Mexicans are  
13          living with ALS at any given time; and

14          WHEREAS, in 2010, soon after his twenty-eighth birthday,  
15          former university of New Mexico lobo and Albuquerque high  
16          school soccer star Patrick Grange was diagnosed with ALS,  
17          making him the youngest ALS patient in New Mexico; and

18          WHEREAS, as a senior, Pat led the Albuquerque high school  
19          bulldogs to a district 1-5A championship title; and

20          WHEREAS, Pat was the first soccer player to be inducted  
21          into the Albuquerque high school athletic hall of fame; and

22          WHEREAS, as a senior at the university of New Mexico, Pat  
23          started in all twenty games for the lobos men's soccer team,  
24          was third on the team in scoring and scored two goals in the  
25          national collegiate athletic association tournament; and

1 WHEREAS, despite fighting this terrible disease as hard as  
2 he could, Pat died of ALS on April 10, 2012; and

3 WHEREAS, "Patrick Grange ALS Awareness Day" will increase  
4 public awareness of ALS patients' circumstances, acknowledge  
5 the terrible impact the disease has, not only on the patient  
6 but also on the patient's family and community, and recognize  
7 the research being done to eradicate this horrible disease;

8 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE  
9 OF NEW MEXICO that February 3, 2015 be proclaimed "Patrick  
10 Grange ALS Awareness Day" in the senate; and

11 BE IT FURTHER RESOLVED that the senate urge the president  
12 of the United States and members of congress to enact  
13 legislation to provide additional funding for research in order  
14 to find a treatment and, eventually, a cure for ALS; and

15 BE IT FURTHER RESOLVED that a copy of this memorial be  
16 transmitted to the interim legislative health and human  
17 services committee.
