16	2014, Section 1272), is amended to read as follows:
17	Section 1272.
18	UNLAWFUL CARRY
19	A. It shall be unlawful for any person to carry upon or about
20	his or her person, or in a purse or other container belonging to the
21	person, any pistol, revolver, shotgun or rifle whether loaded or
22	unloaded or any dagger, bowie knife, dirk knife, switchblade knife,
23	sword cane, knife having a blade which opens automatically by hand
24	pressure applied to a button, spring, or other device in the handle

of the knife, blackjack, loaded cane, billy, hand chain, metal knuckles, or any other offensive weapon, whether such weapon be concealed or unconcealed, except this section shall not prohibit:

- The proper use of guns and knives for hunting, fishing, educational or recreational purposes;
- 2. The carrying or use of weapons in a manner otherwise permitted by statute or authorized by the Oklahoma Self-Defense Act;
- 3. The carrying, possession and use of any weapon by a peace officer or other person authorized by law to carry a weapon in the performance of official duties and in compliance with the rules of the employing agency;
- 4. The carrying or use of weapons in a courthouse by a district judge, associate district judge or special district judge within this state, who is in possession of a valid handgun license issued pursuant to the provisions of the Oklahoma Self-Defense Act and whose name appears on a list maintained by the Administrative Director of the Courts; or
- 5. The carrying and use of firearms and other weapons provided in this subsection when used for the purpose of living history reenactment. For purposes of this paragraph, "living history reenactment" means depiction of historical characters, scenes, historical life or events for entertainment, education, or historical documentation through the wearing or use of period,
