- 4. "Manufacture" means forging, casting, machining, or another process for working a material.
- 1. A firearm suppressor that is manufactured in this state and remains in this state shall not be subject to federal law or federal regulation including registration under the authority of the United States Congress to regulate interstate commerce.
- 2. A basic material from which a firearm suppressor is manufactured in this state, including unmachined steel, is not a firearm suppressor and is not subject to federal regulation under the authority of the United States Congress to regulate interstate commerce as if it were a firearm suppressor.
- 3. A firearm suppressor manufactured and sold in this state must have the words "Made in Oklahoma" clearly stamped, machined, or engraved on it.
- C. For purposes of this section, a firearm suppressor is manufactured in this state if the item is manufactured:
 - 1. In this state from basic materials;
- Without the inclusion of any part imported from another state other than a generic and insignificant part as defined in this section; and
- 3. Without regard to whether a firearm imported into this state from another state is attached to or used in conjunction with the suppressor.
