6	<u>AS INTRODUCED</u>
7	An Act relating to income tax credits; amending 68
8	O.S. 2011, Section 2357.32A, as amended by Section 2, Chapter 371, O.S.L. 2013 (68 O.S. Supp. 2014, Section 2357.32A), which relates to credits for production of
9	electricity from zero-emission facilities; modifying time period during which certain credit is allowed;
10	modifying length of time during which credit may be claimed after certain activity; providing an
11	effective date and declaring an emergency.

13	
14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 68 O.S. 2011, Section 2357.32A, as
16	amended by Section 2, Chapter 371, O.S.L. 2013 (68 O.S. Supp. 2014,
17	Section 2357.32A), is amended to read as follows:
18	Section 2357.32A. A. Except as otherwise provided in
19	subsection H of this section, for tax years beginning on or after
20	January 1, 2003, there shall be allowed a credit against the tax
21	imposed by Section 2355 of this title to a taxpayer for the
22	taxpayer's production and sale to an unrelated person of electricity
23	generated by zero-emission facilities located in this state. As
24	used in this section:

1 1. "Electricity generated by zero-emission facilities" means electricity that is exclusively produced by any facility located in 2 this state with a rated production capacity of one megawatt (1 mw) 3 or greater, constructed for the generation of electricity and placed 4 5 in operation after June 4, 2001, which utilizes eligible renewable resources as its fuel source. The construction and operation of 6 such facilities shall result in no pollution or emissions that are 7 or may be harmful to the environment, pursuant to a determination by 8 9 the Department of Environmental Quality; and

- "Eligible renewable resources" means resources derived from:
 a. wind,
- 12 b. moving water,
- 13 c. sun, or
- 14

d. geothermal energy.

For facilities placed in operation on or after January 1, 15 Β. 2003, and before January 1, 2007, the amount of the credit for the 16 electricity generated on or after January 1, 2003, but prior to 17 January 1, 2004, shall be seventy-five one-hundredths of one cent 18 (\$0.0075) for each kilowatt-hour of electricity generated by zero-19 emission facilities. For electricity generated on or after January 20 1, 2004, but prior to January 1, 2007, the amount of the credit 21 shall be fifty one-hundredths of one cent (\$0.0050) per kilowatt-22 hour for electricity generated by zero-emission facilities. For 23 electricity generated on or after January 1, 2007, but prior to 24

1 January 1, 2012, the amount of the credit shall be twenty-five onehundredths of one cent (\$0.0025) per kilowatt-hour of electricity 2 generated by zero-emission facilities. For facilities placed in 3 operation on or after January 1, 2007, and before January 1, 2021 4 5 January 1, 2016, the amount of the credit for the electricity generated on or after January 1, 2007, shall be fifty one-hundredths 6 of one cent (\$0.0050) for each kilowatt-hour of electricity 7 generated by zero-emission facilities. 8

9 C. Credits may be claimed with respect to electricity generated on or after January 1, 2003, during a ten-year period following the 10 11 date that the facility is placed in operation on or after June 4, 12 2001 and before the effective date of this act. For electricity generated from a facility placed in service on or after the 13 effective date of this act, credits may be claimed during a three-14 year period following the date that the facility is placed in 15 16 service.

1. For credits generated prior to January 1, 2014, if the 17 D. credit allowed pursuant to this section exceeds the amount of income 18 taxes due or if there are no state income taxes due on the income of 19 the taxpayer, the amount of the credit allowed but not used in any 20 tax year may be carried forward as a credit against subsequent 21 income tax liability for a period not exceeding ten (10) years. 22 2. For credits generated, but not used, on or after January 1, 23 2014, the Oklahoma Tax Commission shall refund, at the taxpayer's 24

1 election, directly to the taxpayer eighty-five percent (85%) of the face amount of such credits. The direct refund of the credits 2 3 pursuant to this paragraph shall be available to all taxpayers, including, without limitation, pass-through entities and taxpayers 4 5 subject to Section 2355 of this title, but shall not be available to any entities falling within the provisions of subsection E of this 6 The amount of any direct refund of credits actually 7 section. received at the eighty-five percent (85%) level by the taxpayer 8 9 pursuant to this paragraph shall not be subject to the tax imposed 10 by Section 2355 of this title. If the pass-through entity does not 11 file a claim for a direct refund, the pass-through entity shall allocate the credit to one or more of the shareholders, partners or 12 13 members of the pass-through entity; provided, the total of all credits refunded or allocated shall not exceed the amount of the 14 credit or refund to which the pass-through entity is entitled. For 15 the purposes of this paragraph, "pass-through entity" means a 16 corporation that for the applicable tax year is treated as an S 17 corporation under the Internal Revenue Code of 1986, as amended, 18 general partnership, limited partnership, limited liability 19 partnership, trust or limited liability company that for the 20 applicable tax year is not taxed as a corporation for federal income 21 tax purposes. 22

E. Any nontaxable entities, including agencies of the State ofOklahoma or political subdivisions thereof, shall be eligible to

1 establish a transferable tax credit in the amount provided in subsection B of this section. Such tax credit shall be a property 2 3 right available to a state agency or political subdivision of this state to transfer or sell to a taxable entity, whether individual or 4 5 corporate, who shall have an actual or anticipated income tax liability under Section 2355 of this title. These tax credit 6 provisions are authorized as an incentive to the State of Oklahoma, 7 its agencies and political subdivisions to encourage the expenditure 8 9 of funds in the development, construction and utilization of electricity from zero-emission facilities as defined in subsection A 10 of this section. 11

F. For credits generated prior to January 1, 2014, the amount 12 of the credit allowed, but not used, shall be freely transferable at 13 any time during the ten (10) years following the year of 14 qualification. Any person to whom or to which a tax credit is 15 transferred shall have only such rights to claim and use the credit 16 under the terms that would have applied to the entity by whom or by 17 which the tax credit was transferred. The provisions of this 18 subsection shall not limit the ability of a tax credit transferee to 19 reduce the tax liability of the transferee, regardless of the actual 20 tax liability of the tax credit transferor, for the relevant taxable 21 period. The transferor initially allowed the credit and any 22 subsequent transferees shall jointly file a copy of any written 23 transfer agreement with the Oklahoma Tax Commission within thirty 24

1 (30) days of the transfer. The written agreement shall contain the name, address and taxpayer identification number or social security 2 3 number of the parties to the transfer, the amount of the credit being transferred, the year the credit was originally allowed to the 4 5 transferor, and the tax year or years for which the credit may be The Tax Commission may promulgate rules to permit 6 claimed. verification of the validity and timeliness of the tax credit 7 claimed upon a tax return pursuant to this subsection but shall not 8 9 promulgate any rules that unduly restrict or hinder the transfers of 10 such tax credit. The tax credit allowed by this section, upon the 11 election of the taxpayer, may be claimed as a payment of tax, a 12 prepayment of tax or a payment of estimated tax for purposes of 13 Section 1803 or Section 2355 of this title.

G. For electricity generation produced and sold in a calendar year, the tax credit allowed by the provisions of this section, upon election of the taxpayer, shall be treated and may be claimed as a payment of tax, a prepayment of tax or a payment of estimated tax for purposes of Section 2355 of this title on or after July 1 of the following calendar year.

H. No credit otherwise authorized by the provisions of this
section may be claimed for any event, transaction, investment,
expenditure or other act occurring on or after July 1, 2010, for
which the credit would otherwise be allowable until the provisions
of this subsection shall cease to be operative on July 1, 2011.

1	Beginning July 1, 2011, the credit authorized by this section may be
2	claimed for any event, transaction, investment, expenditure or other
3	act occurring on or after July 1, 2010, according to the provisions
4	of this section. Any tax credits which accrue during the period of
5	July 1, 2010, through June 30, 2011, may not be claimed for any
6	period prior to the taxable year beginning January 1, 2012. No
7	credits which accrue during the period of July 1, 2010, through June
8	30, 2011, may be used to file an amended tax return for any taxable
9	year prior to the taxable year beginning January 1, 2012.
10	SECTION 2. This act shall become effective July 1, 2015.
11	SECTION 3. It being immediately necessary for the preservation
12	of the public peace, health and safety, an emergency is hereby
13	declared to exist, by reason whereof this act shall take effect and
14	be in full force from and after its passage and approval.
