1	SECTION 1. NEW LAW A new section of law to be codified
2	in the Oklahoma Statutes as Section 1210.211 of Title 70, unless
3	there is created a duplication in numbering, reads as follows:
4	Sections 2 and 3 of this act shall be known and may be cited as
5	the "24/7 Tobacco-free Schools Act".

SECTION 2. A new section of law to be codified NEW LAW in the Oklahoma Statutes as Section 1210.212 of Title 70, unless there is created a duplication in numbering, reads as follows:

As used in the 24/7 Tobacco-free Schools Act:

- "Chewing tobacco" means any Cavendish, twist, plug, scrap, and any other kinds and forms of tobacco suitable for chewing;
- "Educational facility" means any property, building, permanent structure, facility, auditorium, stadium, arena or recreational facility owned, leased or under the control of a public school district or private school located in the state. For purposes of this act, a public school district shall not include a technology center school district;
- "School vehicle" means any transportation equipment or auxiliary transportation equipment as defined in Section 9-104 of Title 70 of the Oklahoma Statutes;
- "Smoking tobacco" means any granulated, plug cut, crimp cut, ready rubbed, and any other kinds and forms of tobacco suitable for smoking in a pipe or cigarette; and

- 5. "Tobacco product" means any bidis, cigars, cheroots,
  stogies, smoking tobacco and chewing tobacco, however prepared.
  Tobacco products shall include any other articles or products made
- 3 Tobacco products shall include any other articles or products made 4 of tobacco.
- SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1210.213 of Title 70, unless there is created a duplication in numbering, reads as follows:
  - A. The use of a tobacco product shall be prohibited in or on an educational facility that offers an early childhood education program or in which children in grades kindergarten through twelve are educated. The use of a tobacco product shall also be prohibited in school vehicles and at any school-sponsored or school-sanctioned event or activity.
  - B. Nothing in this section shall be construed to prohibit a public school district or private school from having more restrictive policies regarding tobacco products in or on an educational facility, in school vehicles and at any school-sponsored or school-sanctioned event or activity.
- 19 SECTION 4. AMENDATORY 21 O.S. 2011, Section 1247, as
  20 last amended by Section 1, Chapter 167, O.S.L. 2014 (21 O.S. Supp.
- 21 2014, Section 1247), is amended to read as follows:
- Section 1247. A. The possession of lighted tobacco in any form
  is a public nuisance and dangerous to public health and is hereby

prohibited when such possession is in any indoor place used by or open to the public, all parts of a zoo to which the public may be admitted, whether indoors or outdoors, public transportation, or any indoor workplace, except where specifically allowed by law.

Commercial airport operators may prohibit the use of lighted tobacco in any area that is open to or used by the public whether located indoors or outdoors, provided that the outdoor area is within one hundred seventy-five (175) feet from an entrance.

As used in this section, "indoor workplace" means any indoor place of employment or employment-type service for or at the request of another individual or individuals, or any public or private entity, whether part-time or full-time and whether for compensation or not. Such services shall include, without limitation, any service performed by an owner, employee, independent contractor, agent, partner, proprietor, manager, officer, director, apprentice, trainee, associate, servant or volunteer. An indoor workplace includes work areas, employee lounges, restrooms, conference rooms, classrooms, employee cafeterias, hallways, any other spaces used or visited by employees, and all space between a floor and ceiling that is predominantly or totally enclosed by walls or windows, regardless of doors, doorways, open or closed windows, stairways, or the like. The provisions of this section shall apply to such indoor workplace at any given time, whether or not work is being performed.

- 1 B. All buildings and other properties, or portions thereof, 2 owned or operated by this state shall be designated as nonsmoking. 3 The provisions of this subsection shall not apply to veterans centers operated by this state pursuant to the provisions of Section 4 5 221 et seg. of Title 72 of the Oklahoma Statutes, which shall be designated nonsmoking effective January 1, 2015, at which time 6 7 veterans centers may establish outdoor designated smoking areas for resident veterans only. Smoking shall only be allowed in designated 8 9 outdoor smoking areas until January 1, 2018. All campuses, buildings and grounds, or portions thereof, owned or operated by an institution within The Oklahoma State System of Higher Education may shall be designated as

  - E. No smoking shall be allowed within twenty-five (25) feet of the entrance or exit of any building specified in subsection B, C or D of this section.

- F. The restrictions provided in this section shall not apply to stand-alone bars, stand-alone taverns and cigar bars as defined in Section 1-1522 of Title 63 of the Oklahoma Statutes.
- G. The restrictions provided in this section shall not apply to the following:
- 1. The room or rooms where licensed charitable bingo games are being operated, but only during the hours of operation of such games;
- 2. Up to twenty-five percent (25%) of the guest rooms at a hotel or other lodging establishment;
- 3. Retail tobacco stores predominantly engaged in the sale of tobacco products and accessories and in which the sale of other products is merely incidental and in which no food or beverage is sold or served for consumption on the premises;

- 10. Any outdoor seating area of a restaurant; provided, smoking shall not be allowed within fifteen (15) feet of any exterior public doorway or any air intake of a restaurant.
- H. An employer not otherwise restricted from doing so may elect to provide smoking rooms where no work is performed except for cleaning and maintenance during the time the room is not in use for smoking, provided each smoking room is fully enclosed and exhausted directly to the outside in such a manner that no smoke can drift or circulate into a nonsmoking area. No exhaust from a smoking room shall be located within fifteen (15) feet of any entrance, exit or air intake.
- I. If smoking is to be permitted in any space exempted in subsection F or G of this section or in a smoking room pursuant to subsection H of this section, such smoking space must either occupy the entire enclosed indoor space or, if it shares the enclosed space with any nonsmoking areas, the smoking space shall be fully enclosed, exhausted directly to the outside with no air from the smoking space circulated to any nonsmoking area, and under negative air pressure so that no smoke can drift or circulate into a nonsmoking area when a door to an adjacent nonsmoking area is opened. Air from a smoking room shall not be exhausted within fifteen (15) feet of any entrance, exit or air intake. Any employer

- may choose a more restrictive smoking policy, including being totally smoke free.
- 3 J. Notwithstanding any other provision of this section, until March 1, 2006, restaurants may have designated smoking and 4 5 nonsmoking areas or may be designated as being a totally nonsmoking Beginning March 1, 2006, restaurants shall be totally 6 nonsmoking or may provide nonsmoking areas and designated smoking 7 rooms. Food and beverage may be served in such designated smoking 8 9 rooms which shall be in a location which is fully enclosed, directly 10 exhausted to the outside, under negative air pressure so smoke 11 cannot escape when a door is opened, and no air is recirculated to 12 nonsmoking areas of the building. No exhaust from such room shall be located within twenty-five (25) feet of any entrance, exit or air 13 Such room shall be subject to verification for compliance 14 intake. with the provisions of this subsection by the State Department of 15 Health. 16
  - K. The person who owns or operates a place where smoking or tobacco use is prohibited by law shall be responsible for posting a sign or decal, at least four (4) inches by two (2) inches in size, at each entrance to the building indicating that the place is smokefree or tobacco-free.
  - L. Responsibility for posting signs or decals shall be as follows:

- 1. In privately owned facilities, the owner or lessee, if a lessee is in possession of the facilities, shall be responsible;
  - 2. In corporately owned facilities, the manager and/or supervisor of the facility involved shall be responsible; and
- 3. In publicly owned facilities, the manager and/or supervisor of the facility shall be responsible.
- M. Any person who knowingly violates the provisions of this section is guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine of not less than Ten Dollars (\$10.00) nor more than One Hundred Dollars (\$100.00).
- 11 SECTION 5. AMENDATORY 63 O.S. 2011, Section 1-1522, is
  12 amended to read as follows:
  - Section 1-1522. As used in this act:
  - 1. "Educational facility" means a building owned, leased or under the control of a <u>technology center school district or a</u> public or private <u>school system</u>, college or university;
  - 2. "Health facility" means an entity which provides health services, including, but not limited to, hospitals, nursing homes, long-term care facilities, kidney disease treatment centers, health maintenance organizations and ambulatory treatment centers;
  - 3. "Indoor workplace" means any indoor place of employment or employment-type service for or at the request of another individual or individuals, or any public or private entity, whether part-time

- 8. "Smoking" means the carrying by a person of a lighted cigar, cigarette, pipe or other lighted smoking device; and

Except as specifically provided in the Smoking in Public Places and Indoor Workplaces Act, no person shall smoke in a public place, in any part of a zoo to which the public may be admitted, whether indoors or outdoors, in an indoor workplace, in any vehicle providing public transportation, at a meeting of a public body, in a nursing facility licensed pursuant to the Nursing Home Care Act, or in a child care facility licensed pursuant to the Oklahoma Child Care Facilities Licensing Act. A nursing facility licensed pursuant to the Nursing Home Care Act may designate smoking rooms for residents and their quests. Such rooms

Except as otherwise provided in paragraph 2 of this subsection, an educational facility a technology center school district which offers an early childhood education program or in which children in grades kindergarten through twelve are educated shall prohibit smoking, the use of snuff, chewing tobacco or any other form of tobacco product in the educational facility buildings and on the grounds of the facility by all persons including, but not limited to, full-time, part-time, and contract employees, during the hours of 7:00 a.m. to 4:00 p.m., during the school session, or when class or any program established for students is in session.
  - 2. Career and A technology centers center school district may designate smoking areas outside of buildings, away from general traffic areas and completely out of sight of children under eighteen (18) years of age, for use by adults attending training courses, sessions, meetings or seminars.

- 1 3. An educational facility A technology center school district or college or university may designate smoking areas outside the educational facility buildings for the use of adults during certain activities or functions, including, but not limited to, athletic contests.
  - 4. Smoking shall be prohibited in an educational facility as defined in the 24/7 Tobacco-free Schools Act and as provided for in Section 3 of this act.
  - C. Nothing in this section shall be construed to prohibit educational facilities from having more restrictive policies regarding smoking and the use of other tobacco products in the buildings or on the grounds of the facility.
  - D. A private residence is not a "public place" within the meaning of the Smoking in Public Places and Indoor Workplaces Act except that areas in a private residence that are used as a licensed child care facility during hours of operation are "public places" within the meaning of the Smoking in Public Places and Indoor Workplaces Act.
  - Smoking is prohibited in all vehicles owned by the State of Ε. Oklahoma and all of its agencies and instrumentalities.
  - F. Veterans centers operated by this state pursuant to the provisions of Section 221 et seq. of Title 72 of the Oklahoma Statutes shall be designated nonsmoking effective January 1, 2015,
