which relates to the Board of Dentistry; permitting

referring to certain personnel; permitting certain
14 reimbursement; amending 59 O.S. 2011, Section 328.15,
as last amended by Section 3, Chapter 405, O.S.L.
2013 (59 O.S. Supp. 2014, Section 328.15), which
15 relates to powers of the Board; modifying powers;

16 certain persons; amending 59 O.S. 2011, Section
17 328.27, as amended by Section 8, Chapter 405, O.S.L.
18 2013 (59 O.S. Supp. 2014, Section 328.27), which
19 relates to faculty permits; expanding acceptable
20 documentation for faculty licensure; requiring
21 certain request and certification prior to issuance
22 of faculty license; providing for expiration of
23 license; limiting scope of practice for licensees;
24 permitting issuance of faculty licenses to foreign
applicants; providing standards for issuance;
permitting issuance of temporary licenses under
certain circumstances and for certain purposes;
providing for expiration of temporary licenses;
amending Section 6, Chapter 270, O.S.L. 2012, as
amended by Section 9, Chapter 405, O.S.L. 2013 (59
O.S. Supp. 2014, Section 328.28a), which relates to
criminal background checks; extending effective date
of background checks; providing certain exemption;
amending 59 O.S. 2011, Section 328.29a, as amended by
Section 10, Chapter 405, O.S.L. 2013 (59 O.S. Supp.
2014, Section 328.29a), which relates to dental
assistants; expanding grounds of revocations of
licenses; amending 59 O.S. 2011, Section 328.31a,
which relates to the use of trade names; requiring
name of dentist to be included on certain forms;
requiring certain information on advertisements;
requiring certain facilities to maintain written
records of certain information; providing standards
and guidelines for required information; requiring
records to be maintained for certain duration;
amending 59 O.S. 2011, Section 328.32, as last
amended by Section 12, Chapter 405, O.S.L. 2013 (59

1 O.S. Supp. 2014, Section 328.32), which relates to
2 grounds for penalties; broadening grounds for
3 penalties to include certain acts; extending period
4 of maintaining certain records; amending 59 O.S.
5 2011, Section 328.34, as amended by Section 14,
6 Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2014, Section
7 328.34), which relates to dental supervision;
8 providing definitions; requiring submission of
9 certain information; amending 59 O.S. 2011, Section
10 328.41, as last amended by Section 15, Chapter 405,
11 O.S.L. 2013 (59 O.S. Supp. 2014, Section 328.41),
12 which relates to renewal certificates; establishing
13 continuing education requirements; deleting language
14 relating to waiver of certain fees and renewal of
15 licenses; permitting application for renewal of
16 licenses under certain circumstances; requiring new
17 applications for certain persons; amending 59 O.S.
18 2011, Section 328.43a, as amended by Section 10,
19 Chapter 270, O.S.L. 2012 (59 O.S. Supp. 2014, Section
20 328.43a), which relates to complaints; removing
21 provisions relating to written complaints; requiring
22 Board President to assign certain panel; providing
23 powers and duties of panel; permitting panel to
24 conduct certain actions in investigations and
reviews; prohibiting discussion of deliberations to
certain persons; providing exemption from certain
Act; providing for conduct of certain proceedings;
removing language relating to the acceptance and
disclosure of settlement agreements; requiring
approval of settlements by certain persons;
permitting panel to make certain recommendations;
requiring certain information in complaints;
providing standards for delivery of certain notices;
removing language relating to disclosure of
documents; requiring investigation of fatalities
within certain time period; providing standards for
investigations; amending 59 O.S. 2011, Section
328.44a, as amended by Section 16, Chapter 405,
O.S.L. 2013 (59 O.S. Supp. 2014, Section 328.44a),
which relates to penalties; expanding types of
facilities subject to certain penalties; removing
certain grounds for penalties; amending 59 O.S. 2011,
Section 328.62, which relates to definitions;
modifying definition to include certain persons;
amending 59 O.S. 2011, Section 328.63, which relates
to protection from liability; stating that certain
mediation is voluntary; providing certain

1 construction; permitting involved parties to request
2 dismissal; requiring certain notice; clarifying
3 language; clarifying references; removing obsolete
4 language; providing for codification; providing an
5 effective date; and declaring an emergency.

6 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

7 SECTION 1. AMENDATORY 59 O.S. 2011, Section 328.2, as
8 amended by Section 1, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2014,
9 Section 328.2), is amended to read as follows:

10 Section 328.2. The practice of dentistry in the State of
11 Oklahoma is hereby declared to affect the public health, safety and
12 general welfare and to be subject to regulation and control in the
13 public's best interest. It is further declared to be a matter of
14 public interest and concern that the dental profession, through
15 advancement and achievement, merits and receives the confidence of
16 the public and that only properly qualified dentists be permitted to
17 practice dentistry and supervise dental hygienists, dental
18 assistants and oral maxillofacial surgery assistants in the State of
19 Oklahoma. All provisions of this act relating to the practice of
20 dentistry, the practice of dental hygiene, the procedures performed
21 by dental assistants and oral maxillofacial surgery assistants, and
22 the fabrication of dental appliances in dental laboratories by
23 dental laboratory technicians shall be liberally construed to carry
24 out these objects and purposes.

1 SECTION 2. AMENDATORY 59 O.S. 2011, Section 328.3, as
2 amended by Section 2, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2014,
3 Section 328.3), is amended to read as follows:

4 Section 328.3. As used in the State Dental Act, the following
5 words, phrases, or terms, unless the context otherwise indicates,
6 shall have the following meanings:

7 1. "Accredited dental college" means an institution whose
8 dental educational program is accredited by the Commission on Dental
9 Accreditation of the American Dental Association;

10 2. "Accredited dental hygiene program" means a dental hygiene
11 educational program which is accredited by the Commission on Dental
12 Accreditation of the American Dental Association;

13 3. "Accredited dental assisting program" means a dental
14 assisting program which is accredited by the Commission on Dental
15 Accreditation of the American Dental Association;

16 4. "Board" means the Board of Dentistry;

17 5. "Certified dental assistant" means a dental assistant who
18 has earned and maintains current certified dental assistant
19 certification from the Dental Assisting National Board (DANB);

20 6. "Coronal polishing means a procedure limited to the removal
21 of plaque and stain from exposed tooth surfaces, utilizing a slow
22 speed hand piece with a rubber cup or brush and polishing agent and
23 is not prophylaxis. To be considered prophylaxis, examination for
24 calculus and scaling must be done by a hygienist or dentist;

1 7. "Dentistry" means the practice of dentistry in all of its
2 branches;

3 ~~5.~~ 8. "Dentist" means a graduate of an accredited dental
4 college who has been issued a license by the Board to practice
5 dentistry as defined in Section 328.19 of this title;

6 9. "Dental ambulatory surgical center (DASC)" means a facility
7 that operates exclusively for the purpose of furnishing outpatient
8 surgical services to patients. A DASC shall have the same
9 privileges and requirements as a dental office and additionally must
10 be an accredited facility by the appropriate entity;

11 ~~6.~~ 10. "Dental office" means an establishment owned and
12 operated by a dentist for the practice of dentistry, which may be
13 composed of reception rooms, business offices, private offices,
14 laboratories, and dental operating rooms where dental operations are
15 performed;

16 ~~7.~~ 11. "Dental hygienist" means an individual who has fulfilled
17 the educational requirements and is a graduate of an accredited
18 dental hygiene program and who has passed an examination and has
19 been issued a license by the Board and who is authorized to practice
20 dental hygiene as hereinafter defined;

21 ~~8.~~ 12. "Dental assistant or oral maxillofacial surgery
22 assistant" means an individual working for a dentist, under the
23 dentist's direct supervision or direct visual supervision, and
24 performing duties in the dental office or a treatment facility,

1 including the limited treatment of patients in accordance with the
2 provisions of the State Dental Act. A dental assistant or oral
3 maxillofacial surgery assistant may assist a dentist with the
4 patient; provided, this shall be done only under the direct
5 supervision or direct visual supervision and control of the dentist
6 and only in accordance with the educational requirements and rules
7 promulgated by the Board;

8 ~~9.~~ 13. "Dental laboratory" means a location, whether in a
9 dental office or not, where a dentist or a dental laboratory
10 technician performs dental laboratory technology;

11 ~~10.~~ 14. "Dental laboratory technician" means an individual
12 whose name is duly filed in the official records of the Board, which
13 authorizes the technician, upon the laboratory prescription of a
14 dentist, to perform dental laboratory technology, which services
15 must be rendered only to the prescribing dentist and not to the
16 public;

17 ~~11.~~ 15. "Dental laboratory technology" means using materials
18 and mechanical devices for the construction, reproduction or repair
19 of dental restorations, appliances or other devices to be worn in a
20 human mouth;

21 ~~12.~~ 16. "Dental specialty" means a specialized practice of a
22 branch of dentistry, recognized and defined by the American Dental
23 Association and ~~the rules of the Board~~ whose specialty program is
24 accredited by the Commission on Dental Accreditation (CODA);

1 ~~13.~~ 17. "Direct supervision" means the supervisory dentist is
2 in the dental office or treatment facility and, during the
3 appointment, personally examines the patient, diagnoses any
4 conditions to be treated, and authorizes the procedures to be
5 performed by a dental hygienist, dental assistant, or oral
6 maxillofacial surgery assistant, ~~remains.~~ The supervising dentist
7 is continuously on site and physically present in the dental office
8 or treatment facility while the procedures are being performed and,
9 before dismissal of the patient, evaluates the results of the dental
10 treatment;

11 18. "Direct visual supervision" means the supervisory dentist
12 has direct ongoing visual oversight which shall be maintained at all
13 times during any procedure authorized to be performed by a dental
14 assistant or an oral maxillofacial dental assistant;

15 19. "Fellowship" means a program designed for post-residency
16 graduates to gain knowledge and experience in a specialized field;

17 ~~14.~~ 20. "General supervision" means the supervisory dentist has
18 ~~previously~~ diagnosed any conditions to be treated within the past
19 thirteen (13) months, has personally authorized the procedures to be
20 performed by a dental hygienist, and will evaluate the results of
21 the dental treatment within a reasonable time as determined by the
22 nature of the procedures performed, the needs of the patient, and
23 the professional judgment of the supervisory dentist. General
24 supervision may only be used to supervise a hygienist and may not be

1 used to supervise an oral maxillofacial surgical assistant or dental
2 assistant;

3 ~~15.~~ 21. "Indirect supervision" means the supervisory dentist is
4 in the dental office or treatment facility and has personally
5 diagnosed any conditions to be treated, authorizes the procedures to
6 be performed by a dental hygienist, remains in the dental office or
7 treatment facility while the procedures are being performed, and
8 will evaluate the results of the dental treatment within a
9 reasonable time as determined by the nature of the procedures
10 performed, the needs of the patient, and the professional judgment
11 of the supervisory dentist. Indirect supervision may not be used
12 for an oral maxillofacial surgical assistant or a dental assistant;

13 ~~16.~~ 22. "Investigations" means an investigation proceeding,
14 authorized under Sections 328.15A and 328.43a of this title, to
15 investigate alleged violations of the State Dental Act or the rules
16 of the Board;

17 23. "Mobile dental unit means a motor vehicle or trailer that
18 contains dental equipment and is used to provide dental services;

19 ~~17.~~ 24. "Laboratory prescription" means a written description,
20 dated and signed by a dentist, of dental laboratory technology to be
21 performed by a dental laboratory technician;

22 25. "Prophylaxis" means the removal of any and all calcareous
23 deposits, stains, accretions or concretions from the supragingival
24 and subgingival surfaces of human teeth, utilizing instrumentation

1 by scaler or periodontal curette on the crown and root surfaces of
2 human teeth including rotary or power driven instruments. This
3 procedure may only be performed by a dentist or dental hygienist;

4 ~~18.~~ 26. "Out-of-state dental hygienist" means a graduate of an
5 accredited dental hygienist program who holds a license to practice
6 dental hygiene in another state but who is not licensed to practice
7 dental hygiene in this state;

8 ~~19.~~ 27. "Out-of-state dentist" means a graduate of an
9 accredited dental college who holds a license to practice dentistry
10 in another state but who is not licensed to practice dentistry in
11 this state;

12 ~~20.~~ 28. "Patient" or "patient of record" means an individual
13 who has given a medical history and has been examined and accepted
14 ~~for dental care by a dentist~~ for dental care;

15 ~~21.~~ "Retired dentist" means a person that has a current active
16 ~~dental or specialty license but is limited to practicing in a~~
17 ~~volunteer nonpaid capacity;~~

18 29. "Residencies" are programs designed for advanced clinical
19 and didactic training in general dentistry or other specialties or
20 other specialists at the post-doctoral level recognized by the
21 American Dental Association or the Board;

22 ~~22.~~ 30. "Supervision" means direct supervision, direct visual
23 supervision, indirect supervision, or general supervision; and

24 ~~23.~~ 31. "Treatment facility" means:

- 1 a. a federal, tribal, state or local public health
2 facility,
- 3 b. a federal qualified health care facility (FQHC),
4 c. a private health facility,
- 5 ~~e.~~ d. a group home or residential care facility serving the
6 elderly, handicapped or juveniles,
- 7 ~~d.~~ e. a hospital, or dental ambulatory surgical center
8 (DASC),
- 9 ~~e.~~ f. a nursing home,
- 10 ~~f.~~ g. a penal institution operated by or under contract
11 with the federal or state government,
- 12 ~~g.~~ h. a public or private school,
- 13 ~~h.~~ i. a patient of record's private residence,
- 14 ~~i.~~ j. a mobile dental unit,
- 15 ~~j.~~ ~~an accredited dental college,~~
- 16 k. ~~an accredited dental hygiene program, or a dental~~
17 college, dental program, dental hygiene program or
18 dental assisting program accredited by the Commission
19 on Dental Accreditation, or
- 20 l. such other places as are authorized by the rules of
21 the Board.

22 SECTION 3. AMENDATORY 59 O.S. 2011, Section 328.10, is
23 amended to read as follows:
24

1 Section 328.10. A. The Board of Dentistry shall organize
2 annually at the last regularly scheduled meeting of the Board before
3 the beginning of each fiscal year, by electing from among its
4 members a president, a first vice-president, a second vice-
5 president, and a secretary-treasurer. The duties of each officer
6 shall be prescribed in the rules of the Board. The term of office
7 of the persons elected president, vice-presidents and secretary-
8 treasurer shall be for the following fiscal year and until their
9 successors are elected and qualified.

10 B. The Board shall hold regularly scheduled meetings during
11 each quarter of the year at a time and place determined by the Board
12 and may hold such additional regular meetings, special meetings,
13 emergency meetings, or continued or reconvened meetings as found by
14 the Board to be expedient or necessary. A majority of the Board
15 shall constitute a quorum for the transaction of business.

16 ~~C. The Board may appoint an individual to be the principal~~
17 ~~administrative officer of the Board and may confer upon that person~~
18 ~~the title selected by the Board, based upon the person's education,~~
19 ~~background, experience and ability. The principal administrative~~
20 ~~officer shall be responsible for the performance of administrative~~
21 ~~functions delegated by the Board.~~

22 ~~D.~~ The Board shall act in accordance with the provisions of the
23 Oklahoma Open Meeting Act, the Oklahoma Open Records Act and the
24 Administrative Procedures Act.

1 ~~E. All members of the Board and such employees, as determined~~
2 ~~by the Board, shall be bonded as required by Sections 85.26 through~~
3 ~~85.31 of Title 74 of the Oklahoma Statutes.~~

4 ~~F.~~ D. The responsibilities and rights of any member or employee
5 of the Board who acts within the scope of Board duties or employment
6 shall be governed by the Governmental Tort Claims Act.

7 ~~G.~~ E. Members of the Board shall serve without compensation but
8 shall be reimbursed for all actual and necessary expenses incurred
9 in the performance of their duties in accordance with the State
10 Travel Reimbursement Act. Committee members and anesthesia
11 inspectors appointed by the Board may be reimbursed for travel
12 expenses in accordance with the State Travel Reimbursement Act.

13 SECTION 4. AMENDATORY 59 O.S. 2011, Section 328.15, as
14 last amended by Section 3, Chapter 405, O.S.L. 2013 (59 O.S. Supp.
15 2014, Section 328.15), is amended to read as follows:

16 Section 328.15. A. Pursuant to and in compliance with Article
17 I of the Administrative Procedures Act, the Board of Dentistry shall
18 have the power to formulate, adopt, and promulgate rules as may be
19 necessary to regulate the practice of dentistry in this state and to
20 implement and enforce the provisions of the State Dental Act.

21 B. The Board is authorized and empowered to:

22 1. Examine and test the qualifications of applicants for a
23 license or permit to be issued by the Board;

1 2. Affiliate by contract or cooperative agreement with another
2 state or combination of states for the purpose of conducting
3 simultaneous regional examinations of applicants for a license to
4 practice dentistry, dental hygiene, or a dental specialty;

5 3. Maintain a list of the name, current mailing address and
6 principal office address of all persons who hold a license or permit
7 issued by the Board;

8 4. Account for all receipts and expenditures of the monies of
9 the Board, including annually preparing and publishing a statement
10 of receipts and expenditures of the Board for each fiscal year;

11 5. Within limits prescribed in the State Dental Act, set all
12 fees and administrative penalties to be imposed and collected by the
13 Board;

14 6. Employ an Executive Director, legal counsel and other
15 advisors to the Board, including advisory committees;

16 7. Investigate and issue investigative and other subpoenas,
17 pursuant to Article II of the Administrative Procedures Act;

18 8. Initiate individual proceedings and issue orders imposing
19 administrative penalties, pursuant to Article II of the
20 Administrative Procedures Act, against any dentist, dental
21 hygienist, dental assistant, oral maxillofacial surgery assistant,
22 dental laboratory technician, or holder of a permit to operate a
23 dental laboratory who has violated the State Dental Act or the rules
24 of the Board;

1 9. Conduct, in a uniform and reasonable manner, inspections of
2 dental offices and dental laboratories and their business records;

3 10. Establish guidelines for courses of study necessary for
4 dental assistants, oral maxillofacial surgery assistants and, when
5 appropriate, issue permits authorizing dental assistants to perform
6 expanded duties;

7 11. Establish continuing education requirements for dentists,
8 dental hygienists, dental assistants and oral maxillofacial surgery
9 assistants who hold permits issued by the Board;

10 12. Recognize the parameters and standards of care established
11 and approved by the American Dental Association;

12 13. Formulate, adopt, and promulgate rules, pursuant to Article
13 I of the Administrative Procedures Act, as may be necessary to
14 implement and enforce the provisions of the Oklahoma Dental
15 Mediation Act;

16 14. Seek and receive advice and assistance of the Office of the
17 Attorney General of this state;

18 15. Promote the dental health and the education of dental
19 health of the people of this state;

20 16. Inform, educate, and advise all persons who hold a license
21 or permit issued by the Board, or who are otherwise regulated by the
22 Board, regarding the State Dental Act and the rules of the Board;

23

1 17. Affiliate with the American Association of Dental Boards as
2 an active member, pay regular dues, and send members of the Board as
3 delegates to its meetings;

4 18. Enter into contracts;

5 19. Acquire by purchase, lease, gift, solicitation of gift or
6 by any other manner, hold, encumber, and dispose of personal
7 property as is needed, maintain, use and operate or contract for the
8 maintenance, use and operation of or lease of any and all property
9 of any kind, real, personal or mixed or any interest therein unless
10 otherwise provided by the State Dental Act; provided, all contracts
11 for real property shall be subject to the provisions of Section 63
12 of Title 74 of the Oklahoma Statutes;

13 20. Receive or accept the surrender of a license, permit, or
14 certificate granted to any person by the Board as provided in
15 Section ~~328.44a~~ 328.44b of this title; and

16 21. Take all other actions necessary to implement and enforce
17 the State Dental Act.

18 SECTION 5. AMENDATORY 59 O.S. 2011, Section 328.17, is
19 amended to read as follows:

20 Section 328.17. A. 1. The Board of Dentistry shall have ~~power~~
21 ~~to appoint one dental hygienist in an advisory capacity to sit with~~
22 ~~the Board to:~~

23 ~~1. Assist the Board in the administration and enforcement of~~
24 ~~the dental hygienist provisions of the State Dental Act; and~~

1 ~~2. Be present only at a Board meeting when the agenda of the~~

8 that shall meet once per year and other times as needed to study
9 issues affecting the practice of dentistry and the safety of the
10 public and to make recommendations to the Board:

11 a. Dental Practice Committee,

12 b. Anesthesia Committee,

13 c. Specialty Practice Committee,

14 d. Historical and Retirement Committee, and

15 e. Assistants, Dental Labs and Other Auxiliary Personnel

24 dental hygienist's practice under the special volunteer license will

2 and indigent persons in Oklahoma; ~~and~~

3 4. Acknowledgement and documentation that the dentist or dental
4 hygienist will not receive or have the expectation to receive any
5 payment or compensation, either direct or indirect, for any dental
6 services rendered under the special volunteer license; and

7 5. A listing of all locations and dates that the person will be
8 completing volunteer work under the special volunteer license.

9 C. The Board of Dentistry shall have jurisdiction over
10 dentists, dental hygienists, dental assistants, and dental
11 technicians who volunteer their professional services in the state.
12 Dental assistants and dental technicians shall work under the direct
13 supervision of a dentist.

14 D. Dental assistants ~~and dental technicians shall not be~~
15 ~~required to obtain a volunteer license~~ may be issued a volunteer
16 permit at the request of an entity that provides dental services to
17 the needy. Volunteers in a volunteer initiative who are not
18 dentists or dental hygienists shall be named and provided on a list
19 to the Board by the entity hosting the volunteer initiative with any
20 other requirements as set forth by the Board. The Board shall
21 provide written documentation to the host entity designating all
22 persons who may participate in the volunteer initiative, including
23 authorization of the timetable requested by the host entity for
24 granting licensure exemption. Any person working under a volunteer

1 dental assistant permit shall not receive payment or compensation
2 for any services rendered under the volunteer dental assistant
3 permit. Volunteer dental assistant permits shall be limited to
4 specific dates and locations of services to be provided.

5 E. All persons providing care shall do so under the provisions
6 specified in Section 328.1 et seq. of this title or rules
7 promulgated by the Board. Only those functions authorized by law or
8 administrative rule shall be performed by the named person approved
9 by the Board.

10 F. Volunteers shall not use sedation or general anesthesia
11 during volunteer procedures.

12 G. Volunteers shall use a form to be provided by the Board for
13 any patient with clear instructions for any and all follow-up care.

14 H. At any time, the Board shall revoke a volunteer license
15 based on documentation of failure to participate according to state
16 laws or administrative rules.

17 I. A special volunteer license shall be restricted to services
18 provided at the locations listed on the application or for a
19 specific not-for-profit treatment provider group as approved by the
20 Board.

21 SECTION 11. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 328.23b of Title 59, unless
23 there is created a duplication in numbering, reads as follows:

1 A dentist, dental hygienist or dental assistant that has been
2 licensed or permitted in good standing with the Board in excess of
3 twenty (20) years that has reached the age of sixty-five (65), may
4 apply for a retired volunteer dentist, dental hygienist or dental
5 assistant license or permit on a yearly basis to provide volunteer
6 services. There shall be no continuing education requirements. A
7 retired dentist, dental hygienist or dental assistant with a retired
8 volunteer license or permit shall not receive payment either
9 directly or indirectly for work provided.

14 ~~licensure by credentialing to dental hygienists of~~

16 ~~B. Any dental hygienist who is in good standing with the Board~~
17 ~~shall, upon application to the Board and payment of a fee~~
18 ~~established by the rules of the Board, receive a certificate which~~
19 ~~shall attest that the dental hygienist is in good standing with the~~

20 ~~Board.~~ No person shall practice as a dental assistant or oral
21 maxillofacial dental assistant for more than one (1) day in a
22 calendar year without having applied for a permit as a dental
23 assistant or oral maxillofacial surgery assistant from the Board of
24 Dentistry within thirty (30) days of beginning employment.

1 During this time period, the dental assistant shall work under the
2 direct visual supervision of a dentist at all times.

3 B. The application shall be made to the Board in writing and
4 shall be accompanied by the fee established by the Board, together
5 with satisfactory proof that the applicant:

- 6 1. Is of good moral character; and
7 2. Passes a background check with criteria established by the
8 Board.

9 C. There shall be five types of expanded duty permits available
10 for dental assistants upon completion of a program approved by the
11 Commission on Dental Accreditation (CODA) or a course by the Dental
12 Assisting National Board (DANB) that meets the requirements of the
13 board or a course that has been approved by the Board:

- 14 1. Radiation safety;
15 2. Coronal polishing and topical fluoride;
16 3. Sealants;
17 4. Assisting in the administration of nitrous oxide; or
18 5. Assisting in parenteral or pediatric dental anesthesia.

19 D. The training requirements for all five expanded duty permits
20 shall be set forth by the Board. A program that is not CODA-
21 certified must meet the standards set forth and be approved by the
22 board.

23 E. An applicant for a dental assistant permit who has graduated
24 from a dental assisting program accredited by CODA and has passed

1 the jurisprudence test shall receive all five expanded duty permits
2 provided for in subsection C of this section if the course materials
3 approved by the Board are covered in the program.

4 F. A dental assistant that has met the educational
5 prerequisites and passed the Certified Dental Assistant examination
6 including radiation health and safety, infection control and general
7 chairside component established by DANB, shall have a designation of
8 "CDA" on their Dental Assistant Permit. A dental assistant meeting
9 the qualifications of a CDA® set forth by DANB, shall also receive
10 an expanded duty permit for radiation safety. Each certified dental
11 assistant shall provide proof to the Board that they are in current
12 compliance with the requirements set forth by DANB to maintain their
13 CDA upon each yearly renewal of their permit.

2 Board; and

3 3. Has completed all of the training requirements for the oral

5 D. An oral maxillofacial surgery assistant permit shall be
6 considered a temporary training permit until all of the training
7 requirements, as established by the Board for each oral

10 E. A temporary training permit for each oral maxillofacial
11 surgery assistant shall not be extended beyond two (2) years.

13 under direct supervision or direct visual supervision at all times

15 G. If an oral maxillofacial surgery assistant is not currently

17 surgery assistant permit shall automatically revert to a dental

19 may be eligible for an expanded function assisting in parenteral or
20 pediatric anesthesia if they are employed by a dentist with an

22 may be reinstated upon employment under a licensed oral

4 I. An applicant for an oral maxillofacial surgical assistant
5 permit shall provide satisfactory proof of:

6 1. Successful completion of the Dental Anesthesia Assistant
7 National Certification Examination (DAANCE) provided by the American
8 Association of Oral Maxillofacial Surgeons (AAOMS);

9 2. A valid BLS certification;

10 3. Employment and completion of a minimum of six (6) months of
11 training under the direct supervision of a licensed oral
12 maxillofacial surgeon prior to starting DAANCE;

13 4. A standardized course approved by the Board including a
14 minimum of four (4) hours of didactic training that must include;
15 anatomy, intravenous access or phlebotomy, technique; risks and
16 complications, and hands-on experience starting and maintaining
17 intravenous lines on a human or simulator/manikin, and pharmacology;

18 5. Completion of an infection-control course as approved by the
19 Board.

20 J. An oral maxillofacial surgical assistant who has completed
21 all the requirements shall receive a permit to practice as an oral
22 maxillofacial surgical assistant within a dental office, surgery
23 center, dental ambulatory surgical center or hospital.

1 K. Oral maxillofacial surgical assistants shall be required to
2 complete twelve (12) hours of continuing education every three (3)
3 years in classes approved by AAOMS that are certified by the
4 American Dental Association CERP program or another program approved
5 by the Board. The continuing education requirement shall include at
6 least one (1) hour on infection control.

7 L. The anesthesia committee provided pursuant to Section 328.17
8 of this title may make a recommendation to the Board for an oral
9 maxillofacial surgical assistant holding a temporary training permit
10 to substitute training received from another state university,
11 dental school or technical training institute or training acquired
12 in a surgical center or hospital while working under the authority

23 E. The issuance of a dental intern, resident or fellowship
24 permit by the Board shall in no way be considered a guarantee or

1 predetermination of any person to receive a full license issued by

3 F. Dental intern or resident or fellowship permits may be
4 renewed annually at the request of the Dean of the college or
5 program director of the program approved by CODA and at the
6 discretion of the Board.

7 G. Students currently enrolled at the University Of Oklahoma
8 College Of Dentistry or an accredited dental hygiene or dental
9 assisting program shall be exempted from Sections 328.19 and 328.21

22 C. Each applicant shall include a money order or cashier's
23 check made payable to the Oklahoma State Bureau of Investigation or

3 D. The Board shall forward the fingerprint cards, along with
4 the applicable fee for a national fingerprint criminal history
5 records search, to the Bureau.

6 E. The Bureau shall retain one set of fingerprints in the

2 in the trade name or the trade name is included in an advertisement,
3 a copy of the advertisement, including but not limited to any
4 electronic form of the advertising, shall be kept by the dentist or
5 dentists for three (3) years from the first publication date of the
6 advertisement.

7 B. Beginning July 1, 2016, all advertisements for dentistry
8 shall include the name of the dentist or dentists that shall be
9 providing treatment and shall list the type of dental or specialty
10 license on the advertisement.

11 C. The Board of Dentistry shall promulgate rules regulating
12 advertisements in which one dentist or multiple dentists use a trade
13 name.

14 SECTION 19. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 328.31b of Title 59, unless
16 there is created a duplication in numbering, reads as follows:

17 A. Every dental office or treatment facility, whether
18 individual, group or multi-doctor practice operating under a name,
19 trade name or other professional entity shall maintain written
20 records on each patient treated at the facility and shall make these
21 records available to the Board and other regulatory entities or be
22 subject to the penalties as set forth in Section 328.44 of this
23 title.

24

1 B. Each licensed dentist shall maintain written records on each
2 patient that shall contain, at a minimum, the following information
3 about the patient:

4 1. A health history listing known illnesses, other treating
5 physicians, and current medications prescribed;

6 2. Results of clinical examination and tests conducted,
7 including the identification, or lack thereof, of any oral pathology
8 or diseases;

9 3. Treatment plan proposed by the dentist;

10 4. Treatment rendered to the patient. The patient record shall
11 clearly identify the dentist and the dental hygienist providing the
12 treatment with the dentist, specialty or dental hygienist license
13 number;

14 5. Whenever patient records are released or transferred, the
15 dentist releasing or transferring the records shall maintain either
16 the original records or copies thereof and a notation shall be made
17 in the retained records indicating to whom the records were released
18 or transferred; and

19 6. All claims being submitted for insurance must be signed,
20 stamped or have an electronic signature by the treating dentist.

21 C. Patient records may be kept in an electronic data format,
22 provided that the dentist maintains a back-up copy of information
23 stored in the data processing system using disk, tape or other
24 electronic back-up system and that said back-up is updated on a

1 regular basis, at least weekly, to assure that data is not lost due
2 to system failure. Any electronic data system shall be capable of
3 producing a hard copy on demand.

4 D. All patient records shall be maintained for seven (7) years
5 from the date of treatment.

6 E. Each licensed dentist shall retain a copy of each entry in
7 his or her patient appointment book or such other log, calendar,
8 book, file or computer data used in lieu of an appointment book for
9 a period of no less than seven (7) years from the date of each entry
10 thereon.

11 SECTION 20. AMENDATORY 59 O.S. 2011, Section 328.32, as
12 last amended by Section 12, Chapter 405, O.S.L. 2013 (59 O.S. Supp.
13 2014, Section 328.32), is amended to read as follows:

14 Section 328.32. A. The following acts or occurrences by a
15 dentist shall constitute grounds for which the penalties specified
16 in Section 328.44a of this title may be imposed by order of the
17 Board of Dentistry:

18 1. Pleading guilty or nolo contendere to, or being convicted
19 of, a felony, a misdemeanor involving moral turpitude, or a
20 violation of federal or state controlled dangerous substances laws;

7 which a permit from the Board is required;

8 6. Authorizing or aiding a dental hygienist to perform any
9 procedure prohibited by the State Dental Act or the rules of the
10 Board;

11 7. Authorizing or aiding a dental assistant or oral
12 maxillofacial surgery assistant to perform any procedure prohibited
13 by the State Dental Act or the rules of the Board;

14 8. Failing to pay fees as required by the State Dental Act or
15 the rules of the Board;

16 9. Failing to complete continuing education requirements;

17 10. Representing himself or herself to the public as a
18 specialist in a dental specialty without holding a dental specialty
19 license therefor;

20 11. Representing himself or herself to the public as a
21 specialist whose practice is limited to a dental specialty, when
22 such representation is false, fraudulent, or misleading;

1 12. Endangering the health of patients by reason of having a
2 highly communicable disease and continuing to practice dentistry
3 without taking appropriate safeguards;

4 13. Practicing dentistry in an unsafe or unsanitary manner or
5 place, including but not limited to repeated failures to follow
6 Centers for Disease Control (CDC) or Occupational Health Safety
7 Administration (OSHA) guidelines;

8 14. Being shown to be mentally unsound;

9 15. Being shown to be grossly immoral and that such condition
10 represents a threat to patient care or treatment;

11 16. Being incompetent to practice dentistry while delivering
12 care to a patient;

13 17. Committing gross negligence in the practice of dentistry;

14 18. Committing repeated acts of negligence in the practice of
15 dentistry;

16 19. Offering to effect or effecting a division of fees, or
17 agreeing to split or divide a fee for dental services with any
18 person, in exchange for the person bringing or referring a patient;

19 20. Being involuntarily committed to an institution for
20 treatment for substance abuse, until recovery or remission;

21 21. Using or attempting to use the services of a dental
22 laboratory or dental laboratory technician without issuing a
23 laboratory prescription, except as provided in subsection C of
24 Section 328.36 of this title;

1 22. Aiding, abetting, or encouraging a dental hygienist
2 employed by the dentist to make use of an oral prophylaxis list, or
3 the calling by telephone or by use of letters transmitted through
4 the mails to solicit patronage from patients formerly served in the
5 office of any dentist formerly employing such hygienist;

6 23. Having more than the equivalent of three full-time dental
7 hygienists for each dentist actively practicing in the same dental
8 office ~~who will supervise the dental hygienists, dental assistants,~~
9 ~~or oral maxillofacial surgery assistants;~~

10 24. Allowing a person not holding a permit or license issued by
11 the Board to assist in the treatment of a patient without having a
12 license or permit issued by the Board;

13 25. Knowingly patronizing or using the services of a dental
14 laboratory or dental laboratory technician who has not complied with
15 the provisions of the State Dental Act and the rules of the Board;

16 26. Authorizing or aiding a dental hygienist, dental assistant,
17 oral maxillofacial surgery assistant, dental laboratory technician,
18 or holder of a permit to operate a dental laboratory to violate any
19 provision of the State Dental Act or the rules of the Board;

20 27. Willfully disclosing ~~confidential~~ information protected by
21 the Health Information Portability and Accountability Act, P.L. 104-
22 191;

1 28. Writing a false, unnecessary, or excessive prescription for
2 any drug or narcotic which is a controlled dangerous substance under
3 either federal or state law;

4 29. Prescribing or administering any drug or treatment without
5 having established a valid dentist-patient relationship;

6 30. Using or administering nitrous oxide gas in a dental office
7 in an inappropriate or unauthorized manner;

8 31. Engaging in nonconsensual physical contact with a patient
9 which is sexual in nature, or engaging in a verbal communication
10 which is intended to be sexually demeaning to a patient;

11 32. Practicing dentistry without displaying, at the dentist's
12 primary place of practice, the license issued to the dentist by the
13 Board to practice dentistry and the current renewal certificate;

17 the failure to retain records shall not be a violation of the State

21 35. Failing to retain the dentist's copy of any laboratory
22 prescription for at least three (3) years, except that the failure

3 36. Allowing any corporation, organization, group, person, or

7 interfere with the dentist's clinical judgment. Clinical judgment
8 shall include, but not be limited to, such matters as selection of a
9 course of treatment, control of patient records, policies and
10 decisions relating to pricing, credit, refunds, warranties and
11 advertising, and decisions relating to office personnel and hours of
12 practice. Nothing in this paragraph shall be construed to:

- 13 a. limit a patient's right of informed consent, or
- 14 b. to prohibit insurers, preferred provider organizations
15 and managed care plans from operating pursuant to the
16 applicable provisions of the Oklahoma Insurance Code
17 and the Public Health Code;

18 37. Violating the state dental act of another state resulting
19 in a plea of guilty or nolo contendere, conviction or suspension or
20 revocation or other sanction by another state board, of the license
21 of the dentist under the laws of that state;

22 38. Violating or attempting to violate the provisions of the
23 State Dental Act or the rules of the Board, as a principal,
24 accessory or accomplice;

1 39. Failing to comply with the terms and conditions of an order
2 imposing suspension of a license or placement on probation issued
3 pursuant to Section 328.44a of this title; or

4 40. Failing to cooperate during an investigation or providing
5 false information, verbally or in writing, to the Board, the Board's
6 investigator or an agent of the Board.

7 B. The provisions of the State Dental Act shall not be
8 construed to prohibit any dentist from displaying or otherwise
9 advertising that the dentist is also currently licensed, registered,
10 certified, or otherwise credentialed pursuant to the laws of this
11 state or a nationally recognized credentialing board, if authorized
12 by the laws of the state or credentialing board to display or
13 otherwise advertise as a licensed, registered, certified, or
14 credentialed dentist.

15 SECTION 21. AMENDATORY 59 O.S. 2011, Section 328.34, as
16 amended by Section 14, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2014,

16 certificate and upon satisfactory proof of the loss or destruction
17 thereof, the Board may issue a duplicate, charging therefor a fee

20 assistant or dental assistant that is in good standing and not under
21 investigation that notifies the Board in writing of a voluntary

23 activity pursuant to the State Dental Act when needed.

1 F. In the event of a majority of members of the Board being
2 recused from the Board member jury panel, the Board President or
3 presiding administrative judge shall appoint a previous Board member
4 with a current active license in good standing to serve as a jury
5 panel member.

6 G. Any action as set forth in paragraphs 1 through 3 of
7 subsection E of this section shall remain part of the investigation
8 file, and may be disclosed or used against the respondent only if
9 the respondent violates the settlement agreement or if ordered by a

14 ~~G. H.~~ The Board of Dentistry, its employees, independent
15 contractors, appointed committee members and other agents shall keep
16 confidential all information obtained in the following
17 circumstances:

18 1. During an investigation into allegations of violations of
19 the State Dental Act, including but not limited to:

- 20 a. any review or investigation made to determine whether
21 to allow an applicant to take an examination, or
22 b. whether the Board shall grant a license, certificate,
23 or permit;

24 2. In the course of conducting an investigation;

1 3. Reviewing investigative reports provided to the Board by a
2 registrant; and

3 4. Receiving and reviewing examination and test scores.

4 I. The President of the Board or presiding administrative judge
5 shall approve any private settlement agreement.

6 J. The investigative review panel may make a recommendation for
7 an agreed settlement order to be approved by the Board. The agreed
8 settlement order may include any recommendation agreed upon between
9 the license holder including but not limited to any penalty
10 available to the Board pursuant to Section 328.44a of this title.

11 K. A formal complaint issued by the review and investigative
12 panel shall specify the basic factual allegations and the provisions
13 of the State Dental Act, state law or rules that the license or
14 permit holder is alleged to have violated. The formal notice of a
15 complaint shall be served to the license or permit holder either in
16 person, to their attorney, by agreement of the individual, by an
17 investigator of the Board or a formal process server pursuant to
18 Section 2004 of Title 12 of the Oklahoma Statutes.

13 SECTION 24. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 328.43b of Title 59, unless
15 there is created a duplication in numbering, reads as follows:

16 A. In any matter involving a fatality of a dental patient
17 within forty eight (48) hours of receiving anesthesia or that is
18 required to be reported to the Board pursuant to Section 328.55 of
19 Title 59 of the Oklahoma Statutes, such matter shall be investigated
20 by the Adverse Outcomes Review and Investigation Panel.

21 B. The Adverse Outcomes Review and Investigation Panel shall
22 stand in the place of the Board's Review and Investigation Panel
23 pursuant to Section 328.43a of Title 59 of the Oklahoma Statutes
24 during the complaint and review process.

1 C. Upon notification of a fatality to the Board, the President
2 of the Board shall assign four members of the Anesthesia Committee
3 pursuant to Section 328.17 of Title 59 of the Oklahoma Statutes to
4 review and investigate the matter.

5 D. Two of the members shall hold the same license type, whether
6 general or specialty, as the licensee that is the subject of the
7 complaint and two shall hold different types of licenses.

8 E. All other procedures as defined in Section 328.43a of Title
9 59 of the Oklahoma Statutes regarding complaint and Board procedures
10 shall be followed.

11 F. The Board may promulgate rules to implement the provisions
12 of this section.

13 SECTION 25. AMENDATORY 59 O.S. 2011, Section 328.44a, as
14 amended by Section 16, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2014,
15 Section 328.44a), is amended to read as follows:

16 Section 328.44a. A. The Board of Dentistry is authorized,
17 after notice and opportunity for a hearing pursuant to Article II of

5 2. Suspension of a license or permit issued by the Board for a
6 period of time deemed appropriate by the Board;

7 3. Revocation of a license or permit issued by the Board;

8 4. Imposition of an administrative penalty not to exceed One
9 Thousand Five Hundred Dollars (\$1,500.00) per violation;

10 5. Issuance of a censure;

11 6. Placement on probation for a period of time and under such
12 terms and conditions as deemed appropriate by the Board;

13 7. Probation monitoring fees, which shall be the responsibility
14 of the licensee on all probations; or

15 8. Restriction of the services that can be provided by a
16 dentist or dental hygienist, under such terms and conditions as
17 deemed appropriate by the Board; ~~or~~

18 ~~9. Assessment for the cost of the investigation and hearing~~
19 ~~process including attorney fees.~~

20 B. A dentist, dental hygienist, dental assistant, oral
21 maxillofacial surgery assistant, dental laboratory technician, or
22 holder of a permit to operate a dental laboratory, against whom a
23 penalty is imposed by an order of the Board pursuant to the
24 provisions of this section, shall have the right to seek a judicial

1 review of such order pursuant to Article II of the Administrative
2 Procedures Act.

3 SECTION 26. AMENDATORY 59 O.S. 2011, Section 328.62, is
4 amended to read as follows:

5 Section 328.62. As used in the Oklahoma Dental Mediation Act:

6 1. "Board" means the Board of Dentistry;

7 2. "Dentist" means a ~~graduate of an accredited dental college~~
8 person who has been licensed by the Board to practice dentistry, as
9 defined in Section 328.19 of this title; and

10 3. "Mediation committee" means a committee of persons duly
11 constituted of or appointed by ~~any voluntary dental association,~~
12 ~~voluntary dental society, or the Board~~ a statewide organization
13 representing dentists. The Committee shall consist of two (2)
14 members of a statewide organization representing dentists and one
15 former member of the Board not presently serving. The mediation
16 committee is authorized, upon receiving a written request for a
17 review, to conduct a review of the complaints or requests for review
18 of persons, the treatment performed by a dentist and, where
19 appropriate, hold hearings and conduct personal examinations of
20 dental treatment of patients. The mediation committee may, but

10 d. recommend to the parties, a method of settlement, for

12 Any decision by the mediation committee not to review a matter shall
13 be communicated by the committee to the affected persons within
14 thirty (30) days after the committee has received the material
15 submitted pursuant to Section 328.65 of this title.

16 SECTION 27. AMENDATORY 59 O.S. 2011, Section 328.63, is
17 amended to read as follows:

18 Section 328.63. A. A mediation conducted through the Oklahoma
19 Dental Mediation Act shall be voluntary and shall not be construed
20 as a final action for the purposes of injunctive relief or the basis
21 for an appeal to district court. A mediation committee, entities
22 creating such mediation committees, members and staff of such
23 mediation committee, and other persons who assist such mediation
24 committees shall not be liable in any way for damages or injunctive

1 relief under any law of this state with respect to any action taken
2 in good faith by such mediation committee.

3 B. Any person who supplies information to a mediation committee
4 in good faith and with reasonable belief that such information is
5 true shall not be liable in any way for damages or injunctive relief
6 under any law of this state with respect to giving such information
7 to the mediation committee.

8 C. Either party involved in the mediation may request to be
9 dismissed from the process at any time. Upon dismissal from the
10 mediation program, the matter shall be referred back to the
11 referring entity.

12 D. Upon the completion of a successful mediation, the referring
13 entity shall be given notice that the mediation was successful.

14 SECTION 28. This act shall become effective July 1, 2015.

15 SECTION 29. It being immediately necessary for the preservation
16 of the public peace, health and safety, an emergency is hereby
17 declared to exist, by reason whereof this act shall take effect and
18 be in full force from and after its passage and approval.
