16	SECTION 1. AMENDATORY 57 O.S. 2011, Section 571, as
17	amended by Section 1, Chapter 397, O.S.L. 2015 (57 O.S. Supp. 2017,
18	Section 571), is amended to read as follows:
19	Section 571. As used in the Oklahoma Statutes, unless another
20	definition is specified:
21	1. "Capacity" means the actual available bedspace as certified
22	by the State Board of Corrections subject to applicable federal and
23	state laws and the rules and regulations promulgated under such
