- 2. "Concealed handgun firearm" means a loaded or unloaded pistol or handgun firearm not openly visible to the ordinary observation of a reasonable person;
- "Unconcealed handgun firearm" or "open carry" means a loaded 6 or unloaded pistol or handgun firearm that is not held in the hand, 7 but rather is carried upon the person in a holster where the firearm 9 is visible, or carried upon the person using a scabbard, or on a shouldered sling with the firearm located in a general vertical 10 11 position where the barrel of the firearm is safely pointed in an up 12 or down direction, or in a case designed for carrying firearms. The provisions of this paragraph shall not apply while lawfully at a gun 13 range, while lawfully hunting, during an act of self-defense, or 14 otherwise during lawful use of the firearm; and 15
 - 4. "Pistol" or "handgun" shall have the same definition as provided in the Oklahoma Firearms Act of 1971, defined in Section 1289.3 of this title;
 - 5. "Rifle" shall have the same definition as provided in Section 1289.4 of this title; and
