

HOUSE AMENDMENTS TO HOUSE BILL 2465

- 1 On page 1 of the printed bill, line 3, delete “, 807.160”.
- 2 Delete lines 8 through 27.
- 3 On page 2, delete lines 1 through 30.
- 4 In line 31, delete “2” and insert “1”.
- 5 On page 3, line 2, restore “shall” and delete “may”.
- 6 In line 5, restore “shall” and delete “may”.
- 7 In line 8, after the period insert “Verification of proof of address may include, but is not limited
- 8 to, providing a utility bill, a tax return, a record from a financial institution, a proof of insurance
- 9 card or a health benefits card, a selective service card, a mortgage document or a lease agreement.
- 10 The applicant may provide the proof of address by submitting proof in the form of an original doc-
- 11 ument or a copy of a document, use an electronic device to display proof of address, or provide proof
- 12 through the use of a third party address verification system.”.
- 13 In lines 35 through 42, delete the boldfaced material and restore the bracketed material.
- 14 On page 4, delete lines 35 through 45.
- 15 On page 5, delete lines 1 through 14 and insert:
- 16 “**SECTION 2.** ORS 807.066 is amended to read:
- 17 “807.066. (1) **Subject to subsection (2) of this section**, the Department of Transportation
- 18 [*shall*] **may** not issue driving privileges to a person who is under 18 years of age unless [*the*
- 19 *person*]:
- 20 “[*(1)*] **(a) The person** has graduated from high school and provides the department with proof
- 21 of graduation satisfactory to the department;
- 22 “[*(2)*] **(b) The person** has received a General Educational Development (GED) certificate from
- 23 a community college and provides the department with proof of the certificate satisfactory to the
- 24 department; **or**
- 25 “[*(3)*] **(c)** [*Provides the department with a form provided by the department and signed by the*
- 26 *principal, or the designee of the principal, of the secondary school attended by the person that*
- 27 *declares*] **The person’s parent or legal guardian certifies** that the person is:
- 28 “**(A)** Enrolled in a [*secondary*] school of this state, or any other state **or any other country**;
- 29 “[*(4)* *Provides the department with a form provided by the department and signed by the authorized*
- 30 *representative of the community college attended by the person that declares that the person is*]
- 31 “**(B) Enrolled in a community college and making satisfactory progress toward a General**
- 32 **Educational Development (GED) certificate or high school diploma**;
- 33 “[*(5)* *Provides the department with a form provided by the department and signed by the authorized*
- 34 *representative of the community college attended by the person that declares that the person is making*
- 35 *satisfactory progress toward a high school diploma*;]

1 “(6) Provides the department with a form provided by the department and signed by the authorized
2 representative of the education service district or school district having jurisdiction over the area of the
3 person’s residence that declares that the person is]

4 “(C) Being taught by a private teacher, **legal guardian** or parent in compliance with ORS
5 339.035;

6 “[(7) Provides the department with documentation satisfactory to the department that indicates that
7 the person is]

8 “(D) Exempted from school attendance requirements due to circumstances beyond the control
9 of the person; or

10 “[(8) Provides the department with documentation satisfactory to the department that the person
11 is]

12 “(E) Exempt under ORS 339.030 (2) from the requirement to attend school.

13 “(2) **The department may not issue driving privileges to a person who is under 18 years
14 of age and whose driving privileges are suspended under ORS 809.423 (3) for withdrawing
15 from school unless the person:**

16 “(a) **Has graduated from high school and provides the department with proof of gradu-
17 ation satisfactory to the department;**

18 “(b) **Has received a General Educational Development (GED) certificate from a commu-
19 nity college and provides the department with proof of the certificate satisfactory to the
20 department;**

21 “(c) **Provides the department with a form provided by the department and signed by the
22 principal, or the designee of the principal, of the school attended by the person that declares
23 that the person is enrolled in a school of this state, or any other state or any other country;**

24 “(d) **Provides the department with a form provided by the department and signed by the
25 authorized representative of the community college attended by the person that declares
26 that the person is making satisfactory progress toward a General Educational Development
27 (GED) certificate;**

28 “(e) **Provides the department with a form provided by the department and signed by the
29 authorized representative of the community college attended by the person that declares
30 that the person is making satisfactory progress toward a high school diploma;**

31 “(f) **Provides the department with a form provided by the department and signed by the
32 authorized representative of the education service district or school district having jurisdic-
33 tion over the area of the person’s residence that declares that the person is being taught by
34 a private teacher, legal guardian or parent in compliance with ORS 339.035;**

35 “(g) **Provides the department with documentation satisfactory to the department that
36 indicates that the person is exempted from school attendance requirements due to circum-
37 stances beyond the control of the person; or**

38 “(h) **Provides the department with documentation satisfactory to the department that
39 the person is exempt under ORS 339.030 (2) from the requirement to attend school.”.**

40 In line 15, delete “4” and insert “3”.

41 In line 36, delete “5” and insert “4”.

42 On page 6, line 22, delete “6” and insert “5”.

43 On page 7, line 35, delete “7” and insert “6”.

44 In line 43, restore “shall” and delete “may”.

45 In line 45, after the period insert “Verification of proof of address may include, but is not limited

1 to, providing a utility bill, a tax return, a record from a financial institution, a proof of insurance
2 card or a health benefits card, a selective service card, a mortgage document or a lease agreement.
3 The applicant may provide the proof of address by submitting proof in the form of an original doc-
4 ument, a copy of a document or use an electronic device to display proof of address, or provide proof
5 through the use of a third party address verification system.”.

6 On page 8, line 17, delete “8” and insert “7”.

7 In line 26, restore “shall” and delete “may”.

8 In line 28, after the period insert “Verification of proof of address may include, but is not limited
9 to, providing a utility bill, a tax return, a record from a financial institution, a proof of insurance
10 card or a health benefits card, a selective service card, a mortgage document or a lease agreement.
11 The applicant may provide the proof of address by submitting proof in the form of an original doc-
12 ument or a copy of a document, use an electronic device to display proof of address, or provide proof
13 through the use of a third party address verification system.”.

14 In line 45, delete “9” and insert “8”.

15 On page 9, line 25, restore “shall” and delete “may”.

16 In line 28, after the period insert “Verification of proof of address may include, but is not limited
17 to, providing a utility bill, a tax return, a record from a financial institution, a proof of insurance
18 card or a health benefits card, a selective service card, a mortgage document or a lease agreement.
19 The applicant may provide the proof of address by submitting proof in the form of an original doc-
20 ument or a copy of a document, use an electronic device to display proof of address, or provide proof
21 through the use of a third party address verification system.”.

22 In line 32, delete “10” and insert “9”.

23
