1 On page 1 of the printed bill, line 3, after the second comma delete the rest of the line and line
2 4 and insert “743.731, 743.734, 743.736, 743.737, 743.745, 743.748, 743.751, 743.754, 743.766, 743.769,
3 743.818, 743.826, 743.911, 743A.141, 750.003 and 750.055 and section 66, chapter 681, Oregon Laws
4 2013; repealing ORS 743.775; and declaring an emergency.”.

5 Delete lines 6 through 31 and delete pages 2 through 27 and insert:

6 **“SECTION 1. Sections 2 and 3 of this 2015 Act are added to and made a part of the In-**
7 **surance Code.**

8 **“SECTION 2. (1) As used in this section:**

9 **“(a) ‘Carrier’ has the meaning given that term in ORS 743.730.**

10 **“(b) ‘Health benefit plan’ has the meaning given that term in ORS 743.730.**

11 **“(c) ‘Grandfathered health plan’ has the meaning given that term in ORS 743.730.**

12 **“(d) ‘Transitional grandfathered large employer health benefit plan’ means a grandfa-**
13 **thered health plan that is issued or renewed by an employer with 51 to 100 employees.**

14 **“(e) ‘Transitional large employer health benefit plan’ means a health benefit plan, other**
15 **than a grandfathered health plan, that is:**

16 **“(A) Before January 1, 2016, issued to or renewed by an employer with 51 to 100 em-**
17 **ployees on the date the plan is issued or renewed;**

18 **“(B) In effect on December 31, 2015; and**

19 **“(C) According to guidance issued by the United States Department of Health and Human**
20 **Services, the United States Department of Labor or the United States Department of the**
21 **Treasury, consistent with the requirements of:**

22 **“(i) 42 U.S.C. 300gg;**

23 **“(ii) 42 U.S.C. 300gg-1;**

24 **“(iii) 42 U.S.C. 300gg-2;**

25 **“(iv) 42 U.S.C. 300gg-5;**

26 **“(v) 42 U.S.C. 300gg-6; and**

27 **“(vi) 42 U.S.C. 300gg-8.**

28 **“(2) A transitional large employer health benefit plan and a transitional grandfathered**
29 **large employer health benefit plan are not subject to the requirements:**

30 **“(a) In ORS 742.005 (6);**

31 **“(b) In ORS 743.737 (1)(a), (8), (10) and (11); and**

32 **“(c) Imposing limitations on participation and contribution rates contained in ORS**
33 **743.737.**

34 **“(3) A transitional large employer health benefit plan is not subject to ORS 743.737 (3).**

35 **“(4) A transitional large employer health benefit plan is considered discontinued under**

1 **ORS 743.737 when the carrier stops renewing the plan.**

2 **“(5) ORS 743.752 (2) does not apply when a carrier discontinues a group health benefit**
3 **plan on account of the change in the definition of ‘small employer’ from an employer with a**
4 **maximum of 50 employees to an employer with a maximum of 100 employees.**

5 **“(6) The Department of Consumer and Business Services may modify the requirements**
6 **of this section or extend or delay the operative date of this section to the extent necessary**
7 **to comply with guidance described in subsection (1)(e)(C) of this section.**

8 **“SECTION 3. Notwithstanding ORS 743.736, 743.737 and 743.754, a carrier is not required**
9 **to actively market:**

10 **“(1) A health benefit plan sold only to a bona fide association, to groups that are not**
11 **members of the bona fide association;**

12 **“(2) A grandfathered health plan, to a group or individual who is not eligible for coverage**
13 **under the plan;**

14 **“(3) A group health benefit plan, to a group that is not eligible for coverage under the**
15 **plan;**

16 **“(4) A qualified health plan sold only through the health insurance exchange, to an indi-**
17 **vidual or group outside of the exchange; or**

18 **“(5) A policy of group health insurance that may be delivered or issued for delivery in**
19 **this state without the approval of the Director of the Department of Consumer and Business**
20 **Services under ORS 742.003 (1).**

21 **“SECTION 4. ORS 731.146 is amended to read:**

22 **“731.146. (1) ‘Transact insurance’ means one or more of the following acts effected by mail or**
23 **otherwise:**

24 **“(a) Making or proposing to make an insurance contract.**

25 **“(b) Taking or receiving any application for insurance.**

26 **“(c) Receiving or collecting any premium, commission, membership fee, assessment, due or other**
27 **consideration for any insurance or any part thereof.**

28 **“(d) Issuing or delivering policies of insurance.**

29 **“(e) Directly or indirectly acting as an insurance producer for, or otherwise representing or**
30 **aiding on behalf of another, any person in the solicitation, negotiation, procurement or effectuation**
31 **of insurance or renewals thereof, the dissemination of information as to coverage or rates, the for-**
32 **warding of applications, the delivering of policies, the inspection of risks, the fixing of rates, the**
33 **investigation or adjustment of claims or losses, the transaction of matters subsequent to effectuation**
34 **of the policy and arising out of it, or in any other manner representing or assisting a person with**
35 **respect to insurance.**

36 **“(f) Advertising locally or circularizing therein without regard for the source of such**
37 **circularization, whenever such advertising or circularization is for the purpose of solicitation of in-**
38 **surance business.**

39 **“(g) Doing any other kind of business specifically recognized as constituting the doing of an in-**
40 **surance business within the meaning of the Insurance Code.**

41 **“(h) Offering [*individual or small group coverage under a multistate health benefit plan, as defined***
42 ***in ORS 743.730*] a multistate qualified health plan to individuals or small employers through**
43 **the program administered by the United States Office of Personnel Management pursuant**
44 **to 42 U.S.C. 18054.**

45 **“(i) Doing or proposing to do any insurance business in substance equivalent to any of para-**

1 graphs (a) to (h) of this subsection in a manner designed to evade the provisions of the Insurance
2 Code.

3 “(2) Subsection (1) of this section does not include, apply to or affect the following:

4 “(a) Making investments within a state by an insurer not admitted or authorized to do business
5 within such state.

6 “(b) Except as provided in ORS 743.015, doing or proposing to do any insurance business arising
7 out of a policy of group life insurance or a policy of blanket health insurance, if the master policy
8 was validly issued to cover a group organized primarily for purposes other than the procurement
9 of insurance and was delivered in and pursuant to the laws of another state in which:

10 “(A) The insurer was authorized to do an insurance business;

11 “(B) The policyholder is domiciled or otherwise has a bona fide situs; and

12 “(C) With respect to a policy of blanket health insurance, the policy was approved by the di-
13 rector of such state.

14 “(c) Investigating, settling, or litigating claims under policies lawfully written within a state, or
15 liquidating assets and liabilities, all resulting from the insurer’s former authorized operations within
16 such state.

17 “(d) Transactions within a state under a policy subsequent to its issuance if the policy was
18 lawfully solicited, written and delivered outside the state and did not cover a subject of insurance
19 resident, located or to be performed in the state when issued.

20 “(e) The continuation and servicing of life or health insurance policies remaining in force on
21 residents of a state if the insurer has withdrawn from such state and is not transacting new insur-
22 ance therein.

23 “(3) If mail is used, an act shall be deemed to take place at the point where the matter trans-
24 mitted by mail is delivered and takes effect.

25 “**SECTION 5.** ORS 743.106 is amended to read:

26 “743.106. (1) No policy form shall be delivered or issued for delivery in this state unless:

27 “(a) The policy text achieves a score of 40 or more on the Flesch reading ease test, or an
28 equivalent score on any comparable test as provided in subsection (3) of this section;

29 “(b) The policy, except for specification pages, schedules and tables is printed in not less than
30 **12-point type, 13-point leading for health benefit plans, as defined in ORS 743.730, and 10-point**
31 **type, [one point leaded] 11-point leading for all other policies;**

32 “(c) The style, arrangement and overall appearance of the policy give no undue prominence to
33 any portion of the text, including the text of any indorsements or riders; and

34 “(d) The policy contains a table of contents or an index of the principal sections of the policy,
35 if the policy has more than 3,000 words of text printed on three or less pages, or regardless of the
36 number of words if the policy has more than three pages.

37 “(2) For the purposes of this section, a Flesch reading ease test score shall be calculated as
38 follows:

39 “(a) For policy forms containing 10,000 words or less of text, the entire form shall be analyzed.
40 For policy forms containing more than 10,000 words, two 200-word samples per page may be ana-
41 lyzed instead of the entire form. The samples shall be separated by at least 20 printed lines.

42 “(b) The number of words and sentences in the text shall be counted and the total number of
43 words divided by the total number of sentences. The figure obtained shall be multiplied by a factor
44 of 1.015.

45 “(c) The total number of syllables in the text shall be counted and divided by the total number

1 of words. The figure obtained shall be multiplied by a factor of 84.6.

2 “(d) The sum of the figures computed under paragraphs (b) and (c) of this subsection subtracted
3 from 206.835 equals the Flesch reading ease test score for the policy form.

4 “(e) For purposes of paragraphs (b) and (c) of this subsection, the following procedures shall be
5 used:

6 “(A) A contraction, hyphenated word or numbers and letters, when separated by spaces, shall
7 be counted as one word.

8 “(B) A unit of words ending with a period, semicolon or colon shall be counted as a sentence.

9 “(C) A ‘syllable’ means a unit of spoken language consisting of one or more letters of a word
10 as divided by an accepted dictionary. If the dictionary shows two or more equally acceptable pro-
11 nunciations of a word, the pronunciation containing fewer syllables may be used.

12 “(f) As used in this section, ‘text’ includes all written matter except the following:

13 “(A) The name and address of the insurer; the name, number or title of the policy; the table of
14 contents or index; captions and subcaptions; specification pages; schedules or tables; and

15 “(B) Policy language drafted to conform to the requirements of any state or federal law, regu-
16 lation or agency interpretation; policy language required by any collectively bargained agreement;
17 medical terminology; and words that are defined in the policy. However, the insurer shall identify
18 the language or terminology excepted by this subparagraph and shall certify in writing that the
19 language or terminology is entitled to be excepted by this subparagraph.

20 “(3) Any other reading test may be approved by the Director of the Department of Consumer
21 and Business Services as an alternative to the Flesch reading ease test if it is comparable in result
22 to the Flesch reading ease test.

23 “(4) Each policy filing shall be accompanied by a certificate signed by an officer of the insurer
24 stating that the policy meets the minimum required reading ease score on the test used, or stating
25 that the score is lower than the minimum required but should be authorized in accordance with ORS
26 743.107. To confirm the accuracy of a certification, the director may require the submission of fur-
27 ther information.

28 “(5) At the option of the insurer, riders, indorsements, applications and other forms made a part
29 of the policy may be scored as separate forms or as part of the policy with which they may be used.

30 “**SECTION 6.** ORS 743.552 is amended to read:

31 “743.552. The Director of the Department of Consumer and Business Services shall by rule es-
32 tablish guidelines for the coordination of benefits for individual and [*small*] group health insurance,
33 including:

34 “(1) The procedures by which persons insured under the policies are to be made aware of the
35 existence of a coordination of benefits provision;

36 “(2) The benefits which may be subject to such a provision;

37 “(3) The effect of such a provision on the benefits provided;

38 “(4) Establishment of the order of benefit determination; and

39 “(5) Reasonable claim administration procedures to expedite claim payments.

40 “**SECTION 7.** ORS 743.602 is amended to read:

41 “743.602. If a legally separated, divorced or surviving spouse elects continuation of coverage
42 under ORS 743.601 (1) to (6):

43 “(1) The monthly premium for the continuation shall not be greater than the amount that would
44 be charged if the legally separated, divorced or surviving spouse were a current certificate holder
45 of the group plan plus the amount that the group policyholder would contribute toward the premium

1 if the legally separated, divorced or surviving spouse were a certificate holder of the group plan,
2 plus an additional amount not to exceed two percent of the certificate holder and group plan holder
3 contributions, for the costs of administration.

4 “(2) The first premium shall be paid by the legally separated, divorced or surviving spouse
5 within 45 days of the date of the election.

6 “(3) The right to continuation of coverage shall terminate upon the earliest of any of the fol-
7 lowing:

8 “(a) The failure to pay premiums when due, including any grace period allowed by the policy;

9 “(b) The date that the group policy is terminated as to all group members except that if a dif-
10 ferent group policy is made available to group members, the legally separated, divorced or surviving
11 spouse shall be eligible for continuation of coverage as if the original policy had not been termi-
12 nated;

13 “(c) The date on which the legally separated, divorced or surviving spouse becomes insured
14 under any other group health plan;

15 “(d) The date on which the legally separated[,] **or** divorced [*or surviving*] spouse remarries [*and*
16 *becomes covered under another group health plan*]; or

17 “(e) The date on which the legally separated, divorced or surviving spouse becomes eligible for
18 federal Medicare coverage.

19 “**SECTION 8.** ORS 743.730 is amended to read:

20 “743.730. For purposes of ORS 743.730 to 743.773 **and 743.818 and section 3 of this 2015 Act:**

21 “(1) ‘Actuarial certification’ means a written statement by a member of the American Academy
22 of Actuaries or other individual acceptable to the Director of the Department of Consumer and
23 Business Services that a carrier is in compliance with the provisions of ORS 743.736 based upon the
24 person’s examination, including a review of the appropriate records and of the actuarial assumptions
25 and methods used by the carrier in establishing premium rates for small employer health benefit
26 plans.

27 “(2) ‘Affiliate’ of, or person ‘affiliated’ with, a specified person means any carrier who, directly
28 or indirectly through one or more intermediaries, controls or is controlled by or is under common
29 control with a specified person. For purposes of this definition, ‘control’ has the meaning given that
30 term in ORS 732.548.

31 “(3) ‘Affiliation period’ means, under the terms of a group health benefit plan issued by a health
32 care service contractor, a period:

33 “(a) That is applied uniformly and without regard to any health status related factors to an
34 enrollee or late enrollee;

35 “(b) That must expire before any coverage becomes effective under the plan for the enrollee or
36 late enrollee;

37 “(c) During which no premium shall be charged to the enrollee or late enrollee; and

38 “(d) That begins on the enrollee’s or late enrollee’s first date of eligibility for coverage and runs
39 concurrently with any eligibility waiting period under the plan.

40 “(4) ‘Bona fide association’ means an association that:

41 “(a) Has been in active existence for at least five years;

42 “(b) Has been formed and maintained in good faith for purposes other than obtaining insurance;

43 “(c) Does not condition membership in the association on any factor relating to the health status
44 of an individual or the individual’s dependent or employee;

45 “(d) Makes health insurance coverage that is offered through the association available to all

1 members of the association regardless of the health status of the member or individuals who are
2 eligible for coverage through the member;

3 “(e) Does not make health insurance coverage that is offered through the association available
4 other than in connection with a member of the association;

5 “(f) Has a constitution and bylaws; and

6 “(g) Is not owned or controlled by a carrier, producer or affiliate of a carrier or producer.

7 “(5) ‘Carrier’ means any person who provides health benefit plans in this state, including:

8 “(a) A licensed insurance company;

9 “(b) A health care service contractor;

10 “(c) A health maintenance organization;

11 “(d) An association or group of employers that provides benefits by means of a multiple em-
12 ployer welfare arrangement and that:

13 “(A) Is subject to ORS 750.301 to 750.341; or

14 “(B) Is fully insured and otherwise exempt under ORS 750.303 (4) but elects to be governed by
15 ORS 743.733 to 743.737; or

16 “(e) Any other person or corporation responsible for the payment of benefits or provision of
17 services.

18 “(6) ‘Catastrophic plan’ means a health benefit plan that meets the requirements for a cat-
19 astrophic plan under 42 U.S.C. 18022(e) [*and that is offered through the Oregon health insurance*
20 *exchange*].

21 “[7] ‘Creditable coverage’ means prior health care coverage as defined in 42 U.S.C. 300gg as
22 amended and in effect on February 17, 2009, and includes coverage remaining in force at the time the
23 enrollee obtains new coverage.]

24 “[8] (7) ‘Dependent’ means the spouse or child of an eligible employee, subject to applicable
25 terms of the health benefit plan covering the employee.

26 “[9] (8) ‘Eligible employee’ means an employee who [*works on a regularly scheduled basis, with*
27 *a normal work week of 17.5 or more hours. The employer may determine hours worked for eligibility*
28 *between 17.5 and 40 hours per week subject to rules of the carrier. ‘Eligible employee’ does not include*
29 *employees who work on a temporary, seasonal or substitute basis. Employees who have been employed*
30 *by the employer for fewer than 90 days are not eligible employees unless the employer so allows]* **is**
31 **eligible for coverage under a group health benefit plan.**

32 “[10] (9) ‘Employee’ means any individual employed by an employer.

33 “[11] (10) ‘Enrollee’ means an employee, dependent of the employee or an individual otherwise
34 eligible for a group or individual health benefit plan who has enrolled for coverage under the terms
35 of the plan.

36 “[12] (11) ‘Exchange’ means the health insurance exchange administered by the Oregon Health
37 Insurance Exchange Corporation in accordance with ORS 741.310.

38 “[13] (12) ‘Exclusion period’ means a period during which specified treatments or services are
39 excluded from coverage.

40 “[14] (13) ‘Financial impairment’ means that a carrier is not insolvent and is:

41 “(a) Considered by the director to be potentially unable to fulfill its contractual obligations; or

42 “(b) Placed under an order of rehabilitation or conservation by a court of competent jurisdiction.

43 “[15](a) (14)(a) ‘Geographic average rate’ means the arithmetical average of the lowest pre-
44 mium and the corresponding highest premium to be charged by a carrier in a geographic area es-
45 tablished by the director for the carrier’s:

1 “(A) Group health benefit plans offered to small employers; or
2 “(B) Individual health benefit plans.
3 “(b) ‘Geographic average rate’ does not include premium differences that are due to differences
4 in benefit design, age, tobacco use or family composition.
5 “[~~(16)~~] (15) ‘Grandfathered health plan’ has the meaning prescribed by the United States Secre-
6 taries of Labor, Health and Human Services and the Treasury pursuant to 42 U.S.C. 18011(e).
7 “[~~(17)~~] (16) ‘Group eligibility waiting period’ means, with respect to a group health benefit plan,
8 the period of employment or membership with the group that a prospective enrollee must complete
9 before plan coverage begins.
10 “[~~(18)(a)~~] (17)(a) ‘Health benefit plan’ means any:
11 “(A) Hospital expense, medical expense or hospital or medical expense policy or certificate;
12 “(B) Health care service contractor [*or health maintenance organization subscriber contract*] **as**
13 **defined in ORS 750.005**; or
14 “(C) Plan provided by a multiple employer welfare arrangement or by another benefit arrange-
15 ment defined in the federal Employee Retirement Income Security Act of 1974, as amended, to the
16 extent that the plan is subject to state regulation.
17 “(b) ‘Health benefit plan’ does not include:
18 “(A) Coverage for accident only, specific disease or condition only, credit or disability income;
19 “(B) Coverage of Medicare services pursuant to contracts with the federal government;
20 “(C) Medicare supplement insurance policies;
21 “(D) Coverage of TRICARE services pursuant to contracts with the federal government;
22 “(E) Benefits delivered through a flexible spending arrangement established pursuant to section
23 125 of the Internal Revenue Code of 1986, as amended, when the benefits are provided in addition
24 to a group health benefit plan;
25 “(F) Separately offered long term care insurance, including, but not limited to, coverage of
26 nursing home care, home health care and community-based care;
27 “(G) Independent, noncoordinated, hospital-only indemnity insurance or other fixed indemnity
28 insurance;
29 “(H) Short term health insurance policies that are in effect for periods of 12 months or less,
30 including the term of a renewal of the policy;
31 “(I) Dental only coverage;
32 “(J) Vision only coverage;
33 “(K) Stop-loss coverage that meets the requirements of ORS 742.065;
34 “(L) Coverage issued as a supplement to liability insurance;
35 “(M) Insurance arising out of a workers’ compensation or similar law;
36 “(N) Automobile medical payment insurance or insurance under which benefits are payable with
37 or without regard to fault and that is statutorily required to be contained in any liability insurance
38 policy or equivalent self-insurance; or
39 “(O) Any employee welfare benefit plan that is exempt from state regulation because of the
40 federal Employee Retirement Income Security Act of 1974, as amended.
41 “(c) For purposes of this subsection, renewal of a short term health insurance policy includes
42 the issuance of a new short term health insurance policy by an insurer to a policyholder within 60
43 days after the expiration of a policy previously issued by the insurer to the policyholder.
44 “[~~(19)~~] ‘Individual coverage waiting period’ means a period in an individual health benefit plan
45 during which no premiums may be collected and health benefit plan coverage issued is not effective.]

1 “[20] (18) ‘Individual health benefit plan’ means a health benefit plan:
2 “(a) That is issued to an individual policyholder; or
3 “(b) That provides individual coverage through a trust, association or similar group, regardless
4 of the situs of the policy or contract.
5 “[21] (19) ‘Initial enrollment period’ means a period of at least 30 days following commence-
6 ment of the first eligibility period for an individual.
7 “[22] (20) ‘Late enrollee’ means an individual who enrolls in a group health benefit plan sub-
8 sequent to the initial enrollment period during which the individual was eligible for coverage but
9 declined to enroll. However, an eligible individual shall not be considered a late enrollee if:
10 “(a) The individual qualifies for a special enrollment period in accordance with 42 U.S.C. 300gg
11 or as prescribed by rule by the Department of Consumer and Business Services;
12 “(b) The individual applies for coverage during an open enrollment period;
13 “(c) A court issues an order that coverage be provided for a spouse or minor child under an
14 employee’s employer sponsored health benefit plan and request for enrollment is made within 30
15 days after issuance of the court order;
16 “(d) The individual is employed by an employer that offers multiple health benefit plans and the
17 individual elects a different health benefit plan during an open enrollment period; or
18 “(e) The individual’s coverage under Medicaid, Medicare, TRICARE, Indian Health Service or
19 a publicly sponsored or subsidized health plan, including, but not limited to, the medical assistance
20 program under ORS chapter 414, has been involuntarily terminated within 63 days after applying for
21 coverage in a group health benefit plan.
22 “[23] (21) ‘Minimal essential coverage’ has the meaning given that term in section 5000A(f) of
23 the Internal Revenue Code.
24 “[24] (22) ‘Multiple employer welfare arrangement’ means a multiple employer welfare ar-
25 rangement as defined in section 3 of the federal Employee Retirement Income Security Act of 1974,
26 as amended, 29 U.S.C. 1002, that is subject to ORS 750.301 to 750.341.
27 “[25] (23) ‘Preexisting condition exclusion’ means:
28 “(a) Except for a grandfathered health plan, a limitation or exclusion of benefits or a denial of
29 coverage based on a medical condition being present before the effective date of coverage or before
30 the date coverage is denied, whether or not any medical advice, diagnosis, care or treatment was
31 recommended or received for the condition before the date of coverage or denial of coverage.
32 “(b) With respect to a grandfathered health plan, a provision applicable to an enrollee or late
33 enrollee that excludes coverage for services, charges or expenses incurred during a specified period
34 immediately following enrollment for a condition for which medical advice, diagnosis, care or treat-
35 ment was recommended or received during a specified period immediately preceding enrollment. For
36 purposes of this paragraph pregnancy and genetic information do not constitute preexisting condi-
37 tions.
38 “[26] (24) ‘Premium’ includes insurance premiums or other fees charged for a health benefit
39 plan, including the costs of benefits paid or reimbursements made to or on behalf of enrollees cov-
40 ered by the plan.
41 “[27] (25) ‘Rating period’ means the 12-month calendar period for which premium rates estab-
42 lished by a carrier are in effect, as determined by the carrier.
43 “[28] (26) ‘Representative’ does not include an insurance producer or an employee or author-
44 ized representative of an insurance producer or carrier.
45 “[29](a) ‘Small employer’ means an employer that employed an average of at least one but not more

1 *than 50 employees on business days during the preceding calendar year, the majority of whom are*
2 *employed within this state, and that employs at least one eligible employee on the first day of the plan*
3 *year.]*

4 *“(b) Any person that is treated as a single employer under section 414 (b), (c), (m) or (o) of the*
5 *Internal Revenue Code of 1986 shall be treated as one employer for purposes of this subsection.]*

6 *“(c) The determination of whether an employer that was not in existence throughout the preceding*
7 *calendar year is a small employer shall be based on the average number of employees that it is rea-*
8 *sonably expected the employer will employ on business days in the current calendar year.]*

9 **“(27) ‘Small employer’ has the meaning given that term in 42 U.S.C. 18024.**

10 **“SECTION 9.** ORS 743.730, as amended by section 59, chapter 681, Oregon Laws 2013, is
11 amended to read:

12 **“743.730. For purposes of ORS 743.730 to 743.773 and 743.818 and section 3 of this 2015 Act:**

13 **“(1) ‘Actuarial certification’ means a written statement by a member of the American Academy**
14 **of Actuaries or other individual acceptable to the Director of the Department of Consumer and**
15 **Business Services that a carrier is in compliance with the provisions of ORS 743.736 based upon the**
16 **person’s examination, including a review of the appropriate records and of the actuarial assumptions**
17 **and methods used by the carrier in establishing premium rates for small employer health benefit**
18 **plans.**

19 **“(2) ‘Affiliate’ of, or person ‘affiliated’ with, a specified person means any carrier who, directly**
20 **or indirectly through one or more intermediaries, controls or is controlled by or is under common**
21 **control with a specified person. For purposes of this definition, ‘control’ has the meaning given that**
22 **term in ORS 732.548.**

23 **“(3) ‘Affiliation period’ means, under the terms of a group health benefit plan issued by a health**
24 **care service contractor, a period:**

25 **“(a) That is applied uniformly and without regard to any health status related factors to an**
26 **enrollee or late enrollee;**

27 **“(b) That must expire before any coverage becomes effective under the plan for the enrollee or**
28 **late enrollee;**

29 **“(c) During which no premium shall be charged to the enrollee or late enrollee; and**

30 **“(d) That begins on the enrollee’s or late enrollee’s first date of eligibility for coverage and runs**
31 **concurrently with any eligibility waiting period under the plan.**

32 **“(4) ‘Bona fide association’ means an association that:**

33 **“(a) Has been in active existence for at least five years;**

34 **“(b) Has been formed and maintained in good faith for purposes other than obtaining insurance;**

35 **“(c) Does not condition membership in the association on any factor relating to the health status**
36 **of an individual or the individual’s dependent or employee;**

37 **“(d) Makes health insurance coverage that is offered through the association available to all**
38 **members of the association regardless of the health status of the member or individuals who are**
39 **eligible for coverage through the member;**

40 **“(e) Does not make health insurance coverage that is offered through the association available**
41 **other than in connection with a member of the association;**

42 **“(f) Has a constitution and bylaws; and**

43 **“(g) Is not owned or controlled by a carrier, producer or affiliate of a carrier or producer.**

44 **“(5) ‘Carrier’ means any person who provides health benefit plans in this state, including:**

45 **“(a) A licensed insurance company;**

1 “(b) A health care service contractor;
2 “(c) A health maintenance organization;
3 “(d) An association or group of employers that provides benefits by means of a multiple em-
4 ployer welfare arrangement and that:
5 “(A) Is subject to ORS 750.301 to 750.341; or
6 “(B) Is fully insured and otherwise exempt under ORS 750.303 (4) but elects to be governed by
7 ORS 743.733 to 743.737; or
8 “(e) Any other person or corporation responsible for the payment of benefits or provision of
9 services.
10 “(6) ‘Catastrophic plan’ means a health benefit plan that meets the requirements for a cat-
11 astrophic plan under 42 U.S.C. 18022(e) [*and that is offered through the Oregon health insurance*
12 *exchange*].
13 “[(7) ‘Creditable coverage’ means prior health care coverage as defined in 42 U.S.C. 300gg as
14 amended and in effect on February 17, 2009, and includes coverage remaining in force at the time the
15 enrollee obtains new coverage.]
16 “[(8) (7) ‘Dependent’ means the spouse or child of an eligible employee, subject to applicable
17 terms of the health benefit plan covering the employee.
18 “[(9) (8) ‘Eligible employee’ means an employee who [*works on a regularly scheduled basis, with*
19 *a normal work week of 17.5 or more hours. The employer may determine hours worked for eligibility*
20 *between 17.5 and 40 hours per week subject to rules of the carrier. ‘Eligible employee’ does not include*
21 *employees who work on a temporary, seasonal or substitute basis. Employees who have been employed*
22 *by the employer for fewer than 90 days are not eligible employees unless the employer so allows]* **is**
23 **eligible for coverage under a group health benefit plan.**
24 “[(10) (9) ‘Employee’ means any individual employed by an employer.
25 “[(11) (10) ‘Enrollee’ means an employee, dependent of the employee or an individual otherwise
26 eligible for a group or individual health benefit plan who has enrolled for coverage under the terms
27 of the plan.
28 “[(12) (11) ‘Exchange’ means the health insurance exchange administered by the Oregon Health
29 Insurance Exchange Corporation in accordance with ORS 741.310.
30 “[(13) (12) ‘Exclusion period’ means a period during which specified treatments or services are
31 excluded from coverage.
32 “[(14) (13) ‘Financial impairment’ means that a carrier is not insolvent and is:
33 “(a) Considered by the director to be potentially unable to fulfill its contractual obligations; or
34 “(b) Placed under an order of rehabilitation or conservation by a court of competent jurisdiction.
35 “[(15)(a)] (14)(a) ‘Geographic average rate’ means the arithmetical average of the lowest pre-
36 mium and the corresponding highest premium to be charged by a carrier in a geographic area es-
37 tablished by the director for the carrier’s:
38 “(A) Group health benefit plans offered to small employers; or
39 “(B) Individual health benefit plans.
40 “(b) ‘Geographic average rate’ does not include premium differences that are due to differences
41 in benefit design, age, tobacco use or family composition.
42 “[(16) (15) ‘Grandfathered health plan’ has the meaning prescribed by the United States Secre-
43 taries of Labor, Health and Human Services and the Treasury pursuant to 42 U.S.C. 18011(e).
44 “[(17) (16) ‘Group eligibility waiting period’ means, with respect to a group health benefit plan,
45 the period of employment or membership with the group that a prospective enrollee must complete

1 before plan coverage begins.

2 “[18)(a)] (17)(a) ‘Health benefit plan’ means any:

3 “(A) Hospital expense, medical expense or hospital or medical expense policy or certificate;

4 “(B) Health care service contractor [*or health maintenance organization subscriber contract*] **as**
5 **defined in ORS 750.005**; or

6 “(C) Plan provided by a multiple employer welfare arrangement or by another benefit arrange-
7 ment defined in the federal Employee Retirement Income Security Act of 1974, as amended, to the
8 extent that the plan is subject to state regulation.

9 “(b) ‘Health benefit plan’ does not include:

10 “(A) Coverage for accident only, specific disease or condition only, credit or disability income;

11 “(B) Coverage of Medicare services pursuant to contracts with the federal government;

12 “(C) Medicare supplement insurance policies;

13 “(D) Coverage of TRICARE services pursuant to contracts with the federal government;

14 “(E) Benefits delivered through a flexible spending arrangement established pursuant to section
15 125 of the Internal Revenue Code of 1986, as amended, when the benefits are provided in addition
16 to a group health benefit plan;

17 “(F) Separately offered long term care insurance, including, but not limited to, coverage of
18 nursing home care, home health care and community-based care;

19 “(G) Independent, noncoordinated, hospital-only indemnity insurance or other fixed indemnity
20 insurance;

21 “(H) Short term health insurance policies that are in effect for periods of 12 months or less,
22 including the term of a renewal of the policy;

23 “(I) Dental only coverage;

24 “(J) Vision only coverage;

25 “(K) Stop-loss coverage that meets the requirements of ORS 742.065;

26 “(L) Coverage issued as a supplement to liability insurance;

27 “(M) Insurance arising out of a workers’ compensation or similar law;

28 “(N) Automobile medical payment insurance or insurance under which benefits are payable with
29 or without regard to fault and that is statutorily required to be contained in any liability insurance
30 policy or equivalent self-insurance; or

31 “(O) Any employee welfare benefit plan that is exempt from state regulation because of the
32 federal Employee Retirement Income Security Act of 1974, as amended.

33 “(c) For purposes of this subsection, renewal of a short term health insurance policy includes
34 the issuance of a new short term health insurance policy by an insurer to a policyholder within 60
35 days after the expiration of a policy previously issued by the insurer to the policyholder.

36 “[19] *‘Individual coverage waiting period’ means a period in an individual health benefit plan*
37 *during which no premiums may be collected and health benefit plan coverage issued is not effective.*]

38 “[20)] (18) ‘Individual health benefit plan’ means a health benefit plan:

39 “(a) That is issued to an individual policyholder; or

40 “(b) That provides individual coverage through a trust, association or similar group, regardless
41 of the situs of the policy or contract.

5 “(c) A court issues an order that coverage be provided for a spouse or minor child under an
6 employee’s employer sponsored health benefit plan and request for enrollment is made within 30
7 days after issuance of the court order;

8 “(d) The individual is employed by an employer that offers multiple health benefit plans and the
9 individual elects a different health benefit plan during an open enrollment period; or

10 “(e) The individual’s coverage under Medicaid, Medicare, TRICARE, Indian Health Service or
11 a publicly sponsored or subsidized health plan, including, but not limited to, the medical assistance
12 program under ORS chapter 414, has been involuntarily terminated within 63 days after applying for
13 coverage in a group health benefit plan.

14 “[23] (21) ‘Minimal essential coverage’ has the meaning given that term in section 5000A(f) of
15 the Internal Revenue Code.

16 “[24] (22) ‘Multiple employer welfare arrangement’ means a multiple employer welfare ar-
17 rangement as defined in section 3 of the federal Employee Retirement Income Security Act of 1974,
18 as amended, 29 U.S.C. 1002, that is subject to ORS 750.301 to 750.341.

19 “[25] (23) ‘Preexisting condition exclusion’ means:

20 “(a) Except for a grandfathered health plan, a limitation or exclusion of benefits or a denial of
21 coverage based on a medical condition being present before the effective date of coverage or before
22 the date coverage is denied, whether or not any medical advice, diagnosis, care or treatment was
23 recommended or received for the condition before the date of coverage or denial of coverage.

24 “(b) With respect to a grandfathered health plan, a provision applicable to an enrollee or late
25 enrollee that excludes coverage for services, charges or expenses incurred during a specified period
26 immediately following enrollment for a condition for which medical advice, diagnosis, care or treat-
27 ment was recommended or received during a specified period immediately preceding enrollment. For
28 purposes of this paragraph pregnancy and genetic information do not constitute preexisting condi-
29 tions.

30 “[26] (24) ‘Premium’ includes insurance premiums or other fees charged for a health benefit
31 plan, including the costs of benefits paid or reimbursements made to or on behalf of enrollees cov-
32 ered by the plan.

33 “[27] (25) ‘Rating period’ means the 12-month calendar period for which premium rates estab-
34 lished by a carrier are in effect, as determined by the carrier.

35 “[28] (26) ‘Representative’ does not include an insurance producer or an employee or author-
36 ized representative of an insurance producer or carrier.

37 “[29)(a) ‘Small employer’ means an employer that employed an average of at least one but not more
38 than 100 employees on business days during the preceding calendar year, the majority of whom are
39 employed within this state, and that employs at least one eligible employee on the first day of the plan
40 year.]

41 “[b) Any person that is treated as a single employer under section 414 (b), (c), (m) or (o) of the
42 Internal Revenue Code of 1986 shall be treated as one employer for purposes of this subsection.]

43 “[c) The determination of whether an employer that was not in existence throughout the preceding
44 calendar year is a small employer shall be based on the average number of employees that it is rea-
45 sonably expected the employer will employ on business days in the current calendar year.]

1 “(27) ‘Small employer’ has the meaning given that term in 42 U.S.C. 18024 unless other-
2 wise prescribed by the department by rule in accordance with guidance issued by the United
3 States Department of Health and Human Services, the United States Department of Labor
4 or the United States Department of the Treasury.

5 “**SECTION 10.** Section 66, chapter 681, Oregon Laws 2013, is amended to read:

6 “**Sec. 66.** (1)(a) The amendments to ORS 743.730 by section 17, [*of this 2013 Act*] **chapter 681,**
7 **Oregon Laws 2013,** become operative January 2, 2014.

8 “(b) The amendments to ORS 743.730 by section 59, [*of this 2013 Act*] **chapter 681, Oregon**
9 **Laws 2013,** become operative January [2] 1, 2016.

10 “(2) The amendments to ORS 731.146, 743.734 and 743.822 by sections 9, 20 and 31, [*of this 2013*
11 *Act*] **chapter 681, Oregon Laws 2013,** become operative January 2, 2014.

12 “**SECTION 11.** ORS 743.731 is amended to read:

13 “743.731. The purposes of ORS 743.730 to 743.773 and 743.923 are:

14 “(1) To promote the availability of health insurance coverage to groups regardless of their
15 enrollees’ health status or claims experience;

16 “(2) To prevent abusive rating practices;

17 “(3) To require disclosure of rating practices to purchasers of small employer and individual
18 health benefit plans;

19 “(4) To prohibit the use of preexisting condition exclusions except in **individual** grandfathered
20 health plans;

21 “(5) To encourage the availability of individual health benefit plans for individuals who are not
22 enrolled in group health benefit plans;

23 “(6) To improve renewability and continuity of coverage for employers and covered individuals;

24 “(7) To improve the efficiency and fairness of the health insurance marketplace; and

25 “(8) To ensure that health insurance coverage in Oregon satisfies the requirements of the Health

34 “(a) Any portion of the premium or benefits is paid by a small employer or any [*eligible*] em-
35 ployee is reimbursed, whether through wage adjustments or otherwise, by a small employer for any
36 portion of the health benefit plan premium; or

37 “(b) The health benefit plan is treated by the employer or any of the [*eligible*] employees as part

3 or accept applications from:

4 “(A) A small employer if the small employer is not physically located in the carrier’s approved
5 service area;

6 “(B) An employee of a small employer if the employee does not work or reside within the
7 carrier’s approved service areas; or

8 “(C) Small employers located within an area where the carrier reasonably anticipates, and
9 demonstrates to the department, that it will not have the capacity in its network of providers to
10 deliver services adequately to the enrollees of those small employer groups because of its obligations
11 to existing small employer group contract holders and enrollees.

12 “(b) A carrier that does not offer coverage pursuant to paragraph (a)(C) of this subsection may
13 not offer coverage in the applicable service area to new employer groups other than small employers
14 until the carrier resumes enrolling groups of new small employers in the applicable area.

15 “[9)] (8) For purposes of ORS 743.733 to 743.737, except as provided in this subsection, carriers
16 that are affiliated carriers or that are eligible to file a consolidated tax return pursuant to ORS
17 317.715 shall be treated as one carrier and any restrictions or limitations imposed by ORS 743.733
18 to 743.737 apply as if all health benefit plans delivered or issued for delivery to small employers in
19 this state by the affiliated carriers were issued by one carrier. However, any insurance company or
20 health maintenance organization that is an affiliate of a health care service contractor located in
21 this state, or any health maintenance organization located in this state that is an affiliate of an in-
22 surance company or health care service contractor, may treat the health maintenance organization

28 small employers in this state for a period of five years from one of the following dates:

33 “[11) *This section does not require a carrier to actively market, offer, issue or accept applications*
34 *for a grandfathered health plan or from a small employer not eligible for coverage under such a plan*
35 *as provided by the Patient Protection and Affordable Care Act (P.L. 111-148) as amended by the Health*
36 *Care and Education Reconciliation Act (P.L. 111-152).]*

37 “**SECTION 14.** ORS 743.737 is amended to read:

38 “743.737. (1) A health benefit plan issued to a small employer:

39 “(a) Must cover essential health benefits consistent with 42 U.S.C. [300gg-11] **300gg-6.**

40 “(b) May[:]

41 “[A)] require an affiliation period that does not exceed two months for an enrollee or 90 days
42 for a late enrollee[:].

43 “[B) *Impose an exclusion period for specified covered services, as established under ORS 743.745,*
44 *applicable to all individuals enrolling for the first time in the small employer health benefit plan; or]*

45 “[C)] (c) **May** not apply a preexisting condition exclusion to any enrollee.

1 “(2) Late enrollees in a small employer health benefit plan may be subjected to a group eligi-
2 bility waiting period that does not exceed 90 days.

3 “(3) Each small employer health benefit plan shall be renewable with respect to all eligible
4 enrollees at the option of the policyholder, small employer or contract holder unless:

5 “(a) The policyholder, small employer or contract holder fails to pay the required premiums.

6 “(b) The policyholder, small employer or contract holder or, with respect to coverage of indi-
7 vidual enrollees, an enrollee or a representative of an enrollee engages in fraud or makes an in-
8 tentional misrepresentation of a material fact as prohibited by the terms of the plan.

9 “(c) The number of enrollees covered under the plan is less than the number or percentage of
10 enrollees required by participation requirements under the plan.

11 “(d) The small employer fails to comply with the contribution requirements under the health
12 benefit plan.

13 “(e) The carrier discontinues offering or renewing[, *or offering and renewing,*] all of its small
14 employer health benefit plans in this state or in a specified service area within this state. In order
15 to discontinue plans under this paragraph, the carrier:

16 “(A) Must give notice of the decision to the Department of Consumer and Business Services and
17 to all policyholders covered by the plans;

18 “(B) May not cancel coverage under the plans for 180 days after the date of the notice required
19 under subparagraph (A) of this paragraph if coverage is discontinued in the entire state or, except
20 as provided in subparagraph (C) of this paragraph, in a specified service area;

21 “(C) May not cancel coverage under the plans for 90 days after the date of the notice required
22 under subparagraph (A) of this paragraph if coverage is discontinued in a specified service area
23 because of an inability to reach an agreement with the health care providers or organization of
24 health care providers to provide services under the plans within the service area; and

25 “(D) Must discontinue offering or renewing[, *or offering and renewing,*] all health benefit plans
26 issued by the carrier in the small employer market in this state or in the specified service area.

28 specified service area within this state because of an inability to reach an agreement with the health
29 care providers or organization of health care providers to provide services under the plan within the

42 “[*(h) The carrier discontinues renewing or offering and renewing a grandfathered health plan for*
43 *all small employers in this state or in a specified service area within this state, other than a plan dis-*

45 “[*(i)*] (B) With respect to plans that are being discontinued under [*paragraph (g) or (h) of this*

3 “[(A)] (i) Offer in writing, to each small employer covered by the plan, all other health benefit
4 plans that the carrier offers to small employers in the specified service area.

5 “[(B)] (ii) Issue any such plans pursuant to the provisions of ORS 743.733 to 743.737.

10 to discontinue coverage in accordance with procedures specified or approved by the director upon
11 finding that the continuation of the coverage would:

12 “(A) Not be in the best interests of the enrollees; or

13 “(B) Impair the carrier’s ability to meet contractual obligations.

14 “[(k)] (i) In the case of a small employer health benefit plan that delivers covered services
