

A-Engrossed Senate Bill 1008

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires court to include in judgment document age of defendant at time of committing offense if defendant is sentenced to term of incarceration and physical custody of defendant is related to age of defendant at time of committing offense.

Directs Department of Corrections to transfer person sentenced to term of incarceration for offense committed when person was under 18 years of age to physical custody of Oregon Youth Authority even if criminal proceedings were initiated after person attained 18 years of age.

Eliminates mandatory adult prosecution for certain offenses committed when person charged is 15, 16 or 17 years of age at time of offense. Requires juvenile court, upon filing by state of motion requesting waiver hearing, to hold hearing to determine whether person should be prosecuted as adult.

Authorizes juvenile offender charged with offense subject to mandatory minimum sentence, who receives mandatory minimum sentence or other sentence of imprisonment, to be eligible for conditional release hearing after serving at least one-half of sentence imposed.

Provides that person in custody of Oregon Youth Authority for offense committed while person was under 18 years of age, for which person was sentenced to term of imprisonment with projected release date that falls after person attains 25 years of age but before person attains 27 years of age, is eligible for conditional release hearing.

Prohibits person who was under 18 years of age at time of committing offense from being sentenced to life imprisonment without possibility of release or parole.

Requires court to consider certain factors when sentencing person who was under 18 years of age at time of committing offense. Prohibits court from considering age as aggravating factor. Directs court to include in judgment document fact that person is eligible for hearing and release after serving 15 years of sentence of imprisonment.

Establishes process for hearing with State Board of Parole and Post-Prison Supervision for persons who were under 18 years of age at time of committing offense and who have served 15 years of sentence of imprisonment. Authorizes release of person on parole or post-prison supervision if certain findings are made.

Directs Department of Justice to adopt model policies for providing victim notification concerning conditional release and waiver hearings. Directs district attorney victim assistance programs to provide notice to victims in accordance with model policies.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

Relating to juvenile offender sentencing; creating new provisions; amending ORS 137.071, 137.124, 137.705, 137.707, 137.712, 144.185, 161.610, 161.620, 163.105, 163.115, 163.155, 163A.130, 163A.135, 339.317, 339.319, 339.321, 419C.005, 419C.050, 419C.346, 419C.349, 419C.352, 419C.355, 419C.358, 419C.361, 420.011, 420.081 and 420A.203; prescribing an effective date; and providing for criminal sentence reduction that requires approval by a two-thirds majority.

Be It Enacted by the People of the State of Oregon:

CUSTODY OF JUVENILE OFFENDERS

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **SECTION 1.** ORS 137.071 is amended to read:

2 137.071. (1) The judge in a criminal action shall ensure that the creation and filing of a judgment
3 document complies with this section. On appeal, the appellate court may give leave as provided in
4 ORS 19.270 for entry of a judgment document that complies with this section but may not reverse
5 or set aside a judgment, determination or disposition on the sole ground that the judgment document
6 fails to comply with this section.

7 (2) A judgment document in a criminal action must comply with ORS 18.038. In addition, a
8 judgment document in a criminal action must:

9 (a) Indicate whether the defendant was determined to be financially eligible for purposes of ap-
10 pointed counsel in the action.

11 (b) Indicate whether the court appointed counsel for the defendant in the action.

12 (c) If there is no attorney for the defendant, indicate whether the defendant knowingly waived
13 any right to an attorney after having been informed of that right.

14 (d) Include the identity of the recorder or reporter for the proceeding or action who is to be
15 served under ORS 138.081.

16 (e) Include any information specifically required by statute or by court rule.

17 (f) Specify clearly the court's determination for each charge in the information, indictment or
18 complaint.

19 (g) Specify clearly the court's disposition, including all legal consequences the court establishes
20 or imposes. If the determination is one of conviction, the judgment document must include any sus-
21 pension of sentence, forfeiture, imprisonment, cancellation of license, removal from office, monetary
22 obligation, probation, conditions of probation, discharge, restitution, community service and all other
23 sentences and legal consequences imposed by the court. Nothing in this paragraph requires the
24 judgment document to specify any consequences that may result from the determination but are not
25 established or imposed by the court.

26 (h) Include the identities of the attorney for the state and the attorney, if any, for the defendant.

27 **(i) If the court sentences the defendant to a term of incarceration, and the physical**
28 **custody of the defendant as determined by ORS 137.124 is related to the age of the defendant**
29 **at the time of committing an offense, indicate the age of the defendant at the time of com-**
30 **mitting the offense.**

31 (3) A judgment document in a criminal action that includes a money award, as defined in ORS
32 18.005, must comply with ORS 18.048.

33 (4) The requirements of this section do not apply to a judgment document if the action was
34 commenced by the issuance of a uniform citation adopted under ORS 1.525 and the court has used
35 the space on the citation for the entry of a judgment. The exemption provided by this subsection
36 does not apply if any indictment, information or complaint other than a uniform citation is filed in
37 the action.

38 **(5) For the purposes of determining the defendant's age at the time of committing an**
39 **offense under subsection (2) of this section:**

40 **(a) If the defendant is convicted of two or more offenses occurring on different days, the**
41 **defendant's age shall be calculated using the earliest date.**

42 **(b) If the defendant is convicted of an offense occurring within a range of dates, the**
43 **defendant's age shall be calculated using the date at the beginning of the range.**

44 **SECTION 2.** ORS 137.124 is amended to read:

45 137.124. (1) If the court imposes a sentence upon conviction of a felony that includes a term of

1 incarceration that exceeds 12 months:

2 (a) The court shall not designate the correctional facility in which the defendant is to be con-
3 fined but shall commit the defendant to the legal and physical custody of the Department of Cor-
4 rections; and

5 (b) If the judgment provides that the term of incarceration be served consecutively to a term
6 of incarceration of 12 months or less that was imposed in a previous proceeding by a court of this
7 state upon conviction of a felony, the defendant shall serve any remaining part of the previously
8 imposed term of incarceration in the legal and physical custody of the Department of Corrections.

9 (2)(a) If the court imposes a sentence upon conviction of a felony that includes a term of
10 incarceration that is 12 months or less, the court shall commit the defendant to the legal and
11 physical custody of the supervisory authority of the county in which the crime of conviction oc-
12 curred.

13 (b) Notwithstanding paragraph (a) of this subsection, when the court imposes a sentence upon
14 conviction of a felony that includes a term of incarceration that is 12 months or less, the court shall
15 commit the defendant to the legal and physical custody of the Department of Corrections if the court
16 orders that the term of incarceration be served consecutively to a term of incarceration that ex-
17 ceeds 12 months that was imposed in a previous proceeding or in the same proceeding by a court
18 of this state upon conviction of a felony.

19 (3) After assuming custody of the convicted person the Department of Corrections may transfer
20 inmates from one correctional facility to another such facility for the purposes of diagnosis and
21 study, rehabilitation and treatment, as best seems to fit the needs of the inmate and for the pro-
22 tection and welfare of the community and the inmate.

23 (4) If the court imposes a sentence of imprisonment upon conviction of a misdemeanor, it shall
24 commit the defendant to the custody of the supervisory authority of the county in which the crime
25 of conviction occurred.

26 (5)(a) When a person under 18 years of age at the time of committing the offense and under 20
27 years of age at the time of sentencing is committed to the Department of Corrections under ORS
28 **137.707 or due to the fact that criminal proceedings were initiated after the person attained**
29 **18 years of age**, the Department of Corrections shall transfer the physical custody of the person to
30 the Oregon Youth Authority as provided in ORS 420.011 if:

31 (A) The person will complete the sentence imposed before the person attains 25 years of age;

32 (B) The Department of Corrections and the Oregon Youth Authority determine that, because of
33 the person's age, immaturity, mental or emotional condition or risk of physical harm to the person,
34 the person should not be incarcerated initially in a Department of Corrections institution; or

35 (C) The person is under 18 years of age at the time of sentencing and commitment.

36 (b) A person placed in the custody of the Oregon Youth Authority under this subsection who is
37 at least 18 years of age shall be returned to the physical custody of the Department of Corrections
38 whenever the Director of the Oregon Youth Authority, after consultation with the Department of
39 Corrections, determines that the conditions or circumstances that warranted the transfer of custody
40 under this subsection are no longer present.

41 (c) Notwithstanding ORS 137.320, the sheriff may by agreement with the Department of Cor-
42 rections transfer the person described in this subsection directly to a youth correction facility for
43 physical custody without first delivering the person to the Department of Corrections. As part of the
44 agreement with the Department of Corrections, the sheriff may designate the county juvenile de-
45 partment or the Oregon Youth Authority to conduct the direct transfer described in this paragraph

1 if the sheriff has entered into a written agreement with the county juvenile department, the Oregon
2 Youth Authority, or both, to provide the direct transfer.

3 (6)(a) When a person under 18 years of age at the time of committing the offense and under 20
4 years of age at the time of sentencing is committed to the legal and physical custody of the De-
5 partment of Corrections or the supervisory authority of a county following waiver under ORS
6 419C.349 (1)(b), 419C.352, 419C.364 or 419C.370 or sentencing under ORS 137.707 (5)(b)(A) or (7)(b)
7 or 137.712, the Department of Corrections or the supervisory authority of a county shall transfer the
8 person to the physical custody of the Oregon Youth Authority for placement as provided in ORS
9 420.011 (3). The terms and conditions of the person's incarceration and custody are governed by ORS
10 420A.200 to 420A.206. Notwithstanding ORS 137.320, the sheriff may by agreement with the Depart-
11 ment of Corrections or the supervisory authority of a county transfer the person described in this
12 subsection directly to a youth correction facility for physical custody without first delivering the
13 person to the Department of Corrections or supervisory authority of the county. As part of the
14 agreement with the Department of Corrections or supervisory authority of the county, the sheriff
15 may designate the county juvenile department or the Oregon Youth Authority to conduct the direct
16 transfer described in this paragraph if the sheriff has entered into a written agreement with the
17 county juvenile department, the Oregon Youth Authority, or both, to provide the direct transfer.

18 (b) Notwithstanding ORS 137.320, when a person under 16 years of age is waived under ORS
19 419C.349 (1)(b), 419C.352, 419C.364 or 419C.370 and subsequently is sentenced to a term of
20 imprisonment in the county jail, the sheriff shall transfer the person to a youth correction facility
21 for physical custody as provided in ORS 420.011 (3).

22 *[(7) If the Director of the Oregon Youth Authority concurs in the decision, the Department of*
23 *Corrections or the supervisory authority of a county shall transfer the physical custody of a person*
24 *committed to the Department of Corrections or the supervisory authority of the county under subsection*
25 *(1) or (2) of this section to the Oregon Youth Authority as provided in ORS 420.011 (2) if:]*

26 *[(a) The person was at least 18 years of age but under 20 years of age at the time of committing*
27 *the felony for which the person is being sentenced to a term of incarceration;]*

28 *[(b) The person is under 20 years of age at the time of commitment to the Department of Corrections*
29 *or the supervisory authority of the county;]*

30 *[(c) The person has not been committed previously to the legal and physical custody of the De-*
31 *partment of Corrections or the supervisory authority of a county;]*

32 *[(d) The person has not been convicted and sentenced to a term of incarceration for the commission*
33 *of a felony in any other state;]*

34 *[(e) The person will complete the term of incarceration imposed before the person attains 25 years*
35 *of age;]*

36 *[(f) The person is likely in the foreseeable future to benefit from the rehabilitative and treatment*
37 *programs administered by the Oregon Youth Authority;]*

38 *[(g) The person does not pose a substantial danger to Oregon Youth Authority staff or persons in*
39 *the custody of the Oregon Youth Authority; and]*

40 *[(h) At the time of the proposed transfer, no more than 50 persons are in the physical custody of*
41 *the Oregon Youth Authority under this subsection.]*

42 **[(8)] (7)** Notwithstanding the provisions of *[subsections]* **subsection** (5)(a)(A) *[or (7)]* of this sec-
43 tion, the department or the supervisory authority of a county may not transfer the physical custody
44 of the person under subsection (5)(a)(A) *[or (7)]* of this section if the Director of the Oregon Youth
45 Authority, after consultation with the Department of Corrections or the supervisory authority of a

1 county, determines that, because of the person's age, mental or emotional condition or risk of
2 physical harm to other persons, the person should not be incarcerated in a youth correction facility.

3 [(9)] (8) Notwithstanding any other provision of this section, under no circumstances may a
4 person under 18 years of age be incarcerated in a Department of Corrections institution.

5 (9) If a defendant is transferred under subsection (5) of this section, the defendant shall
6 also be transferred after a resentencing on the same charges resulting from an appellate
7 decision or a post-conviction relief proceeding or for any other reason, even if the defendant
8 is 20 years of age or older at the time of the resentencing.

9 (10) For the purposes of determining the person's age at the time of committing an of-
10 fense under this section:

11 (a) If the person is convicted of two or more offenses occurring on different days, the
12 person's age shall be calculated using the earliest date.

13 (b) If the person is convicted of an offense occurring within a range of dates, the person's
14 age shall be calculated using the date at the beginning of the range.

15 **SECTION 3.** ORS 420.011 is amended to read:

16 420.011. (1) Except as provided in subsections (2) and (3) of this section, admissions to the youth
17 correction facilities are limited to youth offenders who are at least 12 but less than 19 years of age,
18 found by the juvenile court to have committed an act that if committed by an adult would constitute
19 aggravated murder, murder, a felony or a Class A misdemeanor and placed in the legal custody of
20 the Oregon Youth Authority. A youth offender admitted to a youth correction facility may not be
21 transferred by administrative process to any penal or correctional institution.

22 (2)(a) In addition to the persons placed in the legal custody of the youth authority under ORS
23 419C.478 (1) or 419C.481, and with the concurrence of the Director of the Oregon Youth Authority
24 or the director's designee, persons who are committed to the Department of Corrections under ORS
25 137.124 and meet the requirements of ORS 137.124 (5) [or (7)] may be temporarily assigned to a youth
26 correction facility as provided by ORS 137.124 (5) [or (7)]. A person assigned on such a temporary
27 basis remains within the legal custody of the Department of Corrections and such reassignment is
28 subject to termination by the Director of the Oregon Youth Authority by referring the person back
29 to the Department of Corrections as provided in paragraph (b) of this subsection.

30 (b) After a person is transferred to the physical custody of the youth authority under ORS
31 137.124 (5) [or (7)], the Director of the Oregon Youth Authority may refer the person back to the
32 Department of Corrections for physical custody and placement if the director, after consulting with
33 the Department of Corrections, determines that the person is at least 18 years of age and:

34 (A) Poses a substantial danger to youth authority staff or persons in the custody of the youth
35 authority; or

36 (B) Is not likely, in the foreseeable future, to benefit from the rehabilitation and treatment pro-
37 grams administered by the youth authority and is appropriate for placement in a Department of
38 Corrections institution.

39 (3) Any person under 18 years of age at the time of committing the crime and under 20 years
40 of age at the time of sentencing and commitment who, after waiver under ORS 419C.349 (1)(b),
41 419C.352, 419C.364 or 419C.370 or sentencing under ORS 137.707 (5)(b)(A) or (7)(b) or 137.712, is
42 sentenced to a term of imprisonment in the custody of the Department of Corrections, and any per-
43 son under 16 years of age who after waiver under ORS 419C.349 (1)(b), 419C.352, 419C.364 or
44 419C.370 or sentencing under ORS 137.707 (5)(b)(A) or (7)(b) or 137.712 is sentenced to a term of
45 imprisonment in the county jail, shall be temporarily assigned to a youth correction facility by the

1 Department of Corrections, or by the sheriff to whose custody the person has been committed, pur-
2 suant to ORS 137.124 (6). The director shall designate the appropriate youth correction facility or
3 schools for such assignment. A person assigned to a youth correction facility under ORS 137.124 (6)
4 and this subsection remains within the legal custody of the Department of Corrections or sheriff to
5 whose custody the person was committed. The assignment of such a person to the youth correction
6 facility is subject, when the person is 18 years of age or older, to termination by the director by
7 referring the person back to the Department of Corrections or the sheriff to serve the balance of
8 the person's sentence. Assignment to a youth correction facility pursuant to ORS 137.124 (6) and this
9 subsection, if not terminated earlier by the director, shall terminate upon the person's attaining the
10 age specified in ORS 420A.010 (5) setting the age limits for which the Oregon Youth Authority may
11 retain legal and physical custody of the person, and the person shall be referred to the Department
12 of Corrections or the sheriff having legal custody of the person to serve the balance of the person's
13 sentence.

14 (4) Whenever a person committed to the custody of the Department of Corrections is temporarily
15 assigned to a youth correction facility pursuant to this section, the youth authority may provide
16 programs and treatment for the person, and may adopt rules relating to conditions of confinement
17 at the youth correction facility, as the youth authority determines are appropriate. However, the
18 person remains subject to laws and rules of the State Board of Parole and Post-Prison Supervision
19 relating to parole.

20 **(5) For the purposes of determining the person's age at the time of committing an of-**
21 **fense under this section:**

22 **(a) If the person is convicted of two or more offenses occurring on different days, the**
23 **person's age shall be calculated using the earliest date.**

29 **SECTION 4.** ORS 137.705 is amended to read:

30 137.705. (1)(a) As used in this section and ORS 137.707:

31 (A) "Charged" means the filing of an accusatory instrument in a court of criminal jurisdiction
32 [*alleging the commission of an offense listed in ORS 137.707*].

33 (B) "Detention facility" has the meaning given that term in ORS 419A.004.

34 (C) "Prosecuted" includes pretrial and trial procedures, requirements and limitations provided
35 for in criminal cases.

36 (b) Unless otherwise provided in ORS 137.707, ORS chapters 137 and 138 apply to proceedings
37 under ORS 137.707.

38 [(2)(a) *Notwithstanding ORS 419B.100 and 419C.005, a person 15, 16 or 17 years of age at the time*
39 *of committing the offense may be charged with the commission of an offense listed in ORS 137.707 and*
40 *may be prosecuted as an adult.*]

41 [(b) *The district attorney shall notify the juvenile court and the juvenile department when a person*
42 *under 18 years of age is charged with an offense listed in ORS 137.707.*]

43 [(c) *The filing of an accusatory instrument in a criminal court under ORS 137.707 divests the ju-*
44 *venile court of jurisdiction in the matter if juvenile court jurisdiction is based on the conduct alleged*
45 *in the accusatory instrument or any conduct arising out of the same act or transaction. Upon receiving*

1 notice from the district attorney under paragraph (b) of this subsection, the juvenile court shall dismiss,
 2 without prejudice, the juvenile court proceeding and enter any order necessary to transfer the matter
 3 or transport the person to the criminal court for further proceedings. Nothing in this paragraph affects
 4 the authority or jurisdiction of the juvenile court with respect to other matters or conduct.]

5 [(3)(a)] **(2)(a)** [A person charged with a crime under ORS 137.707 who is 16 or 17 years of age
 6 shall] **If the juvenile court enters an order of waiver under ORS 419C.349 (1)(a), the person**
 7 **waived may be charged with the commission of an offense listed in ORS 137.707 and may be**
 8 **prosecuted as an adult. The person may** be detained in custody **only** in a detention facility, un-
 9 less the **person is 16 or 17 years of age and the** director of the county juvenile department and
 10 the sheriff agree to detain the person in a jail or other place where adults are detained. A person
 11 detained in accordance with this paragraph is subject to release on the same terms and conditions
 12 as for adults.

 20 1, 1995, or when a person charged with an offense listed in subsection (4)(b) of this section is 15, 16
 21 or 17 years of age at the time the offense is committed, and the offense is committed on or after October

 31 presumptive term of imprisonment provided for the offense in subsection (4) of this section. The
 32 court may impose a greater presumptive term if otherwise permitted by law, but may not impose a
 33 lesser term. The person is not, during the service of the term of imprisonment, eligible for release
 34 on post-prison supervision or any form of temporary leave from custody. The person is not eligible
 35 for any reduction in[, or based on,] the minimum sentence for any reason under ORS 421.121 or any
 36 other provision of law. **The person is eligible for a hearing and conditional release under ORS**

4 (2) In determining the appropriate sentence for a person who was under 18 years of age
5 at the time of committing the offense, if the court is provided information concerning the
6 following circumstances, or any other relevant circumstances, the court shall consider those
7 circumstances in imposing the sentence:

8 (a) The person's age, intellectual capacity and impetuousness at the time of the offense.

9 (b) The person's family and community environment, history of trauma and prior in-
10 volvement in the juvenile dependency system at the time of the offense.

11 (c) The person's ability at the time of the offense to appreciate the risks and conse-
12 quences of the conduct constituting the offense.

13 (d) The person's community involvement prior to the offense.

14 (e) Any peer or familial pressure to which the person was subjected at the time of the
15 offense.

16 (f) Whether and to what extent an adult was involved in the commission of the offense.

17 (g) The person's capacity for rehabilitation.

18 (h) The person's school records and special education evaluations.

19 (i) Any other mitigating factors or circumstances presented by the person.

20 (3)(a) If the court is provided with a report of a mental health evaluation of the person,
21 the court shall give the evaluation substantial weight in imposing the sentence if:

22 (A) The evaluation was conducted by a psychiatrist or psychologist whose primary prac-
23 tice involves the treatment of adolescents; and

24 (B) The report includes the assessment of the person's degree of insight, judgment,
25 self-awareness, emotional regulation and impulse control.

26 (b) Paragraph (a) of this subsection does not constitute a requirement that a person ob-
27 tain or submit an evaluation for sentencing.

28 (4) When sentencing a person who was under 18 years of age at the time of committing

32 **(7) If the board finds that, based on the consideration of the age and immaturity of the**
33 **person at the time of the offense and the person's behavior thereafter, the person has dem-**
34 **onstrated maturity and rehabilitation, the board shall release the person as follows:**
