SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Provides that certification of person employed by State Board of Parole and Post-Prison Supervision does not lapse if person meets certain requirements.]

Adds officer who is certified as parole and probation officer and is employed full-time by State Board of Parole and Post-Prison Supervision to definition of "parole and probation officer."

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to employees of the State Board of Parole and Post-Prison Supervision; amending ORS
3 181A.355; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 181A.355 is amended to read:

6 181A.355. As used in ORS 181A.355 to 181A.670, unless the context requires otherwise:

7 (1) "Abuse" has the meaning given that term in ORS 107.705.

8 (2) "Board" means the Board on Public Safety Standards and Training appointed pursuant to
9 ORS 181A.360.

10 (3) "Certified reserve officer" means a reserve officer who has been designated by a local law
11 enforcement unit, has received training necessary for certification and has met the minimum stan-
12 dards and training requirements established under ORS 181A.410.

13 (4) "Commissioned" means being authorized to perform various acts or duties of a police officer,
14 certified reserve officer or reserve officer and acting under the supervision and responsibility of a
15 county sheriff or as otherwise provided by law.

16 (5) "Corrections officer" means an officer or member employed full-time by a law enforcement
17 unit who:

18 (a) Is charged with and primarily performs the duty of custody, control or supervision of indi-
19 viduals convicted of or arrested for a criminal offense and confined in a place of incarceration or
20 detention other than a place used exclusively for incarceration or detention of juveniles; or

21 (b) Has been certified as a corrections officer described in paragraph (a) of this subsection and
22 has supervisory or management authority for corrections officers described in paragraph (a) of this
23 subsection.

24 (6) "Department" means the Department of Public Safety Standards and Training.

(7) "Director" means the Director of the Department of Public Safety Standards and Training.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (8) "Domestic violence" means abuse between family or household members.

2 (9) "Emergency medical dispatcher" means a person who has responsibility to process requests
3 for medical assistance from the public or to dispatch medical care providers.

4 (10) "Family or household members" has the meaning given that term in ORS 107.705.

5 (11) "Fire service professional" means a paid or volunteer firefighter, an officer or a member
6 of a public or private fire protection agency that is engaged primarily in fire investigation, fire
7 prevention, fire safety, fire control or fire suppression or providing emergency medical services, light
8 and heavy rescue services, search and rescue services or hazardous materials incident response.
9 "Fire service professional" does not mean forest fire protection agency personnel.

10 (12) "Law enforcement unit" means:

11 (a) A police force or organization of the state, a city, university that has established a police
12 department under ORS 352.121 or 353.125, port, school district, mass transit district, county, county
13 service district authorized to provide law enforcement services under ORS 451.010, tribal govern-
14 ment as defined in ORS 181A.680 that employs authorized tribal police officers as defined in ORS
15 181A.680, the Criminal Justice Division of the Department of Justice, the Department of Corrections,
16 the Oregon State Lottery Commission, the Security and Emergency Preparedness Office of the Ju-
17 dicial Department or common carrier railroad the primary duty of which, as prescribed by law, or-
18 dinance or directive, is one or more of the following:

19 (A) Detecting crime and enforcing the criminal laws of this state or laws or ordinances relating
20 to airport security;

21 (B) The custody, control or supervision of individuals convicted of or arrested for a criminal
22 offense and confined to a place of incarceration or detention other than a place used exclusively for
23 incarceration or detention of juveniles; or

24 (C) The control, supervision and reformation of adult offenders placed on parole or sentenced
25 to probation and investigation of adult offenders on parole or probation or being considered for
26 parole or probation;

27 (b) A police force or organization of a private entity with a population of more than 1,000 resi-
28 dents in an unincorporated area the employees of which are commissioned by a county sheriff;

29 (c) A district attorney's office;

30 (d) The Oregon Liquor Control Commission with regard to regulatory specialists; or

31 (e) A humane investigation agency as defined in ORS 181A.340.

32 (13) "Parole and probation officer" means:

33 (a) An officer who is employed full-time by the Department of Corrections, a county or a court
34 and who is charged with and performs the duty of:

35 (A) Community protection by controlling, investigating, supervising and providing or making
36 referrals to reformatory services for adult parolees or probationers or offenders on post-prison
37 supervision; or

38 (B) Investigating adult offenders on parole or probation or being considered for parole or pro-
39 bation; [or]

40 (b) An officer who:

41 (A) Is certified and has been employed as a full-time parole and probation officer for more than
42 one year;

43 (B) Is employed part-time by the Department of Corrections, a county or a court; and

44 (C) Is charged with and performs the duty of:

45 (i) Community protection by controlling, investigating, supervising and providing or making re-

1 ferrals to reformative services for adult parolees or probationers or offenders on post-prison super-
2 vision; or

3 (ii) Investigating adult offenders on parole or probation or being considered for parole or pro-
4 bation; **or**

5 **(c) An officer who is certified as a parole and probation officer and is employed full-time**
6 **by the State Board of Parole and Post-Prison Supervision.**

7 (14) "Police officer" means:

8 (a) An officer, member or employee of a law enforcement unit employed full-time as a peace of-
9 ficer who is:

10 (A) Commissioned by a city, port, school district, mass transit district, county, county service
11 district authorized to provide law enforcement services under ORS 451.010, tribal government as
12 defined in ORS 181A.680, the Criminal Justice Division of the Department of Justice, the Oregon
13 State Lottery Commission, a university that has established a police department under ORS 352.121
14 or 353.125, the Governor or the Department of State Police; and

15 (B) Responsible for enforcing the criminal laws of this state or laws or ordinances relating to
16 airport security;

17 (b) An investigator of a district attorney's office if the investigator is or has been certified as
18 a peace officer in this or another state;

19 (c) A humane special agent commissioned under ORS 181A.340;

20 (d) A judicial marshal appointed under ORS 1.177 who is trained pursuant to ORS 181A.540; or

21 (e) An authorized tribal police officer as defined in ORS 181A.680.

22 (15) "Public or private safety agency" means a unit of state or local government, a special pur-
23 pose district or a private firm that provides, or has authority to provide, fire fighting, police, am-
24 bulance or emergency medical services.

25 (16) "Public safety personnel" and "public safety officer" include corrections officers, youth
26 correction officers, emergency medical dispatchers, parole and probation officers, police officers,
27 certified reserve officers, reserve officers, telecommunicators, regulatory specialists and fire service
28 professionals.

29 (17) "Regulatory specialist" has the meaning given that term in ORS 471.001.

30 (18) "Reserve officer" means an officer or member of a law enforcement unit who is:

31 (a) A volunteer or employed less than full-time as a peace officer commissioned by a city, port,
32 school district, mass transit district, county, county service district authorized to provide law
33 enforcement services under ORS 451.010, tribal government as defined in ORS 181A.680, the Crimi-
34 nal Justice Division of the Department of Justice, the Oregon State Lottery Commission, a univer-
35 sity that has established a police department under ORS 352.121 or 353.125, the Governor or the
36 Department of State Police;

37 (b) Armed with a firearm; and

38 (c) Responsible for enforcing the criminal laws and traffic laws of this state or laws or ordi-
39 nances relating to airport security.

40 (19) "Telecommunicator" means a person employed as an emergency communications worker as
41 defined in ORS 243.736 or a public safety dispatcher whose primary duties are receiving, processing
42 and transmitting public safety information received through the emergency communications system
43 as defined in ORS 403.105.

44 (20) "Youth correction officer" means an employee of the Oregon Youth Authority who is
45 charged with and primarily performs the duty of custody, control or supervision of youth offenders

1 confined in a youth correction facility.

2 **SECTION 2. This 2021 Act being necessary for the immediate preservation of the public**
3 **peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect**
4 **on its passage.**
