AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in inchoate crimes, further 3 providing for prohibited offensive weapons; in assault, 4 further providing for discharge of a firearm into an occupied 5 structure; in theft and related offenses, further providing 7 for definitions; in riot, disorderly conduct and related offenses, further providing for prohibiting of paramilitary 8 training; in firearms and other dangerous articles, further 9 providing for definitions, for persons not to possess, use, 10 manufacture, control, sell or transfer firearms, for firearms 11 not to be carried without a license and for prohibited 12 conduct during emergency, providing for 3-D printed firearms and further providing for sale or transfer of firearms, for 13 14 15 firearm sales surcharge, for registration of firearms and for 16 licensing of dealers.

- 29 license to manufacture firearms under 18 U.S.C. § 923(a) and
- 30 uses a 3-D printer to create a firearm or any piece or part of a

- 2 <u>firearm without including a manufacturer's serial number.</u>
