A BILL

To prohibit the transfer, loan, or other disposition of a machinegun or semiautomatic assault weapon to an individual under 16 years of age.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Help End Assault Rifle
5 Tragedies Act of 2016” or the “HEART Act”.

1 **SEC. 2. PROHIBITION ON THE TRANSFER, LOAN, OR OTHER**
2 **DISPOSITION OF A MACHINEGUN OR SEMI-**
3 **AUTOMATIC ASSAULT WEAPON TO AN INDI-**
4 **VIDUAL UNDER AGE 16.**

5 (a) IN GENERAL.—Section 922 of title 18, United
6 States Code, is amended by adding at the end the fol-
7 lowing:

8 “(aa) It shall be unlawful for any person, in or affect-
9 ing interstate or foreign commerce, to transfer, loan, or
10 otherwise dispose of a machinegun or semiautomatic as-
11 sault weapon to an individual, knowing or having reason-
12 able cause to believe that the individual has not attained
13 16 years of age, including the temporary transfer of a ma-
14 chinegun or semiautomatic assault weapon to such indi-
15 vidual for use in target shooting or on a firing or shooting
16 range or for any other purpose.”.

17 (b) SEMIAUTOMATIC ASSAULT WEAPON DEFINED.—
18 Section 921(a) of title 18, United States Code, is amended
19 by inserting after paragraph (29) the following:

20 “(30) The term ‘semiautomatic assault weapon’
21 means any of the following, regardless of country of manu-
22 facture or caliber of ammunition accepted:

23 “(A) A semiautomatic rifle that has the capac-
24 ity to accept a detachable magazine and any one of
25 the following:

26 “(i) A pistol grip.

1 “(ii) A forward grip.

2 “(iii) A folding, telescoping, or detachable
3 stock.

4 “(iv) A grenade launcher or rocket launch-
5 er.

6 “(v) A barrel shroud.

7 “(vi) A threaded barrel.

8 “(B) A semiautomatic rifle that has a fixed
9 magazine with the capacity to accept more than 10
10 rounds, except for an attached tubular device de-
11 signed to accept, and capable of operating only with,
12 .22 caliber rimfire ammunition.

13 “(C) Any part, combination of parts, compo-
14 nent, device, attachment, or accessory that is de-
15 signed or functions to accelerate the rate of fire of
16 a semiautomatic rifle but not convert the semiauto-
17 matic rifle into a machinegun.

18 “(D) A semiautomatic pistol that has the ca-
19 pacity to accept a detachable magazine and any one
20 of the following:

21 “(i) A threaded barrel.

22 “(ii) A second pistol grip.

23 “(iii) A barrel shroud.

1 “(iv) The capacity to accept a detachable
2 magazine at some location outside of the pistol
3 grip.

4 “(v) A semiautomatic version of an auto-
5 matic firearm.

6 “(E) A semiautomatic pistol with a fixed maga-
7 zine that has the capacity to accept more than 10
8 rounds.

9 “(F) A semiautomatic shotgun that has any one
10 of the following:

11 “(i) A folding, telescoping, or detachable
12 stock.

13 “(ii) A pistol grip.

14 “(iii) A fixed magazine with the capacity to
15 accept more than 5 rounds.

16 “(iv) The ability to accept a detachable
17 magazine.

18 “(v) A forward grip.

19 “(vi) A grenade launcher or rocket launch-
20 er.

21 “(G) Any shotgun with a revolving cylinder.

22 “(H) All of the following rifles, copies, dupli-
23 cates, variants, or altered facsimiles with the capa-
24 bility of any such weapon thereof:

25 “(i) All AK types, including the following:

1 “(I) AK, AK47, AK47S, AK-74,
2 AKM, AKS, ARM, MAK90, MISR,
3 NHM90, NHM91, Rock River Arms LAR-
4 47, SA85, SA93, Vector Arms AK-47,
5 VEPR, WASR-10, and WUM.

5 gun described in subparagraph (A), (B), (C), (F),
6 (G), (H), (J), or (K).”.

7 (c) PENALTIES.—Section 924(a)(2) of title 18,
8 United States Code, is amended by striking “or (o)” and
9 inserting “(o), or (aa)”.

10 (d) EFFECTIVE DATE.—The amendments made by
11 this section shall apply to conduct engaged in after the
12 date that is 180 days after the date of enactment of this
13 Act.
