A BILL

To amend chapter 44 of title 18, United States Code, to prohibit the sale or other disposition of a firearm to, and the possession, shipment, transportation, or receipt of a firearm by, certain classes of high-risk individuals.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Keeping Guns from
5 High-Risk Individuals Act”.

1 **SEC. 2. FIREARM PROHIBITIONS APPLICABLE WITH RE-**
2 **SPECT TO CERTAIN HIGH-RISK INDIVIDUALS.**

3 (a) SALES OR OTHER DISPOSITIONS.—Section
4 922(d) of title 18, United States Code, is amended in the
5 first sentence—

6 (1) by striking “or” at the end of paragraph
7 (8);

8 (2) by striking the period at the end of para-
9 graph (9) and inserting a semicolon; and

10 (3) by adding at the end the following:

11 “(10) in the most recent 10-year period, has
12 been convicted in any court of a crime of violence
13 (as defined in section 16);

14 “(11) has not attained 25 years of age, and has
15 been adjudicated by any court as having committed
16 an offense that would have been a crime of violence
17 (as defined in section 16) if committed by an adult;

18 “(12) in any period of 3 consecutive years in
19 the most recent 10-year period, has been convicted
20 in any court, on 2 separate occasions, of an offense
21 that has, as an element, the possession or distribu-
22 tion of, or the intent to possess or distribute, alcohol
23 or a controlled substance (as so defined); or

24 “(13) has been convicted in any court of stalk-
25 ing.”.

1 (b) POSSESSION, SHIPMENT, TRANSPORTATION, OR
2 RECEIPT.—Section 922(g) of such title is amended—

3 (1) by striking “or” at the end of paragraph
4 (8);

5 (2) by striking the comma at the end of para-
6 graph (9) and inserting a semicolon; and

7 (3) by inserting after paragraph (9) the fol-
8 lowing:

9 “(10) who, in the most recent 10-year period,
10 has been convicted in any court of a crime of vio-
11 lence (as defined in section 16);

12 “(11) who has not attained 25 years of age and
13 has been adjudicated by any court as having com-
14 mitted an offense that would have been a crime of
15 violence (as defined in section 16) if committed by
16 an adult;

17 “(12) who, in any period of 3 consecutive years
18 in the most recent 10-year period, has been con-
19 victed in any court, on 2 separate occasions, of an
20 offense that has, as an element, the possession or
21 distribution of, or the intent to possess or distribute,
22 alcohol or a controlled substance (as so defined); or

23 “(13) who has been convicted in any court of
24 stalking.”.
