## A BILL

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2016, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*  
3 That the following sums are appropriated, out of any  
4 money in the Treasury not otherwise appropriated, for the  
5 Legislative Branch for the fiscal year ending September  
6 30, 2016, and for other purposes, namely:

7                   TITLE I—LEGISLATIVE BRANCH

8                   HOUSE OF REPRESENTATIVES

9           PAYMENT TO WIDOWS AND HEIRS OF DECEASED

10                   MEMBERS OF CONGRESS

11       For payment to Tori B. Nunnelee, widow of Alan  
12 Nunnelee, late a Representative from the State of Mis-  
13 sissippi, \$174,000.

14                   SALARIES AND EXPENSES

15       For salaries and expenses of the House of Represent-  
16 atives, \$1,180,736,000, as follows:

17                   HOUSE LEADERSHIP OFFICES

18       For salaries and expenses, as authorized by law,  
19 \$22,278,891, including: Office of the Speaker,  
20 \$6,645,417, including \$25,000 for official expenses of the  
21 Speaker; Office of the Majority Floor Leader, \$2,180,048,  
22 including \$10,000 for official expenses of the Majority  
23 Leader; Office of the Minority Floor Leader, \$7,114,471,  
24 including \$10,000 for official expenses of the Minority  
25 Leader; Office of the Majority Whip, including the Chief

1 Deputy Majority Whip, \$1,886,632, including \$5,000 for  
2 official expenses of the Majority Whip; Office of the Mi-  
3 nority Whip, including the Chief Deputy Minority Whip,  
4 \$1,459,639, including \$5,000 for official expenses of the  
5 Minority Whip; Republican Conference, \$1,505,426;  
6 Democratic Caucus, \$1,487,258: *Provided*, That such  
7 amount for salaries and expenses shall remain available  
8 from January 3, 2016 until January 2, 2017.

9 MEMBERS' REPRESENTATIONAL ALLOWANCES  
10 INCLUDING MEMBERS' CLERK HIRE, OFFICIAL  
11 EXPENSES OF MEMBERS, AND OFFICIAL MAIL

12 For Members' representational allowances, including  
13 Members' clerk hire, official expenses, and official mail,  
14 \$554,317,732.

15 COMMITTEE EMPLOYEES

16 STANDING COMMITTEES, SPECIAL AND SELECT

17 For salaries and expenses of standing committees,  
18 special and select, authorized by House resolutions,  
19 \$123,903,173: *Provided*, That such amount shall remain  
20 available for such salaries and expenses until December  
21 31, 2016.

22 COMMITTEE ON APPROPRIATIONS

23 For salaries and expenses of the Committee on Ap-  
24 propriations, \$23,271,004, including studies and examina-  
25 tions of executive agencies and temporary personal serv-

1 ices for such committee, to be expended in accordance with  
2 section 202(b) of the Legislative Reorganization Act of  
3 1946 and to be available for reimbursement to agencies  
4 for services performed: *Provided*, That such amount shall  
5 remain available for such salaries and expenses until De-  
6 cember 31, 2016.

7 SALARIES, OFFICERS AND EMPLOYEES

8 For compensation and expenses of officers and em-  
9 ployees, as authorized by law, \$175,713,679, including:  
10 for salaries and expenses of the Office of the Clerk, includ-  
11 ing the positions of the Chaplain and the Historian, and  
12 including not more than \$25,000, of which not more than  
13 \$20,000 is for the Family Room and not more than  
14 \$2,000 is for the Office of the Chaplain, for official rep-  
15 resentation and reception expenses, \$24,980,898; for sala-  
16 ries and expenses of the Office of the Sergeant at Arms,  
17 including the position of Superintendent of Garages and  
18 the Office of Emergency Management, and including not  
19 more than \$3,000 for official representation and reception  
20 expenses, \$14,827,120 of which \$4,784,229 shall remain  
21 available until expended; for salaries and expenses of the  
22 Office of the Chief Administrative Officer including not  
23 more than \$3,000 for official representation and reception  
24 expenses, \$115,010,000, of which \$1,350,000 shall remain  
25 available until expended; for salaries and expenses of the

1 Office of the Inspector General, \$4,741,809; for salaries  
2 and expenses of the Office of General Counsel,  
3 \$1,413,450; for salaries and expenses of the Office of the  
4 Parliamentarian, including the Parliamentarian, \$2,000  
5 for preparing the Digest of Rules, and not more than  
6 \$1,000 for official representation and reception expenses,  
7 \$1,974,606; for salaries and expenses of the Office of the  
8 Law Revision Counsel of the House, \$3,119,766; for sala-  
9 ries and expenses of the Office of the Legislative Counsel  
10 of the House, \$8,352,975; for salaries and expenses of the  
11 Office of Interparliamentary Affairs, \$814,069; for other  
12 authorized employees, \$478,986.

13 ALLOWANCES AND EXPENSES

14 For allowances and expenses as authorized by House  
15 resolution or law, \$281,251,521, including: supplies, mate-  
16 rials, administrative costs and Federal tort claims,  
17 \$3,625,236; official mail for committees, leadership of-  
18 fices, and administrative offices of the House, \$190,486;  
19 Government contributions for health, retirement, Social  
20 Security, and other applicable employee benefits,  
21 \$254,447,514, to remain available until March 31, 2017;  
22 Business Continuity and Disaster Recovery, \$16,217,008  
23 of which \$5,000,000 shall remain available until expended;  
24 transition activities for new members and staff,  
25 \$2,084,000, to remain available until expended; Wounded

1 Warrior Program \$2,500,000, to remain available until  
2 expended; Office of Congressional Ethics, \$1,467,030; and  
3 miscellaneous items including purchase, exchange, mainte-  
4 nance, repair and operation of House motor vehicles,  
5 interparliamentary receptions, and gratuities to heirs of  
6 deceased employees of the House, \$720,247.

7 ADMINISTRATIVE PROVISIONS

8 SEC. 101. (a) REQUIRING AMOUNTS REMAINING IN  
9 MEMBERS' REPRESENTATIONAL ALLOWANCES TO BE  
10 USED FOR DEFICIT REDUCTION OR TO REDUCE THE  
11 FEDERAL DEBT.—Notwithstanding any other provision of  
12 law, any amounts appropriated under this Act for  
13 “HOUSE OF REPRESENTATIVES—SALARIES AND  
14 EXPENSES—MEMBERS' REPRESENTATIONAL ALLOW-  
15 ANCES” shall be available only for fiscal year 2016. Any  
16 amount remaining after all payments are made under such  
17 allowances for fiscal year 2016 shall be deposited in the  
18 Treasury and used for deficit reduction (or, if there is no  
19 Federal budget deficit after all such payments have been  
20 made, for reducing the Federal debt, in such manner as  
21 the Secretary of the Treasury considers appropriate).

22 (b) REGULATIONS.—The Committee on House Ad-  
23 ministration of the House of Representatives shall have  
24 authority to prescribe regulations to carry out this section.

1 (c) DEFINITION.—As used in this section, the term  
2 “Member of the House of Representatives” means a Rep-  
3 resentative in, or a Delegate or Resident Commissioner  
4 to, the Congress.

5 DELIVERY OF BILLS AND RESOLUTIONS

6 SEC. 102. None of the funds made available in this  
7 Act may be used to deliver a printed copy of a bill, joint  
8 resolution, or resolution to the office of a Member of the  
9 House of Representatives (including a Delegate or Resi-  
10 dent Commissioner to the Congress) unless the Member  
11 requests a copy.

12 DELIVERY OF CONGRESSIONAL RECORD

13 SEC. 103. None of the funds made available by this  
14 Act may be used to deliver a printed copy of any version  
15 of the Congressional Record to the office of a Member of  
16 the House of Representatives (including a Delegate or  
17 Resident Commissioner to the Congress).

18 LIMITATION ON AMOUNT AVAILABLE TO LEASE VEHICLES

19 SEC. 104. None of the funds made available in this  
20 Act may be used by the Chief Administrative Officer of  
21 the House of Representatives to make any payments from  
22 any Members’ Representational Allowance for the leasing  
23 of a vehicle, excluding mobile district offices, in an aggre-  
24 gate amount that exceeds \$1,000 for the vehicle in any  
25 month.

1         LIMITATION ON PRINTED COPIES OF U.S. CODE TO  
2   HOUSE

3         SEC. 105. None of the funds made available by this  
4 Act may be used to provide an aggregate number of more  
5 than 50 printed copies of any edition of the United States  
6 Code to all offices of the House of Representatives.

7                                 DELIVERY OF REPORTS OF DISBURSEMENTS

8         SEC. 106. None of the funds made available by this  
9 Act may be used to deliver a printed copy of the report  
10 of disbursements for the operations of the House of Rep-  
11 resentatives under section 106 of the House of Represent-  
12 atives Administrative Reform Technical Corrections Act  
13 (2 U.S.C. 5535) to the office of a Member of the House  
14 of Representatives (including a Delegate or Resident Com-  
15 missioner to the Congress).

16                                 DELIVERY OF DAILY CALENDAR

17         SEC. 107. None of the funds made available by this  
18 Act may be used to deliver to the office of a Member of  
19 the House of Representatives (including a Delegate or  
20 Resident Commissioner to the Congress) a printed copy  
21 of the Daily Calendar of the House of Representatives  
22 which is prepared by the Clerk of the House of Represent-  
23 atives.

24                                     JOINT ITEMS

25         For Joint Committees, as follows:



## 1 JOINT ECONOMIC COMMITTEE

2 For salaries and expenses of the Joint Economic  
3 Committee, \$4,203,000, to be disbursed by the Secretary  
4 of the Senate.

## 5 JOINT COMMITTEE ON TAXATION

6 For salaries and expenses of the Joint Committee on  
7 Taxation, \$10,095,000, to be disbursed by the Chief Ad-  
8 ministrative Officer of the House of Representatives.

9 For other joint items, as follows:

## 10 OFFICE OF THE ATTENDING PHYSICIAN

11 For medical supplies, equipment, and contingent ex-  
12 penses of the emergency rooms, and for the Attending  
13 Physician and his assistants, including:

14 (1) an allowance of \$2,175 per month to the  
15 Attending Physician;

16 (2) an allowance of \$1,300 per month to the  
17 Senior Medical Officer;

18 (3) an allowance of \$725 per month each to  
19 three medical officers while on duty in the Office of  
20 the Attending Physician;

21 (4) an allowance of \$725 per month to 2 assist-  
22 ants and \$580 per month each not to exceed 11 as-  
23 sistants on the basis heretofore provided for such as-  
24 sistants; and

1           (5) \$2,692,000 for reimbursement to the De-  
2           partment of the Navy for expenses incurred for staff  
3           and equipment assigned to the Office of the Attend-  
4           ing Physician, which shall be advanced and credited  
5           to the applicable appropriation or appropriations  
6           from which such salaries, allowances, and other ex-  
7           penses are payable and shall be available for all the  
8           purposes thereof, \$3,784,000, to be disbursed by the  
9           Chief Administrative Officer of the House of Rep-  
10          resentatives.

11       OFFICE OF CONGRESSIONAL ACCESSIBILITY SERVICES

12                               SALARIES AND EXPENSES

13       For salaries and expenses of the Office of Congres-  
14       sional Accessibility Services, \$1,387,000, to be disbursed  
15       by the Secretary of the Senate.

16                               CAPITOL POLICE

17                                       SALARIES

18       For salaries of employees of the Capitol Police, in-  
19       cluding overtime, hazardous duty pay, and Government  
20       contributions for health, retirement, social security, pro-  
21       fessional liability insurance, and other applicable employee  
22       benefits, \$300,000,000 of which overtime shall not exceed  
23       \$30,928,000 unless the Committee on Appropriations of  
24       the House and Senate are notified, to be disbursed by the  
25       Chief of the Capitol Police or his designee.

## 1 GENERAL EXPENSES

2 For necessary expenses of the Capitol Police, includ-  
 3 ing motor vehicles, communications and other equipment,  
 4 security equipment and installation, uniforms, weapons,  
 5 supplies, materials, training, medical services, forensic  
 6 services, stenographic services, personal and professional  
 7 services, the employee assistance program, the awards pro-  
 8 gram, postage, communication services, travel advances,  
 9 relocation of instructor and liaison personnel for the Fed-  
 10 eral Law Enforcement Training Center, and not more  
 11 than \$5,000 to be expended on the certification of the  
 12 Chief of the Capitol Police in connection with official rep-  
 13 resentation and reception expenses, \$69,000,000, to be  
 14 disbursed by the Chief of the Capitol Police or his des-  
 15 ignee: *Provided*, That, notwithstanding any other provi-  
 16 sion of law, the cost of basic training for the Capitol Police  
 17 at the Federal Law Enforcement Training Center for fis-  
 18 cal year 2016 shall be paid by the Secretary of Homeland  
 19 Security from funds available to the Department of Home-  
 20 land Security.

## 21 ADMINISTRATIVE PROVISION

## 22 DEPOSIT OF REIMBURSEMENTS FOR LAW ENFORCEMENT

## 23 ASSISTANCE

24 SEC. 1001. (a) IN GENERAL.—Section 2802(a)(1) of  
 25 the Supplemental Appropriations Act, 2001 (2 U.S.C.

1 1905(a)(1)) is amended by striking “District of Colum-  
2 bia)” and inserting the following: “District of Columbia),  
3 and from any other source in the case of assistance pro-  
4 vided in connection with an activity that was not spon-  
5 sored by Congress”.

6 (b) CONFORMING AMENDMENT.—Section 2802(a)(2)  
7 of such Act (2 U.S.C. 1905(a)(2)) is amended by striking  
8 “law enforcement assistance to any Federal, State, or local  
9 government agency (including any agency of the District  
10 of Columbia)” and inserting “any law enforcement assist-  
11 ance for which reimbursement described in paragraph (1)  
12 is made”.

13 (c) EFFECTIVE DATE.—The amendments made by  
14 this section shall apply with respect to any reimbursement  
15 received before, on, or after the date of the enactment of  
16 this Act.

## 17 OFFICE OF COMPLIANCE

### 18 SALARIES AND EXPENSES

19 For salaries and expenses of the Office of Compli-  
20 ance, as authorized by section 305 of the Congressional  
21 Accountability Act of 1995 (2 U.S.C. 1385), \$3,959,000,  
22 of which \$450,000 shall remain available until September  
23 30, 2017: *Provided*, That not more than \$500 may be ex-  
24 pended on the certification of the Executive Director of

1 the Office of Compliance in connection with official rep-  
2 resentation and reception expenses.

3 CONGRESSIONAL BUDGET OFFICE

4 SALARIES AND EXPENSES

5 For salaries and expenses necessary for operation of  
6 the Congressional Budget Office, including not more than  
7 \$6,000 to be expended on the certification of the Director  
8 of the Congressional Budget Office in connection with offi-  
9 cial representation and reception expenses, \$47,270,000.

10 ARCHITECT OF THE CAPITOL

11 CAPITOL CONSTRUCTION AND OPERATIONS

12 For salaries for the Architect of the Capitol, and  
13 other personal services, at rates of pay provided by law;  
14 for all necessary expenses for surveys and studies, con-  
15 struction, operation, and general and administrative sup-  
16 port in connection with facilities and activities under the  
17 care of the Architect of the Capitol including the Botanic  
18 Garden; electrical substations of the Capitol, Senate and  
19 House office buildings, and other facilities under the juris-  
20 diction of the Architect of the Capitol; including fur-  
21 nishings and office equipment; including not more than  
22 \$5,000 for official reception and representation expenses,  
23 to be expended as the Architect of the Capitol may ap-  
24 prove; for purchase or exchange, maintenance, and oper-  
25 ation of a passenger motor vehicle, \$90,946,000.

## 1                                   CAPITOL BUILDING

2           For all necessary expenses for the maintenance, care  
3 and operation of the Capitol, \$46,737,000, of which  
4 \$22,737,000 shall remain available until September 30,  
5 2020.

## 6                                   CAPITOL GROUNDS

7           For all necessary expenses for care and improvement  
8 of grounds surrounding the Capitol, the Senate and House  
9 office buildings, and the Capitol Power Plant,  
10 \$11,880,000, of which \$2,000,000 shall remain available  
11 until September 30, 2020.

## 12                                  HOUSE OFFICE BUILDINGS

13           For all necessary expenses for the maintenance, care  
14 and operation of the House office buildings,  
15 \$149,962,000, of which \$23,886,000 shall remain avail-  
16 able until September 30, 2020, and of which \$62,000,000  
17 shall remain available until expended for the restoration  
18 and renovation of the Cannon House Office Building.

19           In addition, for a payment to the House Historic  
20 Buildings Revitalization Trust Fund, \$10,000,000, to re-  
21 main available until expended.

## 22                                  CAPITOL POWER PLANT

23           For all necessary expenses for the maintenance, care  
24 and operation of the Capitol Power Plant; lighting, heat-  
25 ing, power (including the purchase of electrical energy)

1 and water and sewer services for the Capitol, Senate and  
2 House office buildings, Library of Congress buildings, and  
3 the grounds about the same, Botanic Garden, Senate ga-  
4 rage, and air conditioning refrigeration not supplied from  
5 plants in any of such buildings; heating the Government  
6 Printing Office and Washington City Post Office, and  
7 heating and chilled water for air conditioning for the Su-  
8 preme Court Building, the Union Station complex, the  
9 Thurgood Marshall Federal Judiciary Building and the  
10 Folger Shakespeare Library, expenses for which shall be  
11 advanced or reimbursed upon request of the Architect of  
12 the Capitol and amounts so received shall be deposited  
13 into the Treasury to the credit of this appropriation,  
14 \$91,549,898, of which \$14,408,898 shall remain available  
15 until September 30, 2020: *Provided*, That not more than  
16 \$9,000,000 of the funds credited or to be reimbursed to  
17 this appropriation as herein provided shall be available for  
18 obligation during fiscal year 2016.

19 LIBRARY BUILDINGS AND GROUNDS

20 For all necessary expenses for the mechanical and  
21 structural maintenance, care and operation of the Library  
22 buildings and grounds, \$36,589,000, of which  
23 \$11,646,000 shall remain available until September 30,  
24 2020.

## 1 CAPITOL POLICE BUILDINGS, GROUNDS AND SECURITY

2 For all necessary expenses for the maintenance, care  
3 and operation of buildings, grounds and security enhance-  
4 ments of the United States Capitol Police, wherever lo-  
5 cated, the Alternate Computer Facility, and AOC security  
6 operations, \$22,058,000, of which \$4,525,000 shall re-  
7 main available until September 30, 2020.

## 8 BOTANIC GARDEN

9 For all necessary expenses for the maintenance, care  
10 and operation of the Botanic Garden and the nurseries,  
11 buildings, grounds, and collections; and purchase and ex-  
12 change, maintenance, repair, and operation of a passenger  
13 motor vehicle; all under the direction of the Joint Com-  
14 mittee on the Library, \$11,892,000; of which \$2,100,000  
15 shall remain available until September 30, 2020: *Provided*,  
16 That of the amount made available under this heading,  
17 the Architect of the Capitol may obligate and expend such  
18 sums as may be necessary for the maintenance, care and  
19 operation of the National Garden established under sec-  
20 tion 307E of the Legislative Branch Appropriations Act,  
21 1989 (2 U.S.C. 2146), upon vouchers approved by the Ar-  
22 chitect of the Capitol or a duly authorized designee.

## 23 CAPITOL VISITOR CENTER

24 For all necessary expenses for the operation of the  
25 Capitol Visitor Center, \$20,557,000.



## 1 ADMINISTRATIVE PROVISIONS

2 NO BONUSES FOR CONTRACTORS BEHIND SCHEDULE OR  
3 OVER BUDGET

4 SEC. 1101. None of the funds made available in this  
5 Act for the Architect of the Capitol may be used to make  
6 incentive or award payments to contractors for work on  
7 contracts or programs for which the contractor is behind  
8 schedule or over budget, unless the Architect of the Cap-  
9 itol, or agency-employed designee, determines that any  
10 such deviations are due to unforeseeable events, govern-  
11 ment-driven scope changes, or are not significant within  
12 the overall scope of the project and/or program.

## 13 SCRIMS

14 SEC. 1102. None of the funds made available by this  
15 Act may be used for serims containing photographs of  
16 building facades during restoration or construction  
17 projects performed by the Architect of the Capitol.

## 18 ACQUISITION OF PARCEL AT FORT MEADE

19 SEC. 1103. (a) ACQUISITION.—The Architect of the  
20 Capitol is authorized to acquire from the Maryland State  
21 Highway Administration, at no cost to the United States,  
22 a parcel of real property (including improvements thereon)  
23 consisting of approximately 7.34 acres located within the  
24 portion of Fort George G. Meade in Anne Arundel County,  
25 Maryland, that was transferred to the Architect of the

1 Capitol by the Secretary of the Army pursuant to section  
2 122 of the Military Construction Appropriations Act, 1994  
3 (2 U.S.C. 141 note).

4 (b) TERMS AND CONDITIONS.—The terms and condi-  
5 tions applicable under subsections (b) and (d) of section  
6 122 of the Military Construction Appropriations Act, 1994  
7 (2 U.S.C. 141 note) to the property acquired by the Archi-  
8 tect of the Capitol pursuant to such section shall apply  
9 to the real property acquired by the Architect pursuant  
10 to the authority of this section.

11 OVERSIGHT PLAN FOR FUNDS PROVIDED FOR LARGE  
12 SCALE PROJECTS

13 SEC. 1104. (a) The Architect of the Capitol may not  
14 obligate more than 25 percent of the amount made avail-  
15 able to the Architect under this Act for any project for  
16 which \$5,000,000 or more is appropriated under this Act  
17 until—

18 (1) the Architect submits to the Comptroller  
19 General and the Committee on Appropriations of  
20 House of Representatives a plan for the use of the  
21 funds provided for the project which includes a de-  
22 scription of any changes to the project's schedule  
23 (including benchmarks for the timing of the comple-  
24 tion of various stages of the project) or the project's  
25 costs (including estimates of the total costs of the

1 project or the total life cycle costs of the project), as  
2 well as a description of the accounting and other  
3 safeguards the Architect will implement to ensure  
4 that the project will be carried out in a timely and  
5 cost-effective manner; and

6 (2) the Comptroller General and the Committee  
7 on Appropriations of the House of Representatives  
8 approves such plan.

## 9 LIBRARY OF CONGRESS

### 10 SALARIES AND EXPENSES

11 For necessary expenses of the Library of Congress  
12 not otherwise provided for, including development and  
13 maintenance of the Library's catalogs; custody and custo-  
14 dial care of the Library buildings; special clothing; clean-  
15 ing, laundering and repair of uniforms; preservation of  
16 motion pictures in the custody of the Library; operation  
17 and maintenance of the American Folklife Center in the  
18 Library; preparation and distribution of catalog records  
19 and other publications of the Library; hire or purchase  
20 of one passenger motor vehicle; and expenses of the Li-  
21 brary of Congress Trust Fund Board not properly charge-  
22 able to the income of any trust fund held by the Board,  
23 \$419,357,000, of which not more than \$6,000,000 shall  
24 be derived from collections credited to this appropriation  
25 during fiscal year 2016, and shall remain available until

1 expended, under the Act of June 28, 1902 (chapter 1301;  
2 32 Stat. 480; 2 U.S.C. 150) and not more than \$350,000  
3 shall be derived from collections during fiscal year 2016  
4 and shall remain available until expended for the develop-  
5 ment and maintenance of an international legal informa-  
6 tion database and activities related thereto: *Provided*,  
7 That the Library of Congress may not obligate or expend  
8 any funds derived from collections under the Act of June  
9 28, 1902, in excess of the amount authorized for obliga-  
10 tion or expenditure in appropriations Acts: *Provided fur-*  
11 *ther*, That the total amount available for obligation shall  
12 be reduced by the amount by which collections are less  
13 than \$6,350,000: *Provided further*, That of the total  
14 amount appropriated, not more than \$12,000 may be ex-  
15 pended, on the certification of the Librarian of Congress,  
16 in connection with official representation and reception ex-  
17 penses for the Overseas Field Offices: *Provided further*,  
18 That of the total amount appropriated, \$8,231,000 shall  
19 remain available until expended for the digital collections  
20 and educational curricula program.

21 COPYRIGTH OFFICE

23 For all necessary expenses of the Copyright Office,  
24 \$57,008,000, of which not more than \$30,000,000, to re-  
25 main available until expended, shall be derived from collec-

1 tions credited to this appropriation during fiscal year 2016  
2 under section 708(d) of title 17, United States Code: *Pro-*  
3 *vided*, That the Copyright Office may not obligate or ex-  
4 pend any funds derived from collections under such sec-  
5 tion, in excess of the amount authorized for obligation or  
6 expenditure in appropriations Acts: *Provided further*, That  
7 not more than \$5,777,000 shall be derived from collections  
8 during fiscal year 2016 under sections 111(d)(2),  
9 119(b)(3), 803(e), 1005, and 1316 of such title: *Provided*

24 thorized by law to be distributed to Members of Congress;  
25 and publishing, and distribution of Government publica-

1 tions authorized by law to be distributed without charge  
2 to the recipient, \$79,736,000: *Provided*, That this appro-  
3 priation shall not be available for paper copies of the per-  
4 manent edition of the Congressional Record for individual  
5 Representatives, Resident Commissioners or Delegates au-

16 depository and international exchange libraries as author-  
17 ized by law, \$30,500,000: *Provided*, That amounts of not  
18 more than \$2,000,000 from current year appropriations  
19 are authorized for producing and disseminating Congres-  
20 sional serial sets and other related publications for fiscal  
21 years 2014 and 2015 to depository and other designated  
22 libraries: *Provided further*, That any unobligated or unex-

19 tion and reception expenses; temporary or intermittent  
20 services under section 3109(b) of title 5, United States  
21 Code, but at rates for individuals not more than the daily  
22 equivalent of the annual rate of basic pay for level IV of  
23 the Executive Schedule under section 5315 of such title;  
24 hire of one passenger motor vehicle; advance payments in  
25 foreign countries in accordance with section 3324 of title

1 31, United States Code; benefits comparable to those pay-  
2 able under sections 901(5), (6), and (8) of the Foreign  
3 Service Act of 1980 (22 U.S.C. 4081(5), (6), and (8));  
4 and under regulations prescribed by the Comptroller Gen-  
5 eral of the United States, rental of living quarters in for-

7 \$430,000.

8 TITLE II—GENERAL PROVISIONS

9 MAINTENANCE AND CARE OF PRIVATE VEHICLES

10 SEC. 201. No part of the funds appropriated in this  
11 Act shall be used for the maintenance or care of private  
12 vehicles, except for emergency assistance and cleaning as  
13 may be provided under regulations relating to parking fa-  
14 cilities for the House of Representatives issued by the  
15 Committee on House Administration and for the Senate  
16 issued by the Committee on Rules and Administration.

17 FISCAL YEAR LIMITATION

18 SEC. 202. No part of the funds appropriated in this  
19 Act shall remain available for obligation beyond fiscal year  
20 2016 unless expressly so provided in this Act.

21 RATES OF COMPENSATION AND DESIGNATION

22 SEC. 203. Whenever in this Act any office or position  
23 not specifically established by the Legislative Pay Act of  
24 1929 (46 Stat. 32 et seq.) is appropriated for or the rate  
25 of compensation or designation of any office or position

1 appropriated for is different from that specifically estab-  
2 lished by such Act, the rate of compensation and the des-  
3 ignation in this Act shall be the permanent law with re-  
4 spect thereto: *Provided*, That the provisions in this Act  
5 for the various items of official expenses of Members, offi-  
6 cers, and committees of the Senate and House of Rep-  
7 resentatives, and clerk hire for Senators and Members of  
8 the House of Representatives shall be the permanent law  
9 with respect thereto.

10 CONSULTING SERVICES

11 SEC. 204. The expenditure of any appropriation  
12 under this Act for any consulting service through procure-  
13 ment contract, under section 3109 of title 5, United States  
14 Code, shall be limited to those contracts where such ex-  
15 penditures are a matter of public record and available for  
16 public inspection, except where otherwise provided under  
17 existing law, or under existing Executive order issued

19 COSTS OF LBFMC

20 SEC. 205. Amounts available for administrative ex-  
21 penses of any legislative branch entity which participates  
22 in the Legislative Branch Financial Managers Council  
23 (LBFMC) established by charter on March 26, 1996, shall  
24 be available to finance an appropriate share of LBFMC  
25 costs as determined by the LBFMC, except that the total

1 LBFMC costs to be shared among all participating legisla-  
2 tive branch entities (in such allocations among the entities  
3 as the entities may determine) may not exceed \$2,000.

4 LANDSCAPE MAINTENANCE

5 SEC. 206. For fiscal year 2016 and each fiscal year  
6 thereafter, the Architect of the Capitol, in consultation  
7 with the District of Columbia, is authorized to maintain  
8 and improve the landscape features, excluding streets, in  
9 Square 580 up to the beginning of I-395.

10 LIMITATION ON TRANSFERS

11 SEC. 207. None of the funds made available in this  
12 Act may be transferred to any department, agency, or in-  
13 strumentality of the United States Government, except  
14 pursuant to a transfer made by, or transfer authority pro-  
15 vided in, this Act or any other appropriation Act.

16 GUIDED TOURS OF THE CAPITOL

17 SEC. 208. (a) Except as provided in subsection (b),  
18 none of the funds made available to the Architect of the  
19 Capitol in this Act may be used to eliminate or restrict  
20 guided tours of the United States Capitol which are led  
21 by employees and interns of offices of Members of Con-  
22 gress and other offices of the House of Representatives  
23 and Senate

24 (b) At the direction of the Capitol Police Board, or  
25 at the direction of the Architect of the Capitol with the



1 approval of the Capitol Police Board, guided tours of the  
2 United States Capitol which are led by employees and in-  
3 terns described in subsection (a) may be suspended tempo-  
4 rarily or otherwise subject to restriction for security or re-  
5 lated reasons to the same extent as guided tours of the  
6 United States Capitol which are led by the Architect of  
7 the Capitol.

8 BATTERY RECHARGING STATIONS FOR PRIVATELY OWNED  
9 VEHICLES IN PARKING AREAS UNDER THE JURISDIC-  
10 TION OF THE LIBRARIAN OF CONGRESS AT NO NET  
11 COST TO THE FEDERAL GOVERNMENT

12 SEC. 209. (a) DEFINITION.—In this section, the term  
13 “covered employee” means—

14 (1) an employee of the Library of Congress; or  
15 (2) any other individual who is authorized to  
16 park in any parking area under the jurisdiction of  
17 the Library of Congress on the Library of Congress  
18 buildings and grounds.

19 (b) AUTHORITY.—

20 (1) IN GENERAL.—Subject to paragraph (3),  
21 funds appropriated to the Architect of the Capitol  
22 under the heading “CAPITOL POWER PLANT” under  
23 the heading “ARCHITECT OF THE CAPITOL” in  
24 any fiscal year are available to construct, operate,  
25 and maintain on a reimbursable basis battery re-

1 charging stations in parking areas under the juris-  
2 diction of the Library of Congress on Library of  
3 Congress buildings and grounds for use by privately  
4 owned vehicles used by covered employees.

5 (2) VENDORS AUTHORIZED.—In carrying out  
6 paragraph (1), the Architect of the Capitol may use  
7 1 or more vendors on a commission basis.

8 (3) APPROVAL OF CONSTRUCTION.—The Archi-  
9 tect of the Capitol may construct or direct the con-  
10 struction of battery recharging stations described  
11 under paragraph (1) after—

12 (A) submission of written notice detailing  
13 the numbers and locations of the battery re-  
14 charging stations to the Joint Committee on the  
15 Library; and

16 (B) approval by that Committee.

17 (c) FEES AND CHARGES.—

18 (1) IN GENERAL.—Subject to paragraph (2),  
19 the Architect of the Capitol shall charge fees or  
20 charges for electricity provided to covered employees  
21 sufficient to cover the costs to the Architect of the  
22 Capitol to carry out this section, including costs to  
23 any vendors or other costs associated with maintain-  
24 ing the battery recharging stations.

1           (2) APPROVAL OF FEES OR CHARGES.—The Ar-  
2           chitect of the Capitol may establish and adjust fees  
3           or charges under paragraph (1) after—

4                   (A) submission of written notice detailing  
5           the amount of the fee or charge to be estab-  
6           lished or adjusted to the Joint Committee on  
7           the Library; and

8                   (B) approval by that Committee.

9           (d) DEPOSIT AND AVAILABILITY OF FEES, CHARGES,  
10          AND COMMISSIONS.—Any fees, charges, or commissions  
11          collected by the Architect of the Capitol under this section  
12          shall be—

13                   (1) deposited in the Treasury to the credit of  
14          the appropriations account described under sub-  
15          section (b); and

16                   (2) available for obligation without further ap-  
17          propriation during the fiscal year collected.

18          (e) REPORTS.—

19                   (1) IN GENERAL.—Not later than 30 days after  
20          the end of each fiscal year, the Architect of the Cap-  
21          itol shall submit a report on the financial adminis-  
22          tration and cost recovery of activities under this sec-  
23          tion with respect to that fiscal year to the Joint  
24          Committee on the Library and the Committees on

1 Appropriations of the House of Representatives and  
2 Senate.

3 (2) AVOIDING SUBSIDY.—

4 (A) DETERMINATION.—Not later than 3  
5 years after the date of enactment of this Act  
6 and every 3 years thereafter, the Architect of  
7 the Capitol shall submit a report to the Joint  
8 Committee on the Library determining whether  
9 covered employees using battery charging sta-  
10 tions as authorized by this section are receiving  
11 a subsidy from the taxpayers.

12 (B) MODIFICATION OF RATES AND  
13 FEES.—If a determination is made under sub-  
14 paragraph (A) that a subsidy is being received,  
15 the Architect of the Capitol shall submit a plan  
16 to the Joint Committee on the Library on how  
17 to update the program to ensure no subsidy is  
18 being received. If the Joint Committee does not  
19 act on the plan within 60 days, the Architect of  
20 the Capitol shall take appropriate steps to in-  
21 crease rates or fees to ensure reimbursement  
22 for the cost of the program consistent with an  
23 appropriate schedule for amortization, to be  
24 charged to those using the charging stations.

1 (f) EFFECTIVE DATE.—This section shall apply with  
2 respect to fiscal year 2016 and each fiscal year thereafter.

3 COST OF LIVING ADJUSTMENT

4 SEC. 210. Notwithstanding any other provision of  
5 law, no adjustment shall be made under section 601(a)  
6 of the Legislative Reorganization Act of 1946 (2 U.S.C.  
7 4501) (relating to cost of living adjustments for Members  
8 of Congress) during fiscal year 2016.

9 SPENDING REDUCTION ACCOUNT

10 SEC. 211. The amount by which the applicable alloca-  
11 tion of new budget authority made by the Committee on  
12 Appropriations of the House of Representatives under sec-  
13 tion 302(b) of the Congressional Budget Act of 1974, ex-  
14 cluding Senate items, exceeds the amount of proposed new  
15 budget authority is \$0.

16 This Act may be cited as the “Legislative Branch Ap-  
17 propriations Act, 2016”.
