1 AN ACT Relating to creating cost savings by providing
2 administrative flexibility to the department of fish and wildlife in
3 its implementation of Title 77 RCW while not directing any changes to
4 resource management outcomes; amending RCW 77.04.012, 77.04.120,
5 77.04.150, 77.04.160, 77.12.068, 77.12.184, 77.12.360, 77.12.451,
6 77.12.670, 77.12.702, 77.12.755, 77.12.820, 77.12.880, 77.15.110,
7 77.15.245, 77.15.260, 77.15.620, 77.55.141, 77.55.241, 77.57.040,
8 77.57.060, 77.60.170, 77.65.560, 77.70.010, 77.70.210, 77.70.280,
9 77.70.360, 77.70.390, 77.85.020, 77.85.040, 77.85.130, 77.85.160,
10 77.85.220, 77.85.230, 77.95.020, 77.95.090, 77.95.190, 77.95.200,
11 77.95.230, 77.100.050, 77.100.060, and 77.115.010; reenacting and
12 amending RCW 77.08.045, 77.85.140, and 77.08.010; and repealing RCW
13 77.12.605, 77.12.690, 77.12.710, and 77.65.900.

14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

15 **Sec. 1.** RCW 77.04.012 and 2000 c 107 s 2 are each amended to
16 read as follows:

17 (1) Wildlife, fish, and shellfish are the property of the state.
18 The commission, director, and the department shall preserve, protect,
19 perpetuate, and manage the wildlife and food fish, game fish, and
20 shellfish in state waters and offshore waters.

1 (2) The department shall conserve the wildlife and food fish,
2 game fish, and shellfish resources in a manner that does not impair
3 the resource. In a manner consistent with this goal, the department
4 shall seek to maintain the economic well-being and stability of the
5 fishing industry in the state. The department shall promote orderly
6 fisheries and shall enhance and improve recreational and commercial
7 fishing in this state.

8 (3) The commission may authorize the taking of wildlife, food
9 fish, game fish, and shellfish only at times or places, or in manners
10 or quantities, as in the judgment of the commission does not impair
11 the supply of these resources.

12 (4) The commission shall attempt to maximize the public
13 recreational game fishing and hunting opportunities of all citizens,
14 including juveniles, ~~((disabled))~~ individuals with disabilities, and
15 senior citizens.

16 (5) Recognizing that the management of our state wildlife, food
17 fish, game fish, and shellfish resources depends heavily on the
18 assistance of volunteers, the department shall work cooperatively
19 with volunteer groups and individuals to achieve the goals of this
20 title to the greatest extent possible.

21 (6) Nothing in this title shall be construed to infringe on the
22 right of a private property owner to control the owner's private
23 property.

24 **Sec. 2.** RCW 77.04.120 and 2000 c 107 s 3 are each amended to
25 read as follows:

26 (1) The director shall investigate the habits, supply, and
27 economic use of food fish and shellfish in state and offshore waters.

28 (2) The director shall ~~((make an annual))~~ report annually to the
29 governor on the operation of the department and ~~((the))~~ statistics
30 ~~((of))~~ relating to the fishing industry.

31 (3) Subject to RCW 40.07.040 and consistent with RCW 43.01.036,
32 the director shall provide a ~~((comprehensive))~~ biennial report of all
33 departmental operations to the ~~((chairs of the committees on natural
34 resources of the senate and house of representatives, the senate ways
35 and means committee, and the house of representatives appropriations
36 committee, including one copy to the staff of each of the committees,
37 to reflect the previous fiscal period. The format of the report shall
38 be similar to reports issued by the department from 1964-1970 and the
39 report shall include, but not be limited to, descriptions of all~~

1 ~~department activities including: Revenues generated, program costs,~~
2 ~~capital expenditures, personnel, special projects, new and ongoing~~
3 ~~research, environmental controls, cooperative projects,~~
4 ~~intergovernmental agreements, and outlines of ongoing litigation,~~
5 ~~recent court decisions and orders on major issues with the potential~~
6 ~~for state liability. The report shall describe the status of the~~
7 ~~resource and its recreational, commercial, and tribal utilization.~~
8 ~~The report shall)) legislature. The report must be made available to~~
9 the public.

10 **Sec. 3.** RCW 77.04.150 and 2008 c 294 s 1 are each amended to
11 read as follows:

12 (1) The commission must appoint an advisory committee to
13 generally represent the interests of hunters and fishers with
14 disabilities on matters including, but not limited to, special hunts,
15 modified sporting equipment, access to public land, and hunting and
16 fishing opportunities. The advisory committee ~~((is))~~ may not be
17 composed of more than seven members, each being an individual with a
18 disability. The advisory committee members must represent the entire
19 state. ~~((The members must be appointed so that each of the six~~
20 ~~department administrative regions, as they existed on January 1,~~
21 ~~2007, are represented with one resident on the advisory committee.~~
22 ~~One additional member must be appointed at large. The chair of the~~
23 ~~advisory committee must be a member of the advisory committee and~~
24 ~~shall be selected by the members of the advisory committee.))~~

25 (2) For the purposes of this section, an individual with a
26 disability includes but is not limited to:

27 (a) An individual with a permanent disability who is not
28 ambulatory over natural terrain without a prosthesis or assistive
29 device;

30 (b) An individual with a permanent disability who is unable to
31 walk without the use of assistance from a brace, cane, crutch,
32 wheelchair, scooter, walker, or other assistive device;

33 (c) An individual who has a cardiac condition to the extent that
34 the individual's functional limitations are severe;

35 (d) An individual who is restricted by lung disease to the extent
36 that the individual's functional limitations are severe;

37 (e) An individual who is totally blind or visually impaired; or

1 (f) An individual with a permanent disability with upper or lower
2 extremity impairments who does not have the use of one or both upper
3 or lower extremities.

4 (3) The members of the advisory committee are appointed for not
5 more than a four-year term. If a vacancy occurs on the advisory
6 committee prior to the expiration of a term, the commission must
7 appoint a replacement (~~((within sixty days))~~) to complete the term.

8 (4) The advisory committee must meet at least semiannually, and
9 may meet at other times as requested by a majority of the advisory
10 committee members for any express purpose that directly relates to
11 the duties set forth in subsection (1) of this section. A majority of
12 members currently serving on the advisory committee constitutes a
13 quorum. The department must provide staff support for all official
14 advisory committee meetings.

15 (5) Each member of the advisory committee shall serve without
16 compensation but may be reimbursed for travel expenses as authorized
17 in RCW 43.03.050 and 43.03.060.

18 (6) The members of the advisory committee, or individuals acting
19 on their behalf, are immune from civil liability for official acts
20 performed in the course of their duties.

21 (~~((7) Beginning December 1, 2011, and again at least once every~~
22 ~~four years, the commission shall present a report to the appropriate~~
23 ~~legislative committees detailing the effectiveness of the advisory~~
24 ~~committee including, but not limited to, the participation levels,~~
25 ~~general interest, quality of advice, and recommendations as to the~~
26 ~~advisory committee's continuance or modification.))~~)

27 **Sec. 4.** RCW 77.04.160 and 2001 c 337 s 5 are each amended to
28 read as follows:

29 (1) The department shall (~~((prepare an annual))~~) annually provide
30 information to the recreation and conservation office regarding
31 surplus salmon (~~((report))~~). (~~((This report shall))~~) The information must
32 include the disposition of adult salmonids that have returned to
33 salmonid hatchery facilities operated under the jurisdiction of the
34 state that:

35 (a) Have not been harvested; and

36 (b) Were not allowed to escape for natural spawning.

37 (2) The (~~((report))~~) information shall include, by species, the
38 number and estimated weight of surplus salmon and steelhead and a

1 description of the disposition of the adult carcasses including, but
2 not limited to, the following categories:

3 (a) Disposed in landfills;

4 (b) Transferred to another government agency for reproductive
5 purposes;

6 (c) Sold to contract buyers in the round;

7 (d) Sold to contract buyers after spawning;

8 (e) Transferred to Native American tribes;

9 (f) Donated to food banks; and

10 (g) Used in stream nutrient enrichment programs.

11 (3) The ~~((report shall))~~ information must also include, by
12 species, information on the number of requests for viable salmon
13 eggs, the number of these requests that were granted and the number
14 that were denied, the geographic areas for which these requests were
15 granted or denied, and a brief explanation given for each denial of a
16 request for viable salmon eggs.

17 (4) The ~~((report shall be))~~ information provided to the
18 recreation and conservation office under this section must be
19 included in the biennial ~~((state of the salmon))~~ report ~~((required by~~
20 ~~RCW 77.85.020 and other similar state reports on salmon))~~ on the
21 statewide status of salmon recovery and watershed health required
22 under RCW 77.85.020.

23 (5) The ~~((report shall))~~ information must include an assessment
24 of the infrastructure needs and facility modifications necessary to
25 implement chapter 337, Laws of 2001.

26 **Sec. 5.** RCW 77.12.068 and 2008 c 225 s 4 are each amended to
27 read as follows:

28 (1) The department and the state parks and recreation commission
29 shall disseminate information about RCW 77.15.740, whale and wildlife
30 viewing guidelines, and other responsible wildlife viewing messages
31 to educate Washington's citizens on how to reduce the risk of
32 disturbing southern resident orca whales. ~~((The department and the~~
33 state parks and recreation commission must, at minimum, disseminate))
34 This information ~~((on their))~~ must, at a minimum, be disseminated
35 through the agencies' internet sites ~~((and through)),~~ appropriate
36 agency publications ~~((, brochures)),~~ and other information sources
37 deemed appropriate by either agency.

38 (2) The department and the state parks and recreation commission
39 ~~((shall))~~ should also attempt to reach the state's boating community

1 by coordinating with appropriate state and nongovernmental entities
2 to provide ~~((this))~~ the information pursuant to this section at
3 marinas, boat shows, boat dealers, during boating safety training
4 courses, and in conjunction with vessel registration or licensing.

5 **Sec. 6.** RCW 77.12.184 and 2009 c 333 s 31 are each amended to
6 read as follows:

7 (1) The department shall deposit all moneys received from the
8 following activities into the state wildlife account created in RCW
9 77.12.170:

10 (a) The sale of interpretive, recreational, historical,
11 educational, and informational literature and materials;

12 (b) The sale of advertisements in regulation pamphlets and other
13 appropriate mediums; ~~((and))~~

14 (c) Enrollment fees in department-sponsored educational training
15 events; and

16 (d) Fees for accessing mobile device applications, or information
17 on mobile device applications, developed by or for the department
18 that provides user content such as licensing, harvest recording and
19 reporting, and access to regulations and information.

20 ~~((Moneys collected under subsection (1) of this section shall~~
21 ~~be spent primarily for producing regulation booklets for users and~~
22 ~~for the development, production, reprinting, and distribution of~~
23 ~~informational and educational materials. The department may also~~
24 ~~spend these moneys for necessary expenses associated with training~~
25 ~~activities, and other activities as determined by the director.~~

26 ~~(3))~~ Regulation and education pamphlets may be subsidized
27 through appropriate advertising, but must be made available free of
28 charge to the users unless the information is provided through a
29 mobile device application.

30 ~~((4))~~ (3) The director may enter into joint ventures with other
31 agencies and organizations to generate revenue for providing public
32 information and education on wildlife ~~((and))~~, hunting ~~((and))~~,
33 fishing ~~((rules))~~, and recreation.

34 **Sec. 7.** RCW 77.12.360 and 1980 c 78 s 54 are each amended to
35 read as follows:

36 Upon written request of the department, the department of natural
37 resources may withdraw from lease state-owned lands described in the
38 request. The request shall bear the endorsement of the county

1 legislative authority if the lands were acquired under RCW
2 (~~76.12.030 or 76.12.080~~) 79.22.040 or 79.22.020. Withdrawals shall
3 conform to the state outdoor recreation plan. If the lands are held
4 for the benefit of the common school fund or another fund, the
5 department shall pay compensation equal to the lease value of the
6 lands to the appropriate fund.

7 **Sec. 8.** RCW 77.12.451 and 1990 c 36 s 1 are each amended to read
8 as follows:

9 (1) The director may take or remove any species of fish or
10 shellfish from the waters or beaches of the state.

11 (2) The director may sell food fish or shellfish caught or taken
12 during department test fishing operations.

13 (3) The director shall not sell inedible salmon for human
14 consumption. Salmon and carcasses may be given to state institutions
15 or schools or to economically depressed people, unless the salmon are
16 unfit for human consumption. Salmon not fit for human consumption may
17 be sold by the director for animal food, fish food, or for industrial
18 purposes.

19 (4) In the sale of surplus salmon from state hatcheries, (~~the~~
20 ~~division of purchasing shall require that~~) a portion of the surplus
21 salmon must be processed and returned to the state by the purchaser.
22 The processed salmon shall be fit for human consumption and in a form
23 suitable for distribution to individuals. The (~~division of~~
24 ~~purchasing shall establish the~~) required percentage must be set at a
25 level that does not discourage competitive bidding for the surplus
26 salmon. The measure of the percentage is the combined value of all of
27 the surplus salmon sold. The department of social and health services
28 shall distribute the processed salmon to economically depressed
29 individuals and state institutions pursuant to rules adopted by the
30 department of social and health services.

31 **Sec. 9.** RCW 77.08.045 and 2011 1st sp.s. c 21 s 17 and 2011 c
32 339 s 2 are each reenacted and amended to read as follows:

33 As used in this title or rules adopted pursuant to this title:

34 (1) "Migratory waterfowl" means members of the family Anatidae,
35 including (~~brants,~~) ducks, geese, and swans;

36 (2) "Migratory bird" means migratory game birds, including
37 migratory waterfowl and coots, snipe, doves, and band-tailed pigeon;

1 (3) "Migratory bird permit" means the permit that is required by
2 RCW 77.32.350 to be in the possession of all persons to hunt
3 migratory birds; and

4 (4) (~~("Prints and artwork")~~) "Migratory bird artwork" means the
5 stamps, prints, and other replicas of the original stamp design that
6 are sold to the general public. (~~(Prints and artwork)~~) Migratory bird
7 stamps are not to be construed to be the migratory bird permits that
8 (~~(is)~~) are required by RCW 77.32.350. (~~(Artwork may be any facsimile~~
9 ~~of the original stamp design, including color renditions, metal~~
10 ~~duplications, or any other kind of design.)~~)

11 **Sec. 10.** RCW 77.12.670 and 2011 1st sp.s. c 21 s 15 are each
12 amended to read as follows:

13 (1) (~~(Beginning July 1, 2011, the department, after soliciting~~
14 ~~recommendations from the public, shall select the design for the~~
15 ~~migratory bird stamp.~~

16 ~~(2))~~) All revenue derived from the sale of migratory bird
17 (~~(license validations or stamps by the department to any person~~
18 ~~hunting waterfowl or to any stamp collector)~~) permits shall be
19 deposited in the state wildlife account and shall be used only (~~(for~~
20 ~~that portion of the cost of printing and production of the stamps)~~)
21 for:

22 (~~(migratory waterfowl hunters as determined by subsection (4) of~~
23 ~~this section, and for those)~~)

24 (a) Migratory (~~(waterfowl)~~) bird projects specified by the
25 director of the department for the acquisition and development of
26 migratory (~~(waterfowl)~~) bird habitat in the state; and

27 (~~(for)~~) (b) The enhancement, protection, and propagation of
28 migratory (~~(waterfowl)~~) birds in the state.

29 (2) Migratory bird (~~(license validation and stamp)~~) permit funds
30 may not be used on lands controlled by private hunting clubs or on
31 private lands that charge a fee for public access. Migratory bird
32 (~~(license validation and stamp)~~) permit funds may be used for
33 migratory (~~(waterfowl)~~) bird projects on private land where public
34 hunting is provided by written permission or on areas established by
35 the department as (~~(waterfowl)~~) hunting closures.

36 (3) (~~(All revenue derived from the sale of the license validation~~
37 ~~and stamp by the department to persons hunting solely nonwaterfowl~~
38 ~~migratory birds shall be deposited in the state wildlife account and~~
39 ~~shall be used only for that portion of the cost of printing and~~

1 ~~production of the stamps for nonwaterfowl migratory bird hunters as~~
2 ~~determined by subsection (4) of this section, and for those~~
3 ~~nonwaterfowl migratory bird projects specified by the director for~~
4 ~~the acquisition and development of nonwaterfowl migratory bird~~
5 ~~habitat in the state and for the enhancement, protection, and~~

7 ~~(4) With regard to the revenue from license validation and stamp~~
8 ~~sales that is not the result of sales to stamp collectors, the~~
9 ~~department shall determine the proportion of migratory waterfowl~~
10 ~~hunters and solely nonwaterfowl migratory bird hunters by using the~~
11 ~~yearly migratory bird hunter harvest information program survey~~
12 ~~results or, in the event that these results are not available, other~~
13 ~~similar survey results. A two-year average of the most recent survey~~
14 ~~results shall be used to determine the proportion of the revenue~~
15 ~~attributed to migratory waterfowl hunters and the proportion~~
16 ~~attributed to solely nonwaterfowl migratory bird hunters for each~~
17 ~~fiscal year. For fiscal year 1998-99 and for fiscal year 1999-2000,~~
18 ~~ninety six percent of the stamp revenue shall be attributed to~~

20 ~~shall be attributed to solely nonwaterfowl migratory game hunters.~~

21 ~~(5)) Acquisition shall include but not be limited to the~~
22 ~~acceptance of gifts of real estate or any interest therein or the~~
23 ~~rental, lease, or purchase of real estate or any interest therein. If~~
24 ~~the department acquires any fee interest, leasehold, or rental~~
25 ~~interest in real property under this section, it shall allow the~~
26 ~~general public reasonable access to that property and shall, if~~
27 ~~appropriate, ensure that the deed or other instrument creating the~~
28 ~~interest allows such access to the general public. If the department~~
29 ~~obtains a covenant in real property in its favor or an easement or~~
30 ~~any other interest in real property under this section, it shall~~
31 ~~exercise its best efforts to ensure that the deed or other instrument~~
32 ~~creating the interest grants to the general public in the form of a~~

37 ~~((6) The department may produce migratory bird stamps in any~~
38 ~~given year in excess of those necessary for sale in that year. The~~
39 ~~excess stamps may be sold to the public.))~~

1 (4) The selection of the annual migratory bird artwork design and
2 the administration, sale, distribution, and other matters relating to
3 the artwork is the responsibility of the department. The department
4 may contract with an appropriate individual or nonprofit organization
5 for selection of the annual migratory bird artwork design and the
6 administration, sale, distribution, and other matters relating to
7 migratory bird artwork.

8 (5) The costs of producing and marketing artwork may be paid out
9 of the total amount brought in from sales of artwork. The remaining
10 amount may only be used to contract with one or more appropriate
11 individuals or nonprofit organizations for the development of
12 waterfowl propagation projects within Washington. The department may
13 not contract with any individual or organization that obtains
14 compensation for allowing waterfowl hunting except if the individual
15 or organization does not require compensation for hunting on the
16 subject property.

17 **Sec. 11.** RCW 77.12.702 and 2007 c 442 s 2 are each amended to
18 read as follows:

19 (1) The department is directed to develop and implement a
20 rockfish research and stock assessment program. Using funds from the
21 rockfish research account created in subsection (2) of this section,
22 the department must conduct Puget Sound basin and coastal surveys
23 (~~(with new and existing technology)~~) to estimate the current
24 abundance and future recovery of rockfish populations and other
25 groundfish species. The stock assessment must include an evaluation
26 of the potential for marine fish enhancement. (~~(Beginning December~~
27 ~~2008, and every two years thereafter,)~~) The department shall report
28 to (~~(the appropriate committees of)~~) the legislature, consistent with
29 RCW 43.01.036, on the status of the stock assessment program every
30 two years.

31 (2) The rockfish research account is created in the custody of
32 the state treasurer. All receipts from surcharges assessed on
33 commercial and recreational fishing licenses for the purposes of
34 rockfish research must be deposited into the account. Expenditures
35 from the account may be used only for rockfish research, including
36 stock assessments. Only the director of the department or the
37 director's designee may authorize expenditures from the account. The
38 account is subject to allotment procedures under chapter 43.88 RCW,
39 but an appropriation is not required for expenditures.

1 **Sec. 12.** RCW 77.12.755 and 2003 c 311 s 10 are each amended to
2 read as follows:

3 (1) In coordination with the department of natural resources and
4 lead entity groups, the department must establish a ranked inventory
5 of fish passage barriers on land owned by small forest landowners
6 based on the principle of fixing the worst first within a watershed
7 consistent with the fish passage priorities of the forest and fish
8 report.

9 (2) In implementing this section, the department shall first
10 gather and synthesize all available existing information about the
11 locations and impacts of fish passage barriers in Washington. This
12 information must include, but not be limited to, the most recently
13 available limiting factors analysis conducted pursuant to RCW
14 77.85.060(2), the stock status information contained in the
15 department (~~(of fish and wildlife)~~) salmonid stock inventory
16 (~~(SASSI)~~) (SaSI), the salmon and steelhead habitat inventory and
17 assessment project (SSHIAP), and any comparable science-based
18 assessment when available.

19 (3) The inventory of fish passage barriers developed under this
20 section must be kept reasonably current (~~(and at a minimum be updated~~
21 ~~by the beginning of each calendar year)) as the director of the~~
22 ~~department determines funding allows.~~

23 (4) Nothing in this section grants the department or others
24 additional right of entry onto private property.

25 **Sec. 13.** RCW 77.12.820 and 2009 c 333 s 52 are each amended to
26 read as follows:

27 (1) The eastern Washington pheasant enhancement account is
28 created in the custody of the state treasurer. All receipts under RCW
29 77.12.810 must be deposited in the account. Moneys in the account are
30 subject to legislative appropriation and shall be used for the
31 purpose of funding (~~(the)~~) an eastern Washington pheasant enhancement
32 program.

33 (2) The department may use moneys from the eastern Washington
34 pheasant enhancement account to improve pheasant habitat (~~(or)~~), to
35 purchase or produce pheasants(~~(. The department must)~~), and to
36 continue to release rooster pheasants in eastern Washington. The
37 eastern Washington pheasant enhancement account funds (~~(must)~~) may
38 not be used for the purchase of land.

1 (3) The eastern Washington pheasant enhancement account may be
2 used to offer grants to improve pheasant habitat on public or private
3 lands that are open to public hunting.

4 (4) The department may enter partnerships with private
5 landowners, nonprofit corporations, cooperative groups, and federal
6 or state agencies for the purposes of pheasant habitat enhancement in
7 areas that will be available for public hunting.

8 (5) The department shall (~~submit an annual report to the~~
9 ~~appropriate committees of the legislature by December 1st~~) make
10 information regarding the department's eastern Washington pheasant
11 activities available upon request.

12 **Sec. 14.** RCW 77.12.880 and 2003 c 153 s 3 are each amended to
13 read as follows:

14 The department shall, when deemed appropriate by the department,
15 manage wildlife programs in a manner that provides for public
16 opportunities to view wildlife and supports nature-based and wildlife
17 viewing tourism without impairing the state's wildlife resources.

18 **Sec. 15.** RCW 77.15.110 and 2012 c 176 s 13 are each amended to
19 read as follows:

20 (1) For purposes of this chapter, a person acts for commercial
21 purposes if the person engages in conduct that relates to commerce in
22 fish, seaweed, shellfish, or wildlife or any parts thereof.
23 Commercial conduct may include taking, delivering, selling, buying,
24 or trading fish, seaweed, shellfish, or wildlife where there is
25 present or future exchange of money, goods, or any valuable
26 consideration. Evidence that a person acts for commercial purposes
27 includes, but is not limited to, the following conduct:

28 (a) Using gear typical of that used in commercial fisheries;

29 (b) Exceeding the bag or possession limits for personal use by
30 taking or possessing more than three times the amount of fish,
31 seaweed, shellfish, or wildlife allowed;

32 (c) Delivering or attempting to deliver fish, seaweed, shellfish,
33 or wildlife to a person who sells or resells fish, seaweed,
34 shellfish, or wildlife including any licensed or unlicensed
35 wholesaler;

36 (d) Taking fish or shellfish using a vessel designated on a
37 commercial fishery license or using gear not authorized in a personal
38 use fishery;

- 1 (e) Using a commercial fishery license;

10 of eggs, seed, juveniles, or brood stock have a lower priority than
11 use for cooperative projects. The rules must identify and implement
12 appropriate protocols for brood stock handling, including the
13 outplanting of adult fish, spawning, incubation, rearing, and release
14 and establish a prioritized schedule for implementation of chapter
15 337, Laws of 2001, and shall include directives for allowing more
16 hatchery salmon to spawn naturally in areas where progeny of hatchery
17 fish have spawned, including the outplanting of adult fish, in order
18 to increase the number of viable salmon eggs and restore healthy
19 numbers of fish within the state.

20 (4) The procedure for the director to notify a volunteer group
21 that the agreement for the project is being revoked for cause and the
22 procedure for revocation. Revocation shall be documented in writing
23 to the volunteer group. Cause for revocation may include: (a) The
24 unavailability of adequate biological or financial resources; (b) the
25 development of unacceptable biological or resource management
26 conflicts; or (c) a violation of agreement provisions. Notice of
27 cause to revoke for a violation of agreement provisions may specify a
28 reasonable period of time within which the volunteer group must
29 comply with any violated provisions of the agreement.

21 The definitions in this section apply throughout this title or
22 rules adopted under this title unless the context clearly requires
23 otherwise.

24 (1) "Anadromous game fish buyer" means a person who purchases or
25 sells steelhead trout and other anadromous game fish harvested by
26 Indian fishers lawfully exercising fishing rights reserved by federal
27 statute, treaty, or executive order, under conditions prescribed by
28 rule of the director.

29 (2) "Angling gear" means a line attached to a rod and reel
30 capable of being held in hand while landing the fish or a hand-held
31 line operated without rod or reel.

32 (3) "Bag limit" means the maximum number of game animals, game
33 birds, or game fish which may be taken, caught, killed, or possessed
34 by a person, as specified by rule of the commission for a particular
35 period of time, or as to size, sex, or species.

36 (4) "Building" means a private domicile, garage, barn, or public
37 or commercial building.

38 (5) "Closed area" means a place where the hunting of some or all
39 species of wild animals or wild birds is prohibited.

1 (6)(a) "Closed season" means all times, manners of taking, and
2 places or waters other than those established by rule of the
3 commission as an open season.

4 (b) "Closed season" also means all hunting, fishing, taking, or
5 possession of game animals, game birds, game fish, food fish, or
6 shellfish that do not conform to the special restrictions or physical
7 descriptions established by rule of the commission as an open season
8 or that have not otherwise been deemed legal to hunt, fish, take,
9 harvest, or possess by rule of the commission as an open season.

10 (7) "Closed waters" means all or part of a lake, river, stream,
11 or other body of water, where fishing or harvesting is prohibited.

12 (8) "Commercial" means related to or connected with buying,
13 selling, or bartering.

14 (9) "Commission" means the state fish and wildlife commission.

15 (10) "Concurrent waters of the Columbia river" means those waters
16 of the Columbia river that coincide with the Washington-Oregon state
17 boundary.

18 (11) "Contraband" means any property that is unlawful to produce
19 or possess.

20 (12) "Deleterious exotic wildlife" means species of the animal
21 kingdom not native to Washington and designated as dangerous to the
22 environment or wildlife of the state.

23 (13) "Department" means the department of fish and wildlife.

24 (14) "Director" means the director of the department of fish and
25 wildlife.

26 (15) "Endangered species" means wildlife designated by the
27 commission as seriously threatened with extinction.

28 (16) "Ex officio fish and wildlife officer" means:

29 (a) A commissioned officer of a municipal, county, or state
30 agency having as its primary function the enforcement of criminal
31 laws in general, while the officer is acting in the respective
32 jurisdiction of that agency;

33 (b) An officer or special agent commissioned by one of the
34 following: The national marine fisheries service; the Washington
35 state parks and recreation commission; the United States fish and
36 wildlife service; the Washington state department of natural
37 resources; the United States forest service; or the United States
38 parks service, if the agent or officer is in the respective
39 jurisdiction of the primary commissioning agency and is acting under

1 a mutual law enforcement assistance agreement between the department
2 and the primary commissioning agency;

3 (c) A commissioned fish and wildlife peace officer from another
4 state who meets the training standards set by the Washington state
5 criminal justice training commission pursuant to RCW 10.93.090,
6 43.101.080, and 43.101.200, and who is acting under a mutual law
7 enforcement assistance agreement between the department and the
8 primary commissioning agency; or

9 (d) A Washington state tribal police officer who successfully
10 completes the requirements set forth under RCW 43.101.157, is
11 employed by a tribal nation that has complied with RCW 10.92.020(2)
12 (a) and (b), and is acting under a mutual law enforcement assistance
13 agreement between the department and the tribal government.

14 (17) "Fish" includes all species classified as game fish or food
15 fish by statute or rule, as well as all fin fish not currently
16 classified as food fish or game fish if such species exist in state
17 waters. The term "fish" includes all stages of development and the
18 bodily parts of fish species.

19 (18) "Fish and wildlife officer" means a person appointed and
20 commissioned by the director, with authority to enforce this title
21 and rules adopted pursuant to this title, and other statutes as
22 prescribed by the legislature. Fish and wildlife officer includes a
23 person commissioned before June 11, 1998, as a wildlife agent or a
24 fisheries patrol officer.

25 (19) "Fish broker" means a person whose business it is to bring a
26 seller of fish and shellfish and a purchaser of those fish and
27 shellfish together.

28 (20) "Fish buyer" means:

29 (a) A wholesale fish dealer or a retail seller who directly
30 receives fish or shellfish from a commercial fisher or receives fish
31 or shellfish in interstate or foreign commerce; or

32 (b) A person engaged by a wholesale fish dealer who receives fish
33 or shellfish from a commercial fisher.

34 (21) "Fishery" means the taking of one or more particular species
35 of fish or shellfish with particular gear in a particular
36 geographical area.

37 (22) "Food, food waste, or other substance" includes human and
38 pet food or other waste or garbage that could attract large wild
39 carnivores.

1 (23) "Freshwater" means all waters not defined as saltwater
2 including, but not limited to, rivers upstream of the river mouth,
3 lakes, ponds, and reservoirs.

4 (24) "Fur-bearing animals" means game animals that shall not be
5 trapped except as authorized by the commission.

6 (25) "Fur dealer" means a person who purchases, receives, or
7 resells raw furs for commercial purposes.

8 (26) "Game animals" means wild animals that shall not be hunted
9 except as authorized by the commission.

10 (27) "Game birds" means wild birds that shall not be hunted
11 except as authorized by the commission.

12 (28) "Game farm" means property on which wildlife is held,
13 confined, propagated, hatched, fed, or otherwise raised for
14 commercial purposes, trade, or gift. The term "game farm" does not
15 include publicly owned facilities.

16 (29) "Game reserve" means a closed area where hunting for all
17 wild animals and wild birds is prohibited.

18 (30) "Illegal items" means those items unlawful to be possessed.

19 (31)(a) "Intentionally feed, attempt to feed, or attract" means
20 to purposefully or knowingly provide, leave, or place in, on, or
21 about any land or building any food, food waste, or other substance
22 that attracts or could attract large wild carnivores to that land or
23 building.

24 (b) "Intentionally feed, attempt to feed, or attract" does not
25 include keeping food, food waste, or other substance in an enclosed
26 garbage receptacle or other enclosed container unless specifically
27 directed by a fish and wildlife officer or animal control authority
28 to secure the receptacle or container in another manner.

29 (32) "Large wild carnivore" includes wild bear, cougar, and wolf.

30 (33) "License year" means the period of time for which a
31 recreational license is valid. The license year begins April 1st, and
32 ends March 31st.

33 (34) "Limited-entry license" means a license subject to a license
34 limitation program established in chapter 77.70 RCW.

35 (35) "Money" means all currency, script, personal checks, money
36 orders, or other negotiable instruments.

37 (36) "Natural person" means a human being.

38 (37)(a) "Negligently feed, attempt to feed, or attract" means to
39 provide, leave, or place in, on, or about any land or building any
40 food, food waste, or other substance that attracts or could attract

1 large wild carnivores to that land or building, without the awareness
2 that a reasonable person in the same situation would have with regard
3 to the likelihood that the food, food waste, or other substance could
4 attract large wild carnivores to the land or building.

5 (b) "Negligently feed, attempt to feed, or attract" does not
6 include keeping food, food waste, or other substance in an enclosed
7 garbage receptacle or other enclosed container unless specifically
8 directed by a fish and wildlife officer or animal control authority
9 to secure the receptacle or container in another manner.

10 (38) "Nonresident" means a person who has not fulfilled the
11 qualifications of a resident.

12 (39) "Offshore waters" means marine waters of the Pacific Ocean
13 outside the territorial boundaries of the state, including the marine
14 waters of other states and countries.

15 (40) "Open season" means those times, manners of taking, and
16 places or waters established by rule of the commission for the lawful
17 hunting, fishing, taking, or possession of game animals, game birds,
18 game fish, food fish, or shellfish that conform to the special
19 restrictions or physical descriptions established by rule of the
20 commission or that have otherwise been deemed legal to hunt, fish,
21 take, or possess by rule of the commission. "Open season" includes
22 the first and last days of the established time.

23 (41) "Owner" means the person in whom is vested the ownership
24 dominion, or title of the property.

25 (42) "Person" means and includes an individual; a corporation; a
26 public or private entity or organization; a local, state, or federal
27 agency; all business organizations, including corporations and
28 partnerships; or a group of two or more individuals acting with a
29 common purpose whether acting in an individual, representative, or
30 official capacity.

31 (43) "Personal property" or "property" includes both corporeal
32 and incorporeal personal property and includes, among other property,
33 contraband and money.

34 (44) "Personal use" means for the private use of the individual
35 taking the fish or shellfish and not for sale or barter.

36 (45) "Predatory birds" means wild birds that may be hunted
37 throughout the year as authorized by the commission.

38 (46) "Protected wildlife" means wildlife designated by the
39 commission that shall not be hunted or fished.

1 (47) "Raffle" means an activity in which tickets bearing an
2 individual number are sold for not more than twenty-five dollars each
3 and in which a permit or permits are awarded to hunt or for access to
4 hunt big game animals or wild turkeys on the basis of a drawing from
5 the tickets by the person or persons conducting the raffle.

6 (48) "Resident" has the same meaning as defined in RCW 77.08.075.

7 (49) "Retail-eligible species" means commercially harvested
8 salmon, crab, and sturgeon.

9 (50) "Saltwater" means those marine waters seaward of river
10 mouths.

11 (51) "Seaweed" means marine aquatic plant species that are
12 dependent upon the marine aquatic or tidal environment, and exist in
13 either an attached or free floating form, and includes but is not
14 limited to marine aquatic plants in the classes Chlorophyta,
15 Phaeophyta, and Rhodophyta.

16 (52) "Senior" means a person seventy years old or older.

17 (53) "Shark fin" means a raw, dried, or otherwise processed
18 detached fin or tail of a shark.

19 (54)(a) "Shark fin derivative product" means any product intended
20 for use by humans or animals that is derived in whole or in part from
21 shark fins or shark fin cartilage.

22 (b) "Shark fin derivative product" does not include a drug
23 approved by the United States food and drug administration and
24 available by prescription only or medical device or vaccine approved
25 by the United States food and drug administration.

26 (55) "Shellfish" means those species of marine and freshwater
27 invertebrates that have been classified and that shall not be taken
28 or possessed except as authorized by rule of the commission. The term
29 "shellfish" includes all stages of development and the bodily parts
30 of shellfish species.

31 (56) "State waters" means all marine waters and fresh waters
32 within ordinary high water lines and within the territorial
33 boundaries of the state.

34 (57) "Taxidermist" means a person who, for commercial purposes,
35 creates lifelike representations of fish and wildlife using fish and
36 wildlife parts and various supporting structures.

37 (58) "To fish" and its derivatives means an effort to kill,
38 injure, harass, harvest, or capture a fish or shellfish.

39 (59) "To hunt" and its derivatives means an effort to kill,
40 injure, harass, harvest, or capture a wild animal or wild bird.

1 (60) "To process" and its derivatives mean preparing or
2 preserving fish, wildlife, or shellfish.

3 (61) "To take" and its derivatives means to kill, injure,
4 harvest, or capture a fish, shellfish, wild animal, bird, or seaweed.

5 (62) "To trap" and its derivatives means a method of hunting
6 using devices to capture wild animals or wild birds.

7 (63) "To waste" or "to be wasted" means to allow any edible
8 portion of any game bird, food fish, game fish, shellfish, or big
9 game animal other than cougar to be rendered unfit for human
10 consumption, or to fail to retrieve edible portions of such a game
11 bird, food fish, game fish, shellfish, or big game animal other than
12 cougar from the field. For purposes of this chapter, edible portions
13 of game birds must include, at a minimum, the breast meat of those
14 birds. Entrails, including the heart and liver, of any wildlife
15 species are not considered edible.

16 (64) "Trafficking" means offering, attempting to engage, or
17 engaging in sale, barter, or purchase of fish, shellfish, wildlife,
18 or deleterious exotic wildlife.

19 (65) "Unclaimed" means that no owner of the property has been
20 identified or has requested, in writing, the release of the property
21 to themselves nor has the owner of the property designated an
22 individual to receive the property or paid the required postage to
23 effect delivery of the property.

24 (66) "Unclassified wildlife" means wildlife existing in
25 Washington in a wild state that have not been classified as big game,
26 game animals, game birds, predatory birds, protected wildlife,
27 endangered wildlife, or deleterious exotic wildlife.

28 (67) "Wholesale fish dealer" means a person who, acting for
29 commercial purposes, takes possession or ownership of fish or
30 shellfish and sells, barter, or exchanges or attempts to sell,
31 barter, or exchange fish or shellfish that have been landed into the
32 state of Washington or entered the state of Washington in interstate
33 or foreign commerce.

34 (68) "Wild animals" means those species of the class Mammalia
35 whose members exist in Washington in a wild state. The term "wild
36 animal" does not include feral domestic mammals or old world rats and
37 mice of the family Muridae of the order Rodentia.

38 (69) "Wild birds" means those species of the class Aves whose
39 members exist in Washington in a wild state.

1 (70) "Wildlife" means all species of the animal kingdom whose
2 members exist in Washington in a wild state. This includes but is not
3 limited to mammals, birds, reptiles, amphibians, fish, and
4 invertebrates. The term "wildlife" does not include feral domestic
5 mammals, old world rats and mice of the family Muridae of the order
6 Rodentia, or those fish, shellfish, and marine invertebrates
7 classified as food fish or shellfish by the director. The term
8 "wildlife" includes all stages of development and the bodily parts of
9 wildlife members.

10 (71) "Wildlife meat cutter" means a person who packs, cuts,
11 processes, or stores wildlife for consumption for another for
12 commercial purposes.

13 (72) "Youth" means a person fifteen years old for fishing and
14 under sixteen years old for hunting.
