



## 2019 SENATE BILL 312

July 3, 2019 - Introduced by Senators CARPENTER, JOHNSON, LARSON, RISSER, SHILLING, L. TAYLOR, RINGHAND, SMITH, MILLER, HANSEN and WIRCH, cosponsored by Representatives C. TAYLOR, STUBBS, SARGENT, SUBECK, HEBL, GOYKE, ANDERSON, CROWLEY, GRUSZYNSKI, SINICKI, KOLSTE, ZAMARRIPA, SPREITZER, FIELDS, L. 1 **AN ACT to amend** 175.35 (title), 175.35 (2) (d) and 175.35 (2g) (c) 4. c. of the  
2 statutes; **relating to:** waiting period for purchase of handguns.

### *Analysis by the Legislative Reference Bureau*

Current law provides that, before a federally licensed firearms dealer may transfer a handgun after a sale, the dealer must request that the Department of Justice perform a background check on the prospective purchaser to determine if the purchaser is prohibited from possessing a firearm under federal or state law.

This bill prohibits the dealer from transferring the handgun to the purchaser until 48 hours have passed since the firearms dealer requested the background check on the purchaser.

5 **SECTION 3.** 175.35 (2g) (c) 4. c. of the statutes is amended to read:

6 175.35 **(2g)** (c) 4. c. If the search indicates that it is unclear whether the person  
7 is prohibited under state or federal law from possessing a firearm and the  
8 department needs more time than provided under sub. (2) (d) to make the  
9 determination, the department shall make every reasonable effort to determine  
10 whether the person is prohibited under state or federal law from possessing a firearm  
11 and notify the firearms dealer of the results as soon as practicable but no later than  
12 5 working days after the search was requested.

13 **SECTION 4. Initial applicability.**

14 (1) This act first applies to sales that occur on the effective date of this  
15 subsection.
